Make sure that the moving company is properly licensed with the Florida Department of Agriculture and Consumer Services and the Federal Motor Carrier Safety Administration;

Never sign any blank or incomplete documents presented by a moving company;

Obtain estimates and quotes from several different moving companies in writing and make sure the estimates are binding;

· Determine whether the movers will perform the move alone or if the company will be subcontracting to another carrier; and

Beware if movers show up in rental trucks and without uniformed personnel. These may be fly-by-night companies

without appropriate licenses or insurance coverage.

Additional tips and resources can be found by visiting the United States Department of Transportation Federal Motor Carrier Safety Administration's website.

Since 2018, the Florida Attorney General's Office has filed six court actions involving 14 moving companies following investigations into deceptive marketing practices, unlawfully misappropriating customers' property and holding personal possessions hostage.

Anyone who is a victim of a moving scam should contact the Florida Attorney General's Office at MyFloridaLegal.com or by calling 1(866) 9NO-SCAM. Complaints can also be filed with the Florida Department of Agriculture and Consumer Services and the United States Department of Transportation.

By-The-Way, have you been told (by your favorite T.V. News person) about all the diseases that these invading aliens bring with them?


American Citizens are 'encouraged' (forced?) to immunize their children with mandatory vaccinations for a number of problem diseases.

Tips to avoid common military-related scams include:

- Beware of scammers using misleading photos or language to imply association with a branch of the U.S. Military;
- Verify the authenticity of an email or text that appears to be from a military branch. Phishing schemes use manipulated messages that appear to be from a military branch or the U.S. Department of Veterans Affairs in an effort to target service members, veterans or their family members;
- Ensure any veterans charity soliciting funds is registered with the state Department of Agriculture and Consumer Services at 800HelpFla.com; and
- Place an active duty alert on credit reports at no cost. An active duty alert requires businesses to take additional steps before granting credit in the name of active duty personnel serving overseas.

number of heat related deaths of children being left unattended in a vehicle. More than

half of vehicular

heatstroke cases from 1998 to 2018 were because an adult forgot about a child, according to NoHeatstroke.org. Additionally, every year pets suffer and die when their guardians make the mistake of leaving them unattended in a parked vehicle to "run in for just a minute" at the local store. The Lady Lake Police Department is committed to informing and educating parents and pet owners on the dangers of leaving children and pets unattended in a vehicle and taking precautions to help prevent these tragic situations.

Leaving a child or a pet in a hot car even for a short period of time can be dangerous, even if parked in a shade or with the windows cracked. A vehicle's glass transparency allows for the sun's rays to heat up the inside essentially creating a vacuum of heat. Within minutes a car that was just being cooled can experience a spike in temperature. On a sunny day, when outside temperatures are 70 degrees the inside temperature of a vehicle can rise to 89 degrees within 10 minutes and 104 degrees within 30 minutes. At 80 degrees outside, the inside temperature of a vehicle can rise to

94 degrees in 10 minutes and soar up to 114 degrees in 30 minutes.

A child's body temperature can rise up to five times faster than an adult's and death will occur with a body temperature of 107 degrees. Dogs and cats can't sweat like humans, so they pant to lower their body temperature. If they're inside a car, recycling very hot air, panting gives no relief, and heat stroke can happen quickly.

I encourage you to take these safety precautions to help avoid these preventable tragedies.

- Make it routine to open the back door of your car every time you park.
- Set an alarm on your cell phone or computer calendar as a reminder to drop vour child off at child care. Make the alarm sound different from other alert tones.
- Keep a stuffed animal in the child's car seat. Place it on the front passenger seat as a reminder when the child is in the back seat
- Ask your babysitter or child care provider to call you if your child hasn't arrived as scheduled.
- If you are driving a child, put something you need in the back seat so you will need to open the back door. Items may include a cellphone, handbag, employee badges, or any other item you would need at your destination.

What to do if you find a pet confined to a vehicle:

- Take the vehicle's make, model, color and license plate number and notify your local Animal Control or Police Department.
- Once removed from the vehicle, provide

water to drink and if possible spray with a garden hose or immerse in cool water for up to two minutes to gradually lower the body temperature.

Watch for signs and symptoms of heatstroke such as restlessness, thick saliva, heavy panting, glazed eyes, dark tongue, rapid heartbeat, difficulty breathing, dizziness, seizure and lack of coordination. If a dog shows any of these symptoms remove it from the heat and transport to a veterinarian immediately.

Practice safety awareness and follow these precautions this summer season with your children and your pets to prevent a vehicle heat-related tragedy from happening to

## ATTORNEY GENERAL'S FACT-GATHERING MISSION TO STOP TEEN VAPING

#### **Teen Vaping Disturbing Trend**

Our fact-gathering mission to find out what is behind a dramatic increase in teen vaping in Florida continued. According to the Florida Department of Health, ecigarette use among high school students increased 78 percent from 2017 to 2018.

We want to know why, and more importantly how to reverse this disturbing trend. This mission brought me to two Florida cities-Oviedo and Sarasota-this week, where I met with education leaders,

law enforcement officers and concerned parents

According to a **FDOH study**, more than 28 percent of students in Sarasota County and Seminole County use ecigarettes-slightly higher than the state average. Shockingly, people I spoke to believe the rate is much higher.

This is extremely concerning because, according to the Centers for Disease Control, juvenile nicotine exposure can harm brain development in ways that may

affect the health and mental health of youth. To stop this trend and protect our kids, we

need to find out how minors are getting their hands on these products. It's illegal under Florida law to sell these products to anyone under 18, yet vaping among minors is out of control.

As your Attorney General, I am dedicated to protecting all Floridians, but especially the most vulnerable among us. This is just one way, working together, we will build a stronger, safer Florida.


## Smash-and-**Dash Burglary**

Defendant Sentenced to 40 years in Smash-and-Dash Gun Store Burglary Case

Attorney General Ashley Moody's Office of Statewide Prosecution announced a 40year prison sentence for a defendant found guilty of a gun store burglary. James Moore previously entered an open plea to burglary of a structure while using a vehicle as an instrument and 35 counts of grand theft of a

The 20-member group stole from department and retail stores to steal guns, jewelry, electronics, sporting goods and more. Thursday, Judge Frances Perrone sentenced Moore to 40 years in prison.

Attorney General Ashley Moody said, These criminals deliberately wrecked a Tampa store to steal firearms. Not only did they steal property, they also stole a sense of neighborhood. I applaud the great work of my Office of Statewide Prosecution securing this strong prison sentence and continuing to seek prison time for the remaining defendants.

#### **High-Level Drug Trafficers** Nabbed HIGH-LEVEL DRUG TRAFFICKERS NABBED BY LAKE SHERIFF'S **UNDERCOVER DETECTIVES IN**

WARRANTS SWEEP

The Lake County sheriff's undercover narcotics detectives, in conjunction with the Clermont, Leesburg, and Eustis Police Departments, just concluded two simultaneous operations this week that targeted high-level traffickers responsible for distributing methamphetamine, heroin, fentanyl, marijuana, and cocaine throughout Central Florida. Dubbed Operation Pull the Plug and Operation C.E.L.L. Block, the two investigations lasted approximately 6 months and resulted in detectives' obtaining 67 arrest warrants.

During Operation Cell Block, detectives identified Jy'kez Jackson as being responsible for distributing trafficking amounts of methamphetamine, heroin, and fentanyl in South Lake County. As the investigation progressed, it was determined that Mr. Jackson was not only distributing methamphetamine, heroin, and fentanyl, but he was also responsible for distributing edibles, which were manufactured from marijuana, THC oil, and cereal. During the course of the investigation, Alphonsa Williams was also identified as a high-level methamphetamine trafficker and supplier who was operating out of Wildwood, Florida.

During Operation Pull The Plug, agents identified Valentino Knowles and learned he was responsible for distributing trafficking amounts of cocaine throughout the Leesburg area of Lake County. As the investigation progressed, detectives were "First Lady Casey DeSantis' leadership in also able to identify Omar Aviles-Lopez and Julio Gonzalez-Pabon, both of whom reside in Osceola County and were supplying Mr. Knowles with trafficking amounts of cocaine.

As both operations unfolded, undercover detectives were also able to conduct several undercover drug purchases from individuals distributing methamphetamine, crack cocaine, and other narcotics related to the aforementioned operation areas.

As a result of the operations, 67 arrest warrants were obtained for criminal charges cocaine, trafficking in heroin/fentanyl, trafficking in methamphetamine, sale of cocaine, sale methamphetamine, sale of marijuana, and solicitation to purchase illegal narcotics.

Detectives served six search warrants, seized five vehicles, and confiscated over 10,000 dollars of U.S. Currency. They also seized approximately a half a kilo of cocaine (worth approximately \$20,000), a kilo of methamphetamine (worth approximately \$10,000), two ounces of heroin/fentanyl (worth approximately

\$4,000), multiple pounds of marijuana in several different forms, including leaf, edible, and oil.

Detectives arrested 44 subjects on the arrest warrants obtained from these operations during a two-day sweep on Wednesday and Thursday, many of whom have extensive criminal histories for narcotics sales, weapons violations, and violent crimes. Joseph Kramer, for instance, was arrested for conspiracy to traffic methamphetamine and was out on bond for Armed Robbery and Possession of a Firearm by Convicted Felon at the time of his arrest.

There were 3 additional subjects arrested on unrelated charges, for a total of 47 arrests so far, with 23 still wanted. One subject detectives obtained a warrant for, Cliff Johnson, is currently out on bond for a Lake County homicide and is one of the subjects still at large.

"I would like to thank the Clermont, Eustis, and Leesburg Police Departments for their hard work and assistance during these operations. We will continue to work hard together to keep drug dealers off the streets and out of our communities. As I've said before, if you're pushing this poison onto our streets, we're coming for you." -Lake Sheriff Peyton Grinnell.



## Flood-Damaged Vehicles How To Identify Flood-Damaged

Vehicles

(NAPSI)—Following record-setting rainfall in many areas of the country, flooding has taken its toll on vehicles. It's important for those considering buying a used vehicle to be car care aware and check for signs of water intrusion or contamination, advises the nonprofit Car Care Council.

"Purchasing a used vehicle and later learning it has been flood damaged can be very problematic and lead to costly issues down the road. Worse yet, these vehicles can be unhealthy to occupy because of mold and bacteria growing in the carpet and ventilation system," explained Rich White, executive director, Car Care Council.

The Car Care Council and the Car Care Professionals Network (CCPN), a group of systems. If the light comes on and then goes

automotive service providers, say it all comes down to how much water the vehicle took in and where it can be reached. They recommend these five steps to determine if a vehicle has been flood damaged:

Take the sniff test. Close all the windows and doors and let the car sit for about five minutes. Then, crack open a door and sniff. Mildew and mold have very distinctive smells and it doesn't take long for that smell to present itself.

Try the touch test. Get some paper towels and press them against the low spots in the carpet. The paper towels will draw the moisture out and reveal if the carpet is wet under the surface. Some carpets can be several inches thick to insulate from heat and sound. If the paper towel becomes wet, it could mean water has gotten into the car.

Investigate the interior. Look under the seats and dash for corrosion and rust and look for exposed metal that is untreated. There are metal springs under the front seats that are usually not painted. If they are rusted, that is a sign the interior has been wet. Look for mud and debris in places they don't belong.

Inspect the instrument panel. Turn on the key and perform a bulb test. Make sure every bulb lights up. If a system has an issue, removing the warning bulb can hide it. Many times, vehicles that have flooded have malfunctions in their anti-brake and air bag *Continued page 11*

This process, as well as other services, can be done either in person or virtually. The IWP also includes services that the participants will need to prepare for jobs tailored to their capabilities and strengths.

#### Services Available

Different types of service providers focus on different types of services:

Employment Networks (EN) are private or public organizations that can help with career counseling and assistance with job placement, including advising about how benefits will be affected by work. Some ENs provide services only to their local community, while others work across one or more states or even nationwide.

State Vocational Rehabilitation (VR) agencies provide training to help people develop a variety of new skills or strengthen current ones to help people with disabilities return to work, enter a new line of work or enter the workforce for the first time.

Work Incentives Planning & Assistance (WIPA) organizations provide free benefits counseling to help beneficiaries make informed choices about work. These groups provide in-depth counseling about working and the effect that earning money will have on benefits.

The Protection and Advocacy for Beneficiaries of Social Security (PABSS) program provides legal support, advocacy and information to help beneficiaries resolve disability- and employment-related concerns.


