Meet Leslie DiCesare the new executive director of the Chamber of Commerce.



## AS I SEE IT

Columns of 'numbers', like this one, are hard to write and boring read. But, sometimes it's worth the effort.

Since 'Day-One', President Trump has tried to cut foreign aid.

He told the UN General Assembly, "Moving forward, we are only going to give foreign aid to those who respect us and, frankly, are our friends."

Unfortunately Congress (Democrats), who control federal funding, refuse stop the export of American Tax-Payers money to all kinds of foreign countries - Friend & Foe alike.

Did you know that, Congress gives away over \$50 BILLION of Tax-Payers money by way of so-called 'Foreign Aid'?

A concerned citizen might ask "Why?"

One source reports that, every year, Argentina, no friend of America, gets nearly \$4 million. El Salvador and Guatemala, whose main occupation seems to be 'exporting' their own impoverished people

to the USA, get about \$110 million and \$170 million respectively.

To keep our 'friends' happy, Canada gets more than \$22 million; Ireland \$740 million and Israel a whole lot more.

Turkey gets almost \$160 million every year which helps them kill off as many Kurdish people as they can find.

Haiti, a country of a very rich ruling class and impoverished people get about \$265 million.

I was surprised to learn that our taxes also cover about \$40 million which is sent to Mongolia and, (Can-It-Be-True?) - \$160 million to Russia! \$33 million to China! and \$12 million to Cuba!

I'm not sure how much oil-rich, Saudi Arabia gets - But its reasonable to ask "Why are they on the list at all?"

What's even more disturbing is that the USA government (both parties) spend way more than the IRS collects. They borrow money from foreign countries (including China), and deplete the Trust Funds and

Cash Reserves which are supposed to be set aside for Social Security and other programs we paid for.

As I understand it the 'DEFICIT' is the amount of money that the government spends in excess of what it 'earns'.

This year, February's deficit alone is \$12 billion more than last year.

Interest paid this year (October-February 2019) has increased by about \$20 billion.

Without apology, the government is predicting that they will over-spend by about \$1 TRILLION this year.

That's about \$221 billion MORE than last year.

Where are we now?

The National Debt is up to almost \$23 TRILLION.

That means that every American Citizen owes about \$62,000 right now.

AND, we will add another \$3,000 every year in future.

As I See It, America is still the biggest and strongest economy in the world, but, for how long can we spend a \$1 TRILLION more than we earn every year?

What happened to "AMERICA FIRST" and "MAKE AMERICA GREAT AGAIN".

## Insect-based Foods...Yuck!

For what seems like decades, excited environmentalists have been pitching insect-based foods as the next major trend in agriculture. The upsides to insect protein are clear. Producing it requires roughly one-tenth the land of other meat sources, and insect farming is inherently more efficient (think about how big a cow is, and then visualize a mealworm).

So far, environmentalists have been wrong about adoption—clearly, most people aren't buying bug protein at the supermarket—but this hype cycle seems different. Investors and founders are getting more deeply involved.

Ynsect, a France-based company focused on producing insect proteins for pet and other animal foods, raised a \$150 million Series C in February. AgriProtein, another insect protein company, raised \$105 million in June of 2018. InnovaFeed, a France-based insect protein company, raised a roughly \$43 million round this August.

With a growing population driving up the demand for agriculture, and current agricultural processes contributing to our climate crisis, the resource-friendliness of insect protein stands to have an impact.

As other alternative meat startups have ballooned in revenue—Beyond Meat priced its IPO at \$25 and currently trades above \$139—it seems like insect protein could be as potent of a market as the alternative meat market we've seen explode over the last year.

Friends,  
As the month closes, we will be well into our final few weeks of committee meetings before the 2020 Legislative Session begins in January. This leadership in Tallahassee is very talented, energetic and committed to making Florida the best place to live, work and raise a family. We have you, the voter, to thank for sending us these

leaders and it is quite humbling to be part of this great process that shapes policy for 20 million residents and millions more visitors. We do not have a perfect system, but it is so much better than anything they have anywhere else in the world. We have gotten to work on a lot great ideas and proposals so far, and it is exciting to be able to share a few of those things with you today.  
Earlier this year, we filed SB 498 Consumer Protection. This legislation will



crack down on unlicensed vendors who have been predominately preying on people living in our senior communities, but their reach is not just limited to them and it is becoming a state-wide issue. These are vendors that typically show up at your front door, promise a service, take your deposit and either never return, or only partially complete the job. This legislation would help put a stop to these dishonest practices.

More specific to Lake County, though its affects will be felt throughout the region, we have filed SB 384, which would eliminate an unnecessary water authority board called the Harris Chain of Lake Restoration Council. This board was recommended to sunset in 2008, but action was never taken to do so.

Eliminating government waste and bureaucracy has always been a top priority, and this is one way that we begin doing that.

Speaking of top priorities, the issue of protecting life has and always will be number one. We have some great pro-life legislation coming out of the Florida Legislature. SB 404, filed by Senator Stargel, will require parental consent for a minor to have an abortion procedure. Current state law only requires parental notification. It is absurd to think that a 15-year-old girl has to have consent from her parents before getting Tylenol at school, but could be allowed to walk into a clinic and get an invasive, dangerous procedure without any input from her parents. Your Senator has also filed legislation that would help expand the Safe Haven Law to add "newborn safety devices" as an acceptable method of surrendering an infant at one of these Safe Havens. No person should ever have to make such a difficult decision, but this addition to our Save Haven Law would allow them to do so in complete anonymity and hopefully encourage more people to choose to allow their infant a chance to live their life. Our hope is that this will continue to spread the message that all life has value, even if it is not how someone envisioned it would be.

Finally, we have also filed a memorial to the U.S. Congress, urging them to adopt an Amendment to the Constitution, titled "Regulation Freedom Amendment", that would require any federal regulation to be adopted by a majority vote of the House and Senate. Every day, more federal regulatory authority threaten our constitutional liberties. Federal regulators need more accountability from the people's elected representatives.

## Are You A Scam Target



### These Behaviors Make You A Scam Target

(NAPS)—If you spend a lot of time on social media sites or looking for great online deals, you may wear a bullseye when it comes to scammers hunting for prey, according to groundbreaking fraud research from the FINRA Investor Education Foundation, BBB Institute for Marketplace Trust and the Stanford Center on Longevity.

Researchers surveyed more than 1,400 Americans and Canadians who were targeted by scammers and reported the fraud to the Better Business Bureau (BBB), which tracks scams. Nearly half of those surveyed did not engage with the fraudster. However, 30 percent engaged to some degree but ultimately did not lose money, while 23 percent engaged with the fraudster or offer and lost money.

accounted for \$170 million of nursery sales in 2015 (15.5 percent of total nursery sales) and generated an expanded economic impact of \$1.2 billion based on University of Florida survey data.

The Florida Department of Agriculture and Consumer Services (FDACS) has designated more than 550 species of native plants as Endangered, Threatened, or Commercially Exploited, nearly 20 percent of all native plant species in Florida.

"Together, we can make a difference in conserving natural Florida by using native plants at home and in our public landscapes," said Florida Native Plant Society Executive Director Juliet Rynear.

Florida's State Forests and State Parks are ablaze with color in October. Many of these native plants can be purchased at local nurseries. Native plant nurseries can be located on the website of the Florida Association of Native Nurseries.

The Florida Native Plant Society (FNPS) is a non-profit organization whose mission is to promote the preservation, conservation, and restoration of the native plants and native plant communities of Florida. The Society has more than 4400 members and 35 Chapters statewide.

A 1999 treaty between the United States and Ukraine on mutual legal assistance in criminal matters.

From THE WHITE HOUSE, November 10, 1999. To the Senate of the United States:

With a view to receiving the advice and consent of the Senate to ratification, I transmit herewith the Treaty between the United States of America and Ukraine on Mutual Legal Assistance in Criminal Matters with Annex, signed at Kiev on July 22, 1998. I transmit also, for the information of the Senate, an exchange of notes which

was signed on September 30, 1999, which provides for its provisional application, as well as the report of the Department of State with respect to the Treaty.

The Treaty is one of a series of modern mutual legal assistance treaties being negotiated by the United States in order to counter criminal activities more effectively. The Treaty should be an effective tool to assist in the prosecution of a wide variety of crimes, including drug trafficking offenses. The Treaty is self-executing. It provides for a broad range of cooperation in criminal matters. Mutual assistance available under the Treaty includes: taking of testimony or statements of persons; providing documents, records, and articles of evidence; serving documents; locating or identifying persons; transferring persons in custody for testimony or other purposes; executing requests for searches and seizures; assisting in proceedings related to restraint, confiscation, forfeiture of assets, restitution, and collection of fines; and any other form of assistance not prohibited by the laws of the requested state.

I recommend that the Senate give early and favorable consideration to the Treaty and give its advice and consent to ratification.

### Governor Ron DeSantis Announces Legislation to Expedite Water Quality Improvements

**Jupiter, Fla.** – Today, Governor Ron DeSantis announced proposed legislation for the 2020 Legislative Session that will expedite water quality improvements throughout Florida. The legislation incorporates recommendations of the Blue-Green Algae Task Force, which the Governor created shortly after taking office to aid the Department of Environmental Protection (DEP) in protecting, conserving and managing the state's natural resources.

The Governor made today's announcement following a tour of the Loxahatchee River District, where he was joined by DEP Secretary Noah Valenstein and Chief Science Officer Dr. Tom Frazier as well as other environmental stakeholders from across the state.

"The health of our state depends on the health and quality of our water," said **Governor DeSantis**. "That is why I am proposing legislation to expedite the improvement of our water quality throughout Florida. These comprehensive proposals, recommended by the Blue-Green Algae Task Force, will greatly aid the Department of Environmental Protection in

our mission to enhance the quality of our state's most precious natural resource."

The proposed legislation furthers the directives outlined in Governor DeSantis' Executive Order 19-12 and is based on the recommendations of The Blue-Green Algae Task Force. The Blue-Green Algae Task Force, through its discussion and deliberations, provides guidance and specific, science-based recommendations with the goal of expediting improvements and restoration of Florida's water bodies that have been adversely affected by blue-green algae blooms.

The Blue-Green Algae Task Force received input from a variety of stakeholders and identified runoff from agricultural lands, onsite sewage treatment and disposal systems, sanitary sewer overflows, and stormwater runoff as some of the significant sources of nutrient pollution and made recommendations to improve the state's policies and programs to achieve targeted nutrient reductions and protect public health.

"Addressing nutrient impacts will require actions by all stakeholders in Florida and significant water quality changes can only occur when all stakeholders work together," said **DEP Secretary Noah Valenstein**.

"This legislation is the foundation for implementing necessary actions by the department, local governments and our regulated community based on the Task Force's recommendations."

"Today was another example of leadership by Governor DeSantis," said **Eric Eikenberg, CEO of The Everglades Foundation**. "The Governor outlined a comprehensive approach to address water quality problems that have been plaguing our state and the Everglades for decades. Today's announcement ends the era of defending the status quo and moves us into a new chapter of fixing what has been neglected. We look forward to working with the Governor and the Legislature to improve our waterways, restore the Everglades, and protect Florida's vibrant economy."

"We are grateful for Governor DeSantis' continued commitment to Florida's environment," said **Gary Jennings, Director of Keep Florida Fishing**. "Keep Florida Fishing supports the Blue-Green Algae Task Force's multi-faceted, science-based approach to improving water quality throughout the state. We look forward to working with the Governor, Legislature and relevant state agencies to address these issues and move these proposals forward. Water quality is critical for maintaining fish habitat and healthy fish populations, which are so important to Florida's \$11.5 billion sportfishing industry and more than 4 million anglers."

## Electric Vehicle Infrastructure

### Governor Ron DeSantis Announces Finalization of Plan to Strengthen Florida's Electric Vehicle Infrastructure

*Florida's Mitigation Plan Will Further Improve Florida's Air Quality*

**Tallahassee, Fla.** – Today, Governor Ron DeSantis announced another step in the state's effort to modernize public transit, provide accessible electric vehicle infrastructure and reduce harmful air pollutants caused by diesel emissions.

Coordination amongst state agencies and

private and public sector partners will be critical to the success of meeting the objectives of the state's recently submitted Beneficiary Mitigation Plan. The Florida Department of Environmental Protection (DEP) has published three Requests for Information (RFIs) for the three project types outlined in the plan.

"My administration is committed to making smart investments to help improve our state's air quality long-term," said **Governor DeSantis**. "This funding will allow us to focus on projects that will reduce harmful emissions, help modernize school and transit bus fleets, and provide access to charging stations in our state as electric vehicle usage continues to increase."

The Beneficiary Mitigation Plan will be funded by the national Volkswagen Settlement, of which Florida was allotted over \$166 million to improve air quality. While Florida is home to some of the best air quality in the nation, this funding will allow for significant investment to reduce diesel emissions and expand the infrastructure for electric vehicles. Florida's Beneficiary Mitigation Plan outlines how the State intends to spend the full \$166 million awarded to the state under this settlement.

Florida's plan focuses on:

- School, transit and shuttle buses (70%)
- EV Charging Stations (15%)
- Diesel Emissions Reduction Act (DERA) "Option" (15%)

"The Department has worked diligently to develop a plan that meets the needs of our state, the priorities of Governor DeSantis and public comments that were received during the draft plan development process," said **DEP Secretary Noah Valenstein**. "We look forward to working with local governments and other partners to expand Florida's electric vehicle infrastructure."

This week, I announced the most expansive state vaping investigation known publicly to date. As many of you know, I spent the summer traveling the state to find out what was behind the dramatic increase in vaping among our youth. According to

the Florida Department of Health, nearly one in four Florida high school students now admits to using e-cigarettes—students have said that rate is much higher.

One study found two-thirds of young persons didn't even know vaping products contained nicotine. Now we are hearing

about vaping-related hospitalizations around the country. According to a recent report, in Florida there have been 68 cases of vaping-related pulmonary illnesses.

As a mother, I cannot sit on the sidelines while underage vaping skyrockets and our next generation becomes addicted to nicotine. It's illegal under Florida law to sell these products to anyone under 18, yet vaping among our youth is out of control.

It's my job, as Attorney General, to protect Floridians and that's what I'm determined to do. That is why we are investigating more than 20 vaping companies doing business in Florida.

Our investigation will focus on the marketing practices and online sales strategies of these companies to determine if they have intentionally targeted minors, tempting them to vape.

Our investigation must be thorough and will take time, but staggering statistics showing that vaping is a growing epidemic among our youth requires action now.

In the meantime, I urge all parents—talk to your children about the dangers of vaping. Working together, we can protect our children and build a stronger, safer Florida.

### Help Fight the Opioid Crisis and Teen Vaping Epidemic by Participating in the 18th National Drug Take-Back Day

TALLAHASSEE, Fla.—Attorney General Ashley Moody is asking Floridians to help fight the opioid crisis and teen vaping epidemic by participating in the 18th National Prescription Drug Take-Back Day. The biannual event is an opportunity for people to properly dispose of unused or expired prescription drugs or controlled substances. Disposing of unwanted or expired pharmaceuticals helps prevent drug abuse, addiction and overdose deaths. Additionally, the U.S. Drug Enforcement Administration, for the first time ever, will accept vaping products on Drug Take-Back Day.

Attorney General Moody today joined DEA to preview a take-back location in the Tampa Bay area. Drug Take-Back Day will take place this Saturday, Oct. 26, from 10 a.m. to 2 p.m. at locations across Florida.

Attorney General Ashley Moody said, “The excess supply of prescription medications is helping fuel the national opioid crisis and teen vaping is at an all-time high. Properly disposing of unused, expired drugs and vaping products helps prevent addiction and could save a life. I ask all Floridians to please participate in Drug Take-Back Day and help keep addictive opioids and vaping products from falling into the wrong hands.”

DEA coordinates drug take-back days with state and local law enforcement. Floridians can learn more about National Prescription Drug Take-Back Day and find





It is important to note that DEA does not accept devices with lithium ion batteries. If the batteries cannot be removed, DEA recommends individuals visit stores that recycle lithium ion batteries.

Attorney General Moody is also taking additional steps to reduce the excess supply of prescription opioids in Florida.

Last week, Attorney General Moody called on the DEA to reexamine opioid prescription quotas. Lowering federal production quotas will ultimately reduce drug overdose deaths by limiting the amount of leftover pain medication that could fall into the hands of Floridians struggling with addiction.

What separates victims from non-victims?

"The path to victimization begins with

engagement," said FINRA Foundation President Gerri Walsh. "Social media and website scams are flourishing. Every time you respond to a friend request from someone you don't know or click through to an unfamiliar website, you run the risk of being exposed to a scam."

Your chance of falling victim to a scam varies by type—for instance, online purchase scams, tech support ploys, fake check or sweepstakes frauds—and by the method in which you are exposed to the offer. For those exposed to a scam through social media or a website, the numbers are chilling. When exposed to a scam on social media, 91 percent engaged and 53 percent lost money. The odds of losing money to website scams were only slightly lower: 81 percent of consumers in the study who were exposed to a fraud via a website said they engaged—and 50 percent lost money.

Other factors heighten the likelihood of falling for a fraud. Consumers were more likely to be victimized if they were isolated and didn't have anyone to discuss the offer with, according to the study. Consequently, those who engaged scammers and lost money were less likely to be married and more likely to be widowed or divorced. "Sadly, loneliness and fraud victimization seem to go hand in hand," noted Walsh.

You're also more likely to engage and lose money if you're feeling financial strain, or have low levels of financial literacy, the study found.

### Protect Yourself

Take these steps to protect yourself from fraud:

**Ask for input from others.** Scammers

try to isolate their victims. Don't be afraid to contact a friend, or a company or organization you trust for advice. It also helps to do additional research before sending any money. One easy action: Do an Internet search to see if the website or pitch has been flagged as fraudulent or potentially fraudulent by news organizations or members of the public.

**Focus on your financial health and literacy.** Individuals under financial strain and those with lower levels of financial literacy may be more susceptible to scammers.

**Knowledge is power.** Knowing about scams and scammer tactics can be your best

defense in successfully reducing the effect of scams. Keep up with the latest frauds by subscribing to consumer newsletters and seeking out information on current scams.

One-third of consumers who were targeted by a scammer, but did not engage with the offer, already knew about the specific type of scam. In addition, consumers who understood the tactics and behaviors of scammers tended not to engage with fraudsters.


