Friends,
Happy New Year! I hope that all of you had a safe and wonderful holiday season. My family enjoyed all the time we shared together and I was especially grateful for the

opportunity to spend some time in our mountain home in North Carolina that we don't get to visit nearly enough. 2020 is already shaping up to be an exciting year in

the world of government and politics and the Presidential Election is sure to capture the majority of the news over the next year. More on that later.

As we say hello to 2020 and goodbye to 2019, let us take a look at a couple of highlights from this last year and for all that we have to be thankful.

During 2019, crime rates in Florida continue to decrease. We just had a chance to look at FDLE's Uniform Crime Report (UCR), which showed crime dropped 6.1



percent compared to the first half of 2018 with almost 17,100 fewer reported incidents. This can be attributed, firstly, to those men and women in law enforcement who are doing an excellent job holding the blue line. Secondly, we can thank some fantastic leadership, chosen by you, in our county sheriff's departments across the state. In addition, our city police chiefs and state law enforcement directors are among the very best, anywhere in the world and we should be very proud of the work they do. Thirdly, because the people of this state have chosen solid, conservative leaders to send to Tallahassee that will protect the rights of individuals to take responsibility for themselves and others.

Thanks to great work done by Governor DeSantis and the Florida Senate, we are finally seeing some relief from the blue-green algae and red tide that affected the gulf coast for the past few years. The establishment of task force to look at new initiatives and technologies, along with a \$682.6 million investment in water protection, has been very successful in combating these issues. Red Tide is a naturally occurring bloom in the Gulf of Mexico, so we will never be completely rid of it, but we can continue to work on mitigating the impacts on wildlife and water quality.

Finally, I was very pleased to see that Florida was finally removed from the American Tort Reform Foundation's "Judicial Hellhole" list. Formally number #1 on this list, excessive tort cost in Florida caused an estimated 125,000 jobs lost and Florida residents lost nearly \$12 billion in personal revenue. Tort reform was a top priority of the Governor and the Florida Legislature for 2019. That call was answered quickly with the appointment of three new Supreme Court justices, who will be more deferential to legislative efforts to stop lawsuit abuse and are committed to correct actions taken by the prior activist court. Following that lead, the Florida Legislature enacted other measures in 2019 that would remove incentives to file assignment of benefits litigation and discourage unnecessary bad faith actions.

Florida is on a great track for 2020, let us stay the course and avoid taking any hard left turns. As always, it is a honor to be your Senator, thank you for letting me serve you.

Operation Bassville Park

The Special Investigations Unit along with deputies from the Street Crimes Unit conducted phase one of Operation Bassville Park. The operational focus was to target known drug areas and dealers in an attempt to stem the flow of illegal narcotics in the designated area. As a result of the operation, detectives were able to arrest two known drug dealers from the area. An additional illegal narcotics arrest was made from the area for a total of three arrests. Listed below are the arrested parties, what they were charged with, and the circumstances for the arrest.

Nicholas Bradway was charged with DWLS (Habitual Offender), Flee/Elude, Trafficking in Methamphetamine, Possession of Fentanyl, Possession of Cocaine, Possession of MDMA, Possession of Hydrocodone, Possession of Suboxone, and Possession of Drug Paraphernalia. Surveillance units observed Bradway driving a silver Acura in the area of operation. Mr. Bradway is known to detectives for illegal narcotics and not having a valid driver's license. A traffic stop was attempted on Mr. Bradway; however, he refused to stop and fled the area until he crashed into a tree along Carlton Court in Leesburg. Mr. Bradway was secured without incident. Detectives then conducted a search of the car, during which approximately 52 grams of methamphetamine, plastic baggies containing Fentanyl, Cocaine, MDMA, Hydrocodone pills, Suboxone pills, and numerous amounts of Drug Paraphernalia were located. Mr. Bradway had a one-stop-shop of illegal narcotics, which, based on the number of narcotics and packaging material, are indicative of illegal narcotic sales.

Kyle Vanzant was charged with Possession of Methamphetamine with the intent to Distribute, Grand theft of Firearm, Possession of Marijuana over 20 grams, and Possession of Drug Paraphernalia. A traffic stop was conducted on Mr. Vanzant in the operational area. During the traffic stop, probable cause was developed to search the vehicle that Mr. Vanzant occupied. During

The Last Rainbow Springs Cowboy



What I believe was the last Rainbow Springs Cowboy, Dave Springer has passed away. He is survived by his wife Vicki Edmondson

Springer. They were living in St Petersburg at the time of his passing. He was known for his story telling about the history of local cowboys & cowgirls that competed in the rodeos. He will be remembered as a local historian. He remembered names, dates, events, who won, everything you would want to know about different events.

I first met Dave 30 years ago when we hired him to break a horse for us. At the time he was working at the Rainbow Springs attraction Daily Rodeo. He rode twice a day and made \$10 per show. They would ride bucking horses and most of the time get thrown off because that's what the audience came to see. He camped out in Rainbow Springs most of the time. He had a dog with him.

Dave knew everyone and everyone knew him. Some liked him and some did not. But I remember the stories he told about the cowboys and cowgirls. I also remember the stories he told about the local cowboys and their competing to win the top rider.

I remember one day while working with

the horse in the front yard my mother-in-law sprayed something with the water hose. The horse spooked and Dave almost lost control but he stayed on. When it was all over he rode the horse over next to my mother-in-law and said thanks. "Now that I have the horse right here to watch you do it, do it again". The horse only reacted a little. The next week when he was working the horse, the horse reacted badly. Dave rode by me and said "I'll see you at sun down". He rode the horse for hours, wore him out and then he started listening. Then he rode back into the yard. The horse was dragging but was listening. I think the horse was better good after that.

Dave was always good at remembering names and dates of riders competing in the Ocala rodeos. We lost a real historian that lived in Dunnellon in the 1980s while Rainbow Springs was still a top notch daily attraction, with animals, activities, glass bottom boats, rodeos every day and sometimes two shows a day.

One of our historians is gone. May he rest in peace.

Rainbow Springs changed hands several times and finally the state of Florida bought it to persevere and protect a piece of the natural springs. There were developers trying to develop it for private use. Right now you go in and walk around the springs with the trees and natural native plants and flowers for a couple of dollars for the day. The springs itself is a large pool of multiple, gorgeous blue waters, abundant with fish. You can see clear to the bottom. Pick a good day and visit Rainbow Springs.

From the Governor's Desk

DeSantis Applauds President Donald Trump's Significant Increase in Everglades Restoration Funding

Tallahassee, Fla. — Today, Governor Ron DeSantis applauded President Donald Trump for securing \$200 million for Everglades restoration in the federal budget that the President signed into law yesterday. Since taking office, Governor DeSantis has championed historic investments in Everglades restoration and water quality to protect Florida's precious natural resources. Earlier this year, Governor DeSantis joined Senator Marco Rubio and Senator Rick Scott in asking President Trump to include \$200 million for Everglades restoration in his federal budget.

The \$200 million federal appropriation secured by President Trump for South Florida Ecosystem Restoration is a \$130 million increase in Everglades restoration funding from last year. This important funding advances critical Everglades restoration projects including the Everglades Agricultural Area (EAA) Reservoir Project, which will help reduce harmful discharges to the Caloosahatchee and St. Lucie estuaries and send more water south.

the search of the vehicle, detectives located a stolen 9mm Taurus handgun out of Apopka, prepackaged plastic baggies of Methamphetamine, Marijuana, and numerous items of drug paraphernalia. Detectives also located a small amount of white powder, which tested positive for

Fentanyl and later determined to belong to another individual. The owner of the Fentanyl is still under investigation and an arrest warrant will be obtained at a later time for this individual. The Special Investigations Unit has received numerous complaints about Mr. Vanzant selling illegal narcotics.

Taylor Rigano was charged with Possession of Fentanyl, Possession of Heroin, Possession of Methamphetamine, Possession of Marijuana, and Possession of Drug Paraphernalia. A traffic stop was conducted on a blue sport utility vehicle for a traffic violation that occurred in the operational area. During the traffic stop, detectives developed probable cause to search the vehicle. During the search, detectives located user amounts of Heroin, Fentanyl, Methamphetamine, Marijuana, and numerous amounts of used needles and smoking devices. Rigano was transported to the Lake County Jail without incident.

This investigation is ongoing and more arrests are expected.

Happy New Year! Protect Your Identity!

With the Holiday Season coming to an end and the New Year beginning, it is important to remain vigilant. Identity theft is a topic that is

critical because once you become victimized, it is difficult to clear your name and credit if it becomes compromised. Perpetrators will steal data such as social security numbers, date of birth, addresses, and bank account information. If your information is stolen, you may receive correspondence from companies or creditors for debt you weren't aware of.

There have been recent vehicle burglaries where wallets, pocketbooks, and backpacks have been left in both the front and back seats. The victim's driver's license, debit cards, and check book were in possession of perpetrators that wrote checks and passed them using the bank's drive through teller lane that is farthest from the window also known as "felony lane." The person passing the check will disguise themselves to match the appearance on the victim's photo identification card by using wigs and sunglasses. It may sound peculiar to some but it works because the teller is busy with the transaction and cannot truly verify the identity. This is why it is so important not to leave anything of value in your vehicle even

if it's locked.

Credit card fraud and other financial scams are one of the most reported uses for identity theft. Some criminals steal credit card information only to make immediate purchases before the card is reported stolen. One of the bigger problems is if other accounts are opened under your name. You may see bank or credit card transactions against your account that you did not make. There may be outstanding debt from different accounts that will be in your name and will be your responsibility to pay them off or start the process of claiming identity theft. The process of clearing your name and credit can be costly and take an emotional toll on the victim.

Here are some tips to help prevent identity theft:

- Shred all documents that you no longer need that have personal information on them.
- Notify the post office to hold your mail if you will be out of town or have someone you trust pick up your mail.
- If using on-line sources for banking or shopping, make sure the site is secure and try to avoid using public computers or public Wi-Fi.
- Watch your surroundings when entering PIN numbers as criminals will attempt to watch from behind.
- Avoid providing personal information over the phone unless you are sure of who you are giving it to.
- Regularly check your credit report for suspicious activity.

If you become a victim it is important to:

- Immediately notify the company you have credit with about any transaction you did not authorize.
- File a police report or an online report with the Federal Trade Commission.
- Notify the three credit agencies: Experian, TransUnion, and Equifax.
- Follow-up to make sure that your credit is flagged for fraudulent activity. A fraud alert can be put on your credit to alert businesses that they must contact you prior to opening accounts.

The Lady Lake Police Department reminds you that we are here to help protect you from criminal activity but protecting your identity starts with you. Using some of these tips can help you from becoming a victim.

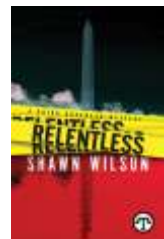

Attorney General Moody Applauds Congress for Passage of TRACED Act

TALLAHASSEE, Fla.—Attorney General Ashley Moody thanks Congress for passing the Telephone Robocall Abuse Criminal Enforcement and Deterrence Act. The TRACED Act, passed by the U.S. Senate Thursday, is designed to reduce the number of illegal robocalls and stop spoofing—the practice of using technology to disguise a caller's phone number. The Act will now go to President Donald J. Trump for his signature.

Attorney General Ashley Moody said, "Passing this Act is vital step in our fight to stop illegal robocalls and the scams that often accompany them nationwide. We must stop the inundation of robocalls that has been the norm for far too long. This legislation will also give us better tools for

going against the practice of spoofing so we can better protect consumers."

Attorney General Moody urged Congress earlier this year to pass the legislation because the TRACED Act enables states, federal regulators and telecom providers to each take steps in the effort to combat illegal robocalls. The legislation requires voice service providers to participate in a call authentication framework to help block unwanted calls. In addition, the Act creates an interagency working group that can take additional actions to reduce robocalls and hold telemarketers and robocalls accountable.

In March, Attorney General Moody joined a multistate bipartisan group of 54 attorneys general in sending a letter to the U.S. Senate Committee on Commerce, Science and Transportation in support of the

bill.

More than 48 billion robocalls were made in 2018. Robocalls remain the number one source of consumer complaints to the Federal Trade Commission and the Federal Communications Commission, resulting in millions in consumer losses every year.

Despite Language Stating Otherwise, Proposed Ballot Initiative Will Not Make Conduct Legal

TALLAHASSEE, Fla.—Attorney General Ashley Moody today filed a petition regarding the Adult Use of Marijuana initiative. The initiative's ballot summary claims it will permit adults to possess, use and buy marijuana. In fact, nothing could be further from the truth. Using and possessing the drug is and will still be a crime under federal law. Federal penalties for possessing the Schedule 1 Controlled Substance are and will remain significant.

Attorney General Ashley Moody said, "Facts matter. Before Florida voters are asked to make critical changes to our state constitution, those facts should be made clear. That's why, by law, any citizen initiative seeking to amend the state constitution must offer voters a summary explaining the legal effect of that amendment—painting a full picture of the important choice voters are asked to make. This initiative suggests to voters that their vote will allow for conduct that will remain illegal with significant penalties."

Previous proposed ballot initiatives to change Florida's marijuana laws warned voters that the amendment applied "only to Florida law" and would not "immunize violations of federal law." This initiative's ballot summary simply does not do that. Unlike those prior initiatives, this initiative completely omits the illegality of this conduct under federal law. Given this oversight, the Attorney General's Office must oppose placement of this new proposed amendment on the ballot.

Under Florida Statutes § 16.061, the Attorney General is required to file a petition with the Florida Supreme Court seeking an advisory opinion once an initiative is certified by the Secretary of State as crossing a threshold of signatures. Article XI, §3 of the Florida Constitution and Section 101.161 of the Florida Statutes impose requirements on the titles and summaries of initiatives, so that Florida's citizens will know what they are voting on and not be misled.

In accordance with state law and Florida's Constitution, Attorney General Moody is also challenging several additional misleading initiatives. The Attorney General's Office has not challenged the minimum wage initiative—a proposed one-sentence change to the State Constitution.

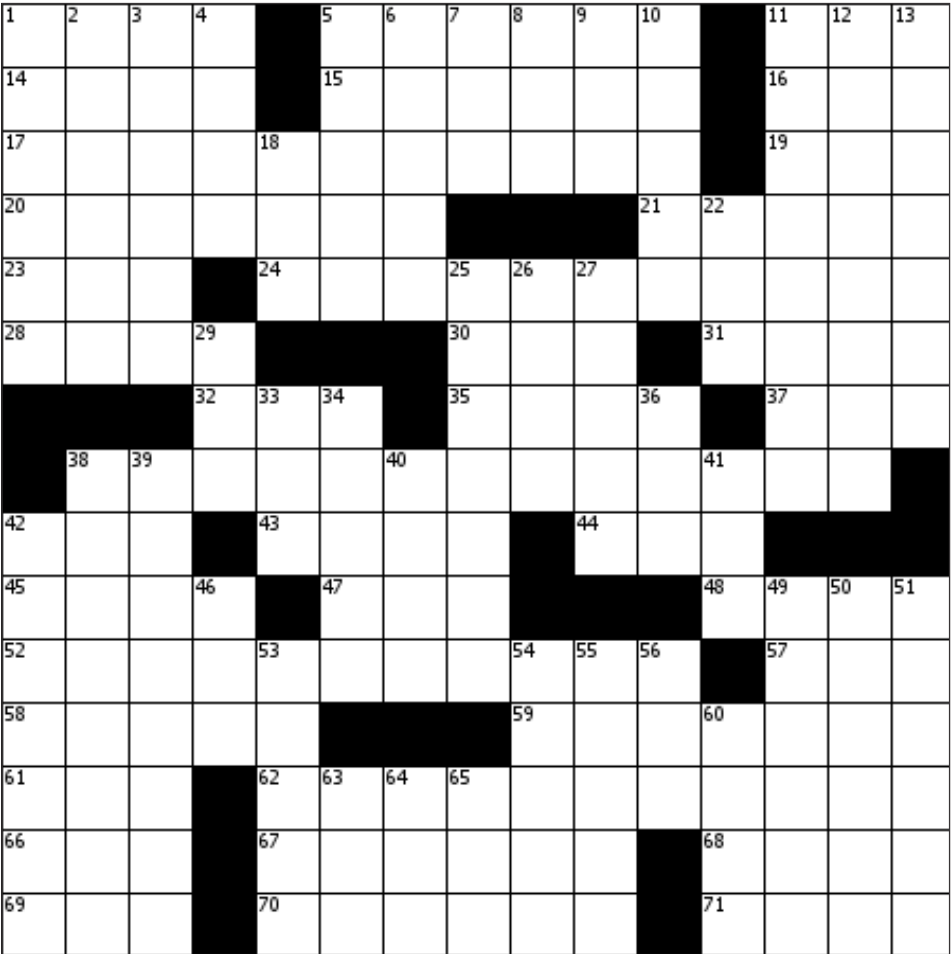

How People With Low Vision Can Stay Safe And Independent

(NAPSI)—People with low vision have blind spots that can make it difficult or impossible to drive, read or see faces. These impairments cannot be corrected by surgery or

glasses. What's more, too many are blind to the realization that much can be done to improve their quality of life.

What Can Be Done

In fact, low vision rehabilitation services help people make the most of the vision they have. The first step is to get an eye exam by an ophthalmologist, a physician who specializes in medical and surgical eye care.

Who Can Help

An ophthalmologist can determine the full extent of vision loss and exact location of blind spots. Either the ophthalmologist or a low vision specialist can then determine the best techniques and devices that can help you get around your individual challenges.

Where EyeCare America Comes In

If you're concerned about the cost of the exam, the American Academy of Ophthalmology's EyeCare America program may be able to help. This national public service program provides eye care through volunteer ophthalmologists for eligible seniors 65 and older; and those at increased risk for eye disease. As one EyeCare America patient said, "I'm a senior living on a low income. It had been 30 years since I'd had an eye exam. It was a true blessing to receive this service."

Low Vision Services Offer Hope

The field of vision rehabilitation has advanced significantly over the years, offering more effective technologies and strategies. Today, ophthalmologists' solutions range from simple, portable video magnifiers to enlarge text and objects to high-tech glasses with cameras that let people read text and see faces.

In addition, there are many simple changes people can make on their own to help them live better:

Improve contrast. Contrasting colors can make it easier to accomplish household tasks

and improve safety. Put dark place mats under white place settings, get area rugs that are a contrasting color with the floor and kitchen towels and cutting boards that contrast with the counter top. Use contrasting colored tape along the edges of rugs, stair steps and lamp shades.

Improve lighting. Every year, about three million older Americans are treated for injuries from falls, according to the Centers for Disease Control and Prevention. Many of these falls are caused by low vision. Add lighting to staircases and dark hallways. Remove rugs from hallways to prevent tripping. Task lighting in the kitchen can make food preparation safer and easier.

Reduce clutter and organize. A cluttered house is more difficult to navigate and can

contribute to falls and frustration. When each item has a specific place and is identified with a high-contrast label, it's easier to locate items needed for everyday living.

Embrace technology. Books on tape and personal voice-activated assistants, such as Google Home or Amazon's Alexa, can be enormously helpful for people who can no longer see well enough to read, dial a phone or set a thermostat. With a simple voice command, these can phone dial a friend for you while the thermostat dials up the heat.

While there isn't one strategy or tool that works for every person, vision rehabilitation offers hope for many and can help people stay in their homes and continue doing the things they love.

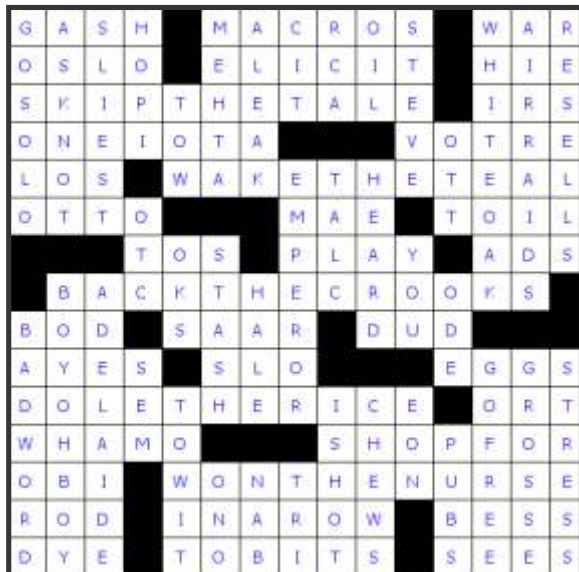
