## AS I SEE IT

What is the 'ELECTORAL COLLEGE' ?  
- Apparently USA elections are not 1-person=1 vote "as advertised".

Donald Trump lost to Hilary Clinton by over 3 million votes, but the so-called 'electors' quickly fixed it.

This time, Joe Biden won by over 6 million votes and they are trying to 'fix' that too.

Contrary to what we are told, these 'electors' are appointed by state politicians and are not legally bound by the recent election.

Some States (Maine and Nebraska) split their Electoral votes regardless of their voters choice. Others choose their Electors based on the NATIONAL popular vote regardless of their State's vote.

Fact is that the Republicans can put President Trump back in office. It's perfectly legal. If/when it happens no-one, not the Senate, the military or anyone else has any legal right or authority to stop it. What might be worse is that future Presidents will know that it can be done.

Win enough State Governorships and you can 'stack' the Electors any way you want. As mentioned above, the 'Popular Vote' already means nothing, does it?

What is 'RANKED CHOICE VOTING'?  
In most elections the candidate with the most votes wins as in Florida and most other states.

For example, in a three person race if A gets 40% and the other two, B and C get 35 and 25%, the winner is A the 40% vote getter.

That seemed fair enough, until I realized that the 40% winner defeated the 60% losers.

Recently Alaska changed to Ranked Choice Voting. The lowest vote-getter is eliminated.

For example, in a 4-person election, voters would mark their first choice candidate on the ballot, with the proviso that

says "If my candidate is eliminated (comes in last), then transfer my vote to my second choice AND if/when that candidate is eliminated, transfer my vote to this candidate"

This ensures that the winner has more than 50%, a majority of the voters.

So, who should be elected, the candidate with 40% support under the present system or the candidate with more than 60% support under Ranked Choice Voting?

Another advantage is that it also eliminates runoffs like they are having in Georgia right now.

As I See It, Republicans and Democrats alike want final results on election day, not weeks later.

But a possible problem for Alaska is that primaries will now be open to all voters. That is, candidates can run without ties to either party.

Only the top four vote getters advance to the general election, even if they are all from the same party.

Somehow that doesn't seem like a good idea.

Ballots could simply ask "Which Democrat do you want to vote for?"

Where are we with a COVID VACCINE? Seems like wild claims of success are rampant, but verifiable facts are few.

The claim of "95% EFFECTIVE" means only that the vaccines stimulate so-called 'anti-bodies' in patients.

As I See It, that is not at all the same as proving that a vaccine will prevent infection, which is what 'vaccination' means.

Simple questions never asked of the manufacturers include "Have you, your family, your friends and your staff all taken the vaccine?"

Seems to me that if they don't trust their own product, why should we?

## North Florida Land Trust Donation

**North Florida Land Trust has received a conservation easement donation in Columbia County**

*The Griffis family donated the easement which is within the critical O2O wildlife corridor*

**Jacksonville, Fla., Oct. 28, 2020** – North Florida Land Trust has received a donation of a conservation easement in Columbia County which lies within the critical Ocala to Osceola, or O2O, wildlife corridor. Sam "Buck" Griffis and his wife, Vickie, donated the land on their 68-acres known as Sweet Gum Farm to make sure it remains free from development forever. A grant NFLT received from the EJK Foundation of Houston, Texas helped to fund the due diligence that was needed to complete the donation.

"Buck and Vickie consider the farm a sanctuary and wanted to make sure no one could come in and turn their beautiful farm into a residential development," said Jim McCarthy, president of NFLT. "The Griffis' will continue to own the land where they enjoy raising cattle, horses and chickens while ensuring it will remain a farm and natural forest in perpetuity."

In addition to the farmlands and some unimproved pastures, the property consists of pine flatwoods, depression marshes, mixed scrub-shrub wetlands and upland hardwood forests. It lies within the boundaries of the Osceola National Forest and is adjacent to the forest on two sides. Preserving the land not only protects it from development but also helps further the objectives of The Forest Plan for the National Forests in Florida. The plan aims to improve ownership patterns of the forest to enable important management techniques including prescribed burning.

The 1.6 million-acre O2O corridor is a preservation focus for NFLT. It provides an

important habitat for the Florida Black Bear and numerous endangered species including the red-cockaded woodpecker, indigo snakes and gopher tortoises. The nonprofit is currently leading the O2O Wildlife Corridor Partnership, an effort by public and private organizations to accelerate land conservation within the O2O.

The EJK Foundation awarded NFLT a \$450,000 transformational grant to help support its efforts in the O2O Wildlife Corridor and also issued a \$75,000 challenge grant for additional funding for the project.

McCarthy said, "The EJK Foundation grant has allowed us to save another piece of the beautiful natural landscape from future development. We encourage any landowners, ranchers or farmers that want to do the same to please give us a call."

NFLT has until August 31, 2021, to meet the challenge and is actively seeking funds to be matched 1:1 by the EJK Foundation if the \$75,000 goal is met. ## Super Computer True or False

A man who once claimed he could prove a federal conspiracy against Sheriff Joe Arpaio — and who collected more than \$100,000 from the Maricopa County Sheriff's Office before it determined his claims were baseless — is now a key figure in a right-wing vote fraud conspiracy theory being pushed by key supporters of President Donald Trump.

Media reports and conservative activists on social media say Dennis Montgomery has been spreading the claim that widespread voter fraud is the product of a deep-state supercomputer called "The Hammer" and software called "Scorecard." According to the claims circulated online, those systems were allegedly used to alter ballot counts across the country.

The right-wing website American Report apparently helped launch the idea in a story it published Oct. 31. American Report features, among other things, extensive stories reiterating right-wing conspiracy theories from the Obama administration era.

The site said Montgomery claimed to have developed the HAMR, or Hammer, computer and the Scorecard software in the late 2000s, and that it was commandeered by the Obama administration and used to steal the 2012 election and is now being used to steal the election on Biden's behalf.

The claim has been pushed by former Trump adviser Steve Bannon, former national security adviser Michael Flynn, Fox Business host Lou Dobbs and other high-profile allies in Trump's orbit — though researchers have thoroughly debunked the idea.

## Holiday Blues?



### Many Older Americans Heading Into The Holidays Feeling Depressed

(NAPSI)—Many older Americans say they feel depressed—yet the majority of them are not planning to get help, according to a new national survey—though it could make a tremendous difference in their health and well-being.

With the onset of colder weather, fewer daylight hours, and the effect of the pandemic on holiday celebrations and traditions, more seniors than ever could be struggling with depression.

The GeneSight Mental Health Monitor reported that about two-thirds of adults 65 and older who are concerned they may be suffering from depression say they won't seek treatment. That's compared to fewer than half of adults over age 18. In addition, three in 10 of these older adults think "they can just snap out of it."

"The 'pull yourself up by your bootstraps' mindset and reluctance to talk about mental health may be preventing seniors from getting the help they need," said Dr. Mark Pollack, chief medical officer of Myriad Neuroscience, makers of the GeneSight test, a genetic measure that identifies potential gene-drug interactions for depression medication. "People seek treatment for conditions like heart disease, high blood pressure or diabetes. Depression is no different. It is an illness that can and should be treated."

One GeneSight patient, Carmala Walgren, a 74-year-old resident of New York, agrees that depression should be

# Working Daughters Deserve Support

(NAPSI)—For the approximate 23 million women who balance caring for an aging parent with going to work, and often raising children of their own, there is little recognition and not enough support. These women themselves often don't think of what they do as caregiving; they just consider themselves dutiful daughters. Yet they average 24.4 hours of unpaid care a week, from buying groceries, to managing medication, helping with household chores, assisting their parents with bathing and dressing, and driving to appointments. Many are even providing complex medical

tasks, with little or no training, such as administering injections, monitoring vital signs, caring for wounds or cleaning feeding tubes. Collectively, they provide \$470 billion in unpaid care, according to the AARP.

Often, these women provide this care at great cost to their careers. Working daughters, much like working mothers, may need to switch to a less demanding job, take time off or quit work altogether. They lose wages and job-related benefits costing them, on average, \$304,000 in lost wages and benefits while spending nearly 20 percent of their own income on caregiving.

To give these unsung heroes recognition and much needed support, it's important to make the care they give compatible with their careers. With 10,000 people turning 65 every day in the United States, the caregiving workforce is only going to grow. Smart businesses must examine policies and corporate cultures to create environments where caregivers can thrive. Working



daughters need flexibility, paid family leave policies and expanding eligibility requirements. They need affordable, quality eldercare options.

Follow these tips to help ensure we all *Arrive Alive* this holiday season:

- **Never drive impaired.** Celebrate responsibly and do not get behind the wheel if you have been drinking or took drugs that cause impairment. Plan ahead and find a safe way home every time – designate a driver or use a ride service.

- **Check your tires.** Tires are a vehicle's first line of defense on the road. Check your tire pressure, tread depth and spare tire especially before long trips. Do not overload your vehicle, it can result in premature wear and tire blowouts.

- **Buckle up.** A seat belt is your vehicle's most important safety feature. Florida law requires that all drivers, all front seat passengers and all passengers under the age of 18 wear seat belts or the appropriate child restraints. Seat belts save lives, so buckle up every trip, every time.

- **Register or update your Emergency Contact Information (ECI).** ECI is a secure system allowing law enforcement, nationwide, to contact designated family or friends in response to an emergency situation.

- **Observe and obey all speed limits.** Speed limits may change as you drive through different types of roadways, so make sure you adjust your speed accordingly. In Florida, the limit will never be over 70 mph.

### Keeping Your Home Safe

- We all want our homes to reflect the joy of the season, but avoid displaying gifts where they can be seen from a window or doorway.

- Arrange to have packages delivered to a neighbor if you're not home to receive them. Packages left on porches or doorsteps are "easy picking" for thieves. It also draws unwanted attention to your home.

- Consider simple outside decorations. Elaborate decorations are sometimes stolen right off the lawn.

- Be sure not to obscure the view from your windows. You need a clear view of your property.

- Always lock your home's doors and

windows, even if you're only gone for a few minutes.

- Dispose of gift packaging discreetly. Often criminals will spot something you've discarded and can target you for their next burglary or theft.

### Remain Alert While Shopping

- Always lock your car and close the windows, even if you're only gone a few moments. When possible, lock all merchandise or packages in the trunk of your car. Load your packages before departing and not at the next destination.

- Shop with at least one other person. Have your car or house key in your hand as you approach the door.

- Stay alert to your surroundings and the people around you. Look inside your car and around it as you approach.

- Be mindful of your purses and wallets. Be sure that your purse is secured as you travel to and from the store and don't leave it in a shopping cart unattended. Keep wallets in a side pant pocket or an inside pocket of a coat, if possible.

## LCS Charities 8th Annual Bass Fishing Tournament

February 13th, 2021

Hickory Point Recreation Complex  
Rules:

**1. ENTRY FEE:** \$100.00 per boat (includes big bass), 2 contestants per boat. On time entries must be postmarked by February 6, 2021. Late entries will be accepted at the ramp or after 2/6/2021 at the rate of \$120.00.

**2. ELIGIBILITY:** Boat Operator must be 18 years of age. Parent's signature required for any minor fishing the event. Entry form must be completely filled out and signed by both contestants.

**3. Tournament Size and Limit:** Minimum size 12 inches guidelines with state exemption permit. Tournament limit 5 largemouth bass per boat. No culling of dead fish.

**4. Dead Fish:** Dead fish penalty will assess at the rate of .25 pound per dead fish. To be considered a live fish it must swim off

upright within 3 minutes witnessed by a tournament official. Dead fish penalty will be deducted before consideration for BIG BASS AWARD.

**5. TOURNAMENT HOURS:** SAFE LIGHT until 3:00 pm. Boats will be launched in 25 boat flights and will be allowed 15 minutes per flight time extension per flight. Boats will check out by end of fishing pier and check in at the same.

**6. Late Penalty** will assess at 1 pound per minute up to 15 minutes, then disqualified.

**7. TAKE-OFF:** Will be in order in which entries are received. Confirmations will be sent to the boater's provided email.

**8. TACKLE & EQUIPMENT:** Only artificial lures may be used. All bass must be caught in a legal sporting manner.

**9. No Trolling:** Trolling is use of the outboard to power the boat to give action to the lure.

**10. BOATS & MOTORS:** Boats 16 feet or longer, with properly working aerated live-wells and kill switch. NO

OVERPOWERED BOATS ALLOWED. All boats must meet B.I.A., U.S. Coast Guard regulations.

**11. Life Jackets:** MUST BE WORN anytime the outboard is running until check in. Kill switches MUST BE Attached to the driver anytime the combustion motor is running. Each contestant is expected to follow high standards of sportsmanship, courtesy, safety and conservation. No alcoholic beverages, stimulants or depressants allowed in boats during tournament hours.

**12. PERMITTED FISHING LOCATIONS:** Anywhere on the tournament water except within 50 yards of another Contestant's boat or the take-off / launch area. All fishing must be done from boat. No Contestant may leave the boat to fish or land a fish.

Tournament Director has final decision. Any violation of these rules may constitute disqualification from this event with no refund of entry fee.

fields of the future and the workforce that's needed. Equipping community colleges with programs that serve this transition will help bolster a new American workforce, powered by advanced manufacturing and FHE and other technology. Increased

demand for both awareness-boosting and skill-building programs will help drive technology development and subsequent commercial proliferation of FHE and the greater advanced manufacturing industry.

While the tech workforce hasn't been immune to disruption from COVID-19, it remains a field expected to have one of the biggest demands for a skilled workforce in the future. The pandemic has temporarily reduced that workforce; there's a promising future for advanced manufacturing in 2021 and beyond.

To match these growing markets, there will be an increasing demand for workshops and seminars that showcase the benefits the technology offers for diverse application spaces, as FHE technology continues to mature and demonstrate its potential to transform advanced manufactured products. This includes more defense and industrial demand for engineers with the knowledge, skills and abilities to design and manufacture FHE-enabled products as the technology nears commercialization.

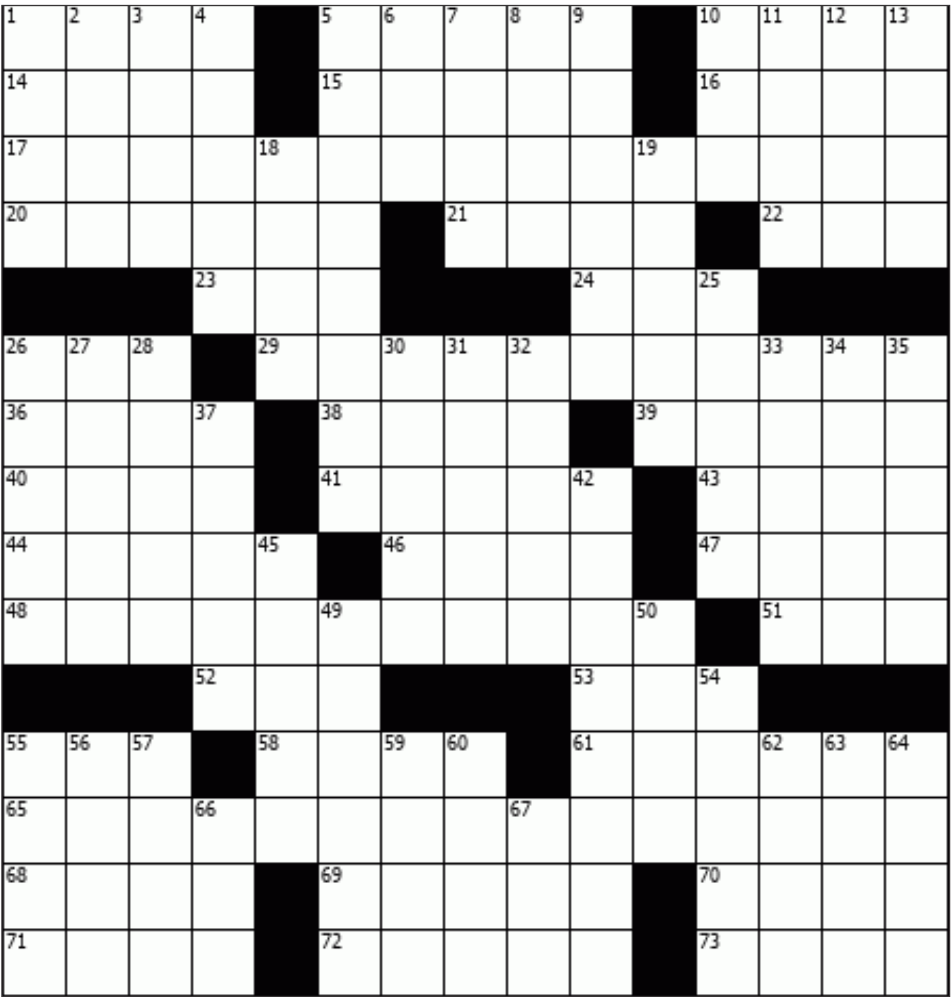

treated regardless of age.

“There is such a stigma about depression among people my age,” said Walgren. “It is worth it to find treatment that helps you.”

**Canceling Holiday Celebrations and The Effect on Mental Health**

The pandemic is taking a toll on the mental health of older Americans. Nearly one in four people over age 65 said that the news about the pandemic has left them “feeling consumed with sadness.” For those seniors who think they might have depression, the number climbs to nearly 4 in 10. Concerns about COVID are also why more than one in three seniors worried about being depressed say they are “somewhat” or “very likely” to cancel holiday celebrations such as Thanksgiving.

Even as some consider canceling holiday festivities, isolation from friends and family remains a concern. Just under half of these seniors say they feel “isolated and disconnected from family,” compared with 28% of all respondents over age 65, and 24% of respondents over age 18.

**Connecting Can Help with Depression**

Parikshit Deshmukh, M.D., CEO and medical director at Balanced Wellbeing, LLC, specializes in geriatric psychiatry. According to Dr. Deshmukh, families should make plans to connect virtually if they don't feel comfortable about getting together in person. Further, caregivers should be vigilant in looking for the signs of depression in their older loved ones.

“It's more important than ever to let each other know we care and that we are not alone—even if it feels that way,” said Dr. Deshmukh. “Video calls might not be for

everyone. Yet, if that's the only way to stay in touch, we need to do it.”

And Dr. Deshmukh reminds seniors to talk to their doctors. “If your clinician recommends treatment, ask about the GeneSight test. The results can help them make decisions about medications to treat your depression.”

## FROM THE DESK OF ATTORNEY GENERAL MOODY



### Attorney General Moody Announces \$113 Million Agreement with Apple Over iPhone Throttling

TALLAHASSEE, Fla.—Attorney General Ashley Moody today announced a \$113 million agreement with Apple, Inc. regarding Apple's decision to throttle consumers' iPhone speeds in order to address unexpected shutdowns in some iPhones. Attorney General Moody is joined by more than 30 other attorneys general in reaching the agreement.

Based on the multistate investigation, Apple allegedly discovered that battery issues were leading to unexpected shutdowns in iPhones. Rather than disclosing these issues or replacing batteries, Apple updated software that reduced iPhone performance in an effort to keep the phones from unexpectedly shutting down.

The attorneys general allege that Apple's decision to throttle the performance of consumers' iPhones led to Apple profiting from selling additional iPhones to consumers whose phone performance Apple had slowed.

Attorney General Ashley Moody said, "Countless Floridians depend on their iPhones daily for necessary professional and personal communication and pay significant fees for this service. It is

essential that a widespread and trusted service provider such as Apple provide accurate and reliable information about performance issues and viable options if service is disrupted. I am proud of this action that will require Apple to be more transparent to consumers and hold them accountable for their actions that negatively impacted many Floridians."

Under the agreement, Apple will pay the Florida Attorney General's Office \$5,088,588. In addition to the monetary payment, Apple must also provide truthful information to consumers about iPhone battery health, performance and power management. Apple must provide this important information in various forms on its website, in update installation notes and in the iPhone user interface itself.

The consent judgment states:

- Apple will maintain easily accessible and prominent webpages that provide clear and conspicuous information to consumers about lithium-ion batteries and unexpected shutdowns. The webpages will provide guidance to consumers on steps they can take to maximize battery health;

- Apple will ensure its consumer-facing staff and Apple-authorized iPhone retailers are familiar with these webpages; and

- Apple will provide information to consumers in the iPhone user interface settings about the battery, such as the battery's maximum capacity and

information about its peak performance capability.

In addition, Apple recently entered into a proposed agreement resulting from class action litigation related to the same conduct that requires Apple to pay up to \$500 million in consumer restitution.

The proposed consent judgment is pending judicial approval.

### Attorney General Moody's Office of Statewide Prosecution Secures Life Sentence for Child Sex Predator

TALLAHASSEE, Fla.—Attorney General Ashley Moody's Office of Statewide Prosecution has secured a life sentence for a Hillsborough county man that engaged in, and promoted, child sex

pornography. The jury found Roger Labor guilty of lewd or lascivious molestation, two counts of use of a child in a sexual performance and 50 counts of possession of child pornography. The Honorable Michael Williams of Florida's 13<sup>th</sup> Judicial Circuit sentenced Labor to life for lewd or lascivious molestation and a total of 75 additional years for the remaining charges.

Attorney General Ashley Moody said, "This disgusting excuse of a man will stay behind bars for life, right where he belongs. He is a predator and his actions were beyond vile and repugnant. I am so proud of the Office of Statewide Prosecution's hard work on this case and for making sure he never victimizes a child again."

Commissioner Rick Swearingen said, "Heinous crimes like those committed by Labor have no place in civilized society, and I commend all those who worked tirelessly to bring him to justice. I hope this life sentence will help his victims to heal and will serve as a warning to those who would prey on the most vulnerable among us."

In 2017, the Florida Department of Law Enforcement received cyber tips from the National Center for Missing and Exploited Children indicating that a Google user in Hillsborough county uploaded suspected child pornography. After further investigation, law enforcement seized numerous electronic items from Labor's residence. A forensic examination of the electronic items recovered more than 5,000 pornographic images. The investigation also discovered two victims that Labor molested and used to promote child pornography.

Assistant Statewide Prosecutors Rita Peters and Diana Bock prosecuted the case.

### MFCU Arrests Woman for Defrauding Medicaid More Than \$15,000

TALLAHASSEE, Fla.—Attorney General Ashley Moody's Medicaid Fraud Control Unit and the Levy County Sheriff's Office arrested a woman for organized fraud and fraudulent use of personal identification information to defraud a Medicaid provider. Carolyn Ausherman allegedly forged fraudulent Medicaid employee service logs, defrauding the Medicaid program out of more than \$15,000.

Attorney General Ashley Moody said, "The Medicaid program provides necessary medical services to our most vulnerable citizens. To purposefully defraud this taxpayer-funded program for personal benefit is a gross injustice and exploitation of the patients dependent upon the care provided by Medicaid. I am confident my Medicaid Fraud Control Unit will continue to work diligently to hold accountable anyone who attempts to defraud the Medicaid program and taxpayer dollars."

According to the investigation, Ausherman entered into an agreement with an employee of a Medicaid provider wherein Ausherman used the employee's name to submit forged and fraudulent service logs to the Medicaid provider. The service logs submitted by Ausherman claimed that the employee provided caregiving services to the Medicaid recipient, a disabled adult. The investigation revealed that the employee never provided services to the disabled adult. The Medicaid provider issued paychecks to the employee that were then cashed and split with Ausherman.

Ausherman faces one count of organized fraud and one count of fraudulent use of personal identification information, both third-degree felonies punishable up to five years in prison. The Attorney General's Medicaid Fraud Control Unit will prosecute the case through an agreement with the State Attorney's Office for the Eighth Judicial Circuit.

### Beware of COVID-19 Texting Scam

TALLAHASSEE, Fla.—Attorney General Ashley Moody is warning taxpayers of a new COVID-19 related text scam that deceives recipients into disclosing personal banking information in order to receive a \$1,200 stimulus check. This latest scam impersonates the Internal Revenue Service. The Attorney General's Office reminds taxpayers that the federal government and state agencies will never require personal banking information to be disclosed via text message to receive stimulus payments.

Attorney General Ashley Moody said, "As long as COVID-19 remains a threat, scammers will attempt every trick in the book to exploit taxpayers and coerce them into disclosing personal information. I encourage all Floridians to familiarize themselves with emerging COVID-19 scams, available on our COVID-19 resource webpage at

[MyFloridaLegal.com/COVID19](http://MyFloridaLegal.com/COVID19)."

The scam text message states the recipient received a \$1,200 direct deposit from COVID-19 TREAS FUND and requires further action for the payment to be deposited into the account. The text then directs the recipient to follow a fake phishing link.

The bogus phishing URL appears to be a state agency or relief organization's website. However, when clicked, the URL directs recipients to a website fraudulently impersonating the IRS. Scammers use the website with the goal of collecting the personal and financial information of individuals who visit the fraudulent site.

Those who receive this text should immediately report it to the IRS by sending a screenshot of the message to [Phishing@IRS.gov](mailto:Phishing@IRS.gov) with the following information:

- Date, time and time zone the text message was received;
- The 10-digit phone number that sent the text; and
- The recipient's mobile phone number.

The Attorney General's Consumer Protection Division reminds taxpayers that the IRS will never send unsolicited texts or emails requesting personal information, call with threats of jail, lawsuits or demand tax payments on gift cards. If you receive any correspondence you believe to be fraudulent, report it to the Attorney General's Office by visiting [MyFloridaLegal.com](http://MyFloridaLegal.com), calling 1(866) 9NO-SCAM or downloading the No Scam app, available in English and Spanish, on all Apple and Android devices.

If you believe you are eligible for the Economic Impact Payment, please visit [IRS.gov](http://IRS.gov). If you do not have a filing requirement but are eligible for EIP, use the non-filers tool on the IRS website before Nov. 21 to claim the payment.

Earlier this year, the Attorney General's Office created the *Scams at a Glance* program, designed as a resource for Floridians to use for protection against fraud as the state and nation continue to battle the COVID-19 pandemic. The *Scams at a Glance* website provides downloadable brochures designed to teach consumers how to avoid falling victim to fraud, including an IRS Imposter Scams brochure.
