The Sumter County raging tax battle has been temporarily stopped. It has been tabled until July. Three new Sumter County Commissioners Miller, Search and Estep have voted against the compromise that has been proposed. The proposed tax could have doubled the taxes for the residents and businesses in Sumter County.

Recently the Developer offered to pay \$40% more of the road impact fees on every home they build. The compromise was denied by the County Commission. All three County Commissioners have their own idea of a fair taxation. Some of the increased taxes are supposed to assist with the New UF Health Hospital.

Commissioner Breeden has rejected any taxation on the people of Sumter County. Breeden said when we raised the ad Valorem

tax we promised the people that we would not raise taxes for five years, that was in 2018.

Commissioner Doug Gilpin was not agree. I guess we will have to wait till July to see how it is worked out.

Dear Friends,  
The 2021 Legislative Session will be underway as of March 2 and already the picture is becoming a little clearer about what the priorities of the Florida Legislature will be. The eight weeks of committee hearings leading up to this have had numerous state agency and local government presentations, along with citizen input, about the challenges our

state faces and the needs we will be asked to meet. I will share a few of those highlights with you today.

The state budget is always the top concern, as the only constitutionally mandated duty of the Florida Senate is to pass a balanced budget. We do not have to do anything else or pass a single bill, except that one. Which we have done, faithfully, each year. This year, with the COVID crises, the forecasting is predicting a budget shortfall, which means that cuts will be

made and many good projects will go unfunded. This will be an exercise in frugality and efficiency and will not be all together bad for our state. A budget event like this can be a good reset for Florida as it brings in to focus those things, which are actually a priority. We are in a good place with Senator Kelli Stargel leading our efforts in this area and she has my full confidence.

SB 498, sponsored by Senator Joe Gruters is a bill that your Senator is particularly excited about seeing pass this year as this is something that we have been working on for a long time. This bill fixes an issue for many churchgoers and others that attend religious institutions that are connected to a school. Currently, state law prohibits a person from

carrying a firearm to defend themselves in these places. SB 498 will remove this prohibition and let these churches and other religious institutions decide for themselves. This is a great pro-second amendment and pro-property rights bill.

SB 744 is another bill that your Senator is co-sponsoring this year and could be a huge win for the pro-life movement if passed. This bill is called the "Florida Pain-Capable Unborn Child Protection Act", which you probably have heard of already as other states have passed in some form or another. This bill would prohibit doctors from performing an abortion procedure on an unborn child more than 20 weeks old. This is the age that most physicians agree that an unborn child can feel pain. This bill is not perfect, but it is a step in the right direction and will save many lives.

Unfortunately, because of the issues with COVID, the Senate President is not allowing visitors to our offices in the Capitol, but we are holding virtual meetings and phone calls with any constituents who have concerns or ideas. So, please do not let that stop you from reaching out to our office. We need your input in this process. I work for you.

## A Tool To Save Lives



(NAPSI)—Heart disease is a leading cause of death for all Americans, but the death rate is higher for African American men and African

American women of all ages than for whites. To help community health workers in African American communities teach others about heart disease prevention, The Heart Truth®, a program of the National Heart, Lung, and Blood Institute, recently released a new resource, "With Every Heartbeat Is Life," that provides culturally tailored information about heart health. It is a resource for community health workers to use when holding educational sessions on heart disease in their own communities. It has culturally relevant information, such as heart-healthy modifications of traditional recipes, to make the manual particularly useful and meaningful in African American communities.

Heart-health experts developed the toolkit to help community health workers teach the course and engage participants using idea starters and picture cards to generate conversations.

The curriculum discusses heart disease risk factors and prevention, blood pressure, cholesterol levels, diabetes, alcohol consumption, weight management, sleep, physical activity, stress, and not smoking. The resource provides practical tips, such as eating healthy even when money is tight, and how to act in time to respond to heart attack signs.

# Keep Your Air Clean



(NAPSI)—People are increasingly concerned about dirt and germs these pandemic days, but many are neglecting an unseen area where airborne contaminants can lurk: the air ducts.

March 22-28 is National Drug and Alcohol Facts Week. Addiction can happen to any person regardless of age. It usually starts when a person

## Tiny Teeth Are A BIG Deal



(NAPSI)—With more than half of the state's third graders having experienced tooth decay, the Tooth Fairy is canvassing the state—virtually—to help improve the dental health habits of her young friends, in hopes of a cavity-free Washington.

“Children who experience tooth decay are more likely to miss school, have lower academic success, experience nutritional and speech development issues... and over time, become more susceptible to systemic inflammation, which may limit growth and development. It can also result in an increased risk for lifelong dental problems,” explains Abbie Goudarzi, DDS, a licensed dentist and Delta Dental consultant. “It's really unacceptable that more than half of our state's third graders have tooth decay, a number that's even higher in many rural and BIPOC communities.”

To help address the issue, the Tooth Fairy

is making virtual appearances in classrooms and community-based youth organizations statewide as part of her interactive pediatric dental health education program, The Tooth Fairy Experience, designed to make dental health education fun for students in kindergarten through second grade.

The free 30-minute interactive presentations led by the Tooth Fairy are customized for each learning environment—including a storybook reading, fun teeth facts, proper brushing techniques, tooth science experiment, dental health hand puppets and a sugar demonstration. It's all aimed to improve dental health behaviors of kids as they enter their cavity-prone years, and to spur regular dental exams—which were down 17 percent statewide last year for 5-10-year-olds, claims data from the state's largest dental benefits provider reveal.

According to Delta Dental's National Children's Oral Health Survey, 30 percent of U.S. parents reported that their children (between the ages of 6 and 12) missed school in the previous year due to an oral health problem (as opposed to a regularly scheduled dental appointment).

Children's dental care may not seem like a top priority considering kids lose their first set of teeth, but baby teeth are very important. Cavities early in a child's life can have long-term effects which linger far past the loss of baby teeth—it's why the program's website ([www.TheToothFairyExperience.com](http://www.TheToothFairyExperience.com)) also offers helpful resources and tips for parents, including early signs of cavities:

Pain around the tooth and gums when eating or brushing

A new or increased sensitivity to hot or cold food and drinks

Aversion to hard or crunchy foods

Consistent bad breath

Visible white spots on the teeth

Holes or discoloration (cavities in their early stages will often appear as white spots, then become a light brown color as they progress. More serious cavities may turn a dark brown or even black)

Delta Dental reminds parents and caregivers that good dental health habits are important throughout a child's life and are particularly impactful during the formative years—and to educate themselves and their children on the importance of dental health, noting that “the Tooth Fairy will thank you!”

without contacting you and increase its margin requirements at any time without providing you with advance notice.

**6. Get the basics on options trading.** Options are contracts that give the purchaser the right, but not the obligation, to buy or sell a security at a fixed price within a specific period of time. Options can help investors manage risk or increase buying power. But buying and selling options also involves risk, and it is possible to lose money.

**7. Know the rules if you are day trading.** Are you actively trading stocks? If so, it's important to know what it means to be a “pattern day trader” because there are requirements associated with this kind of trading.

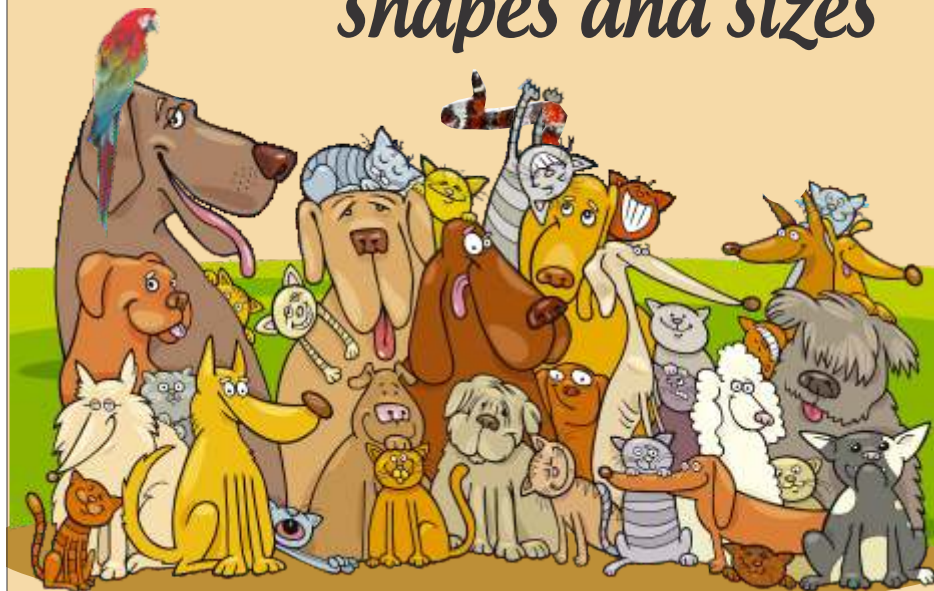

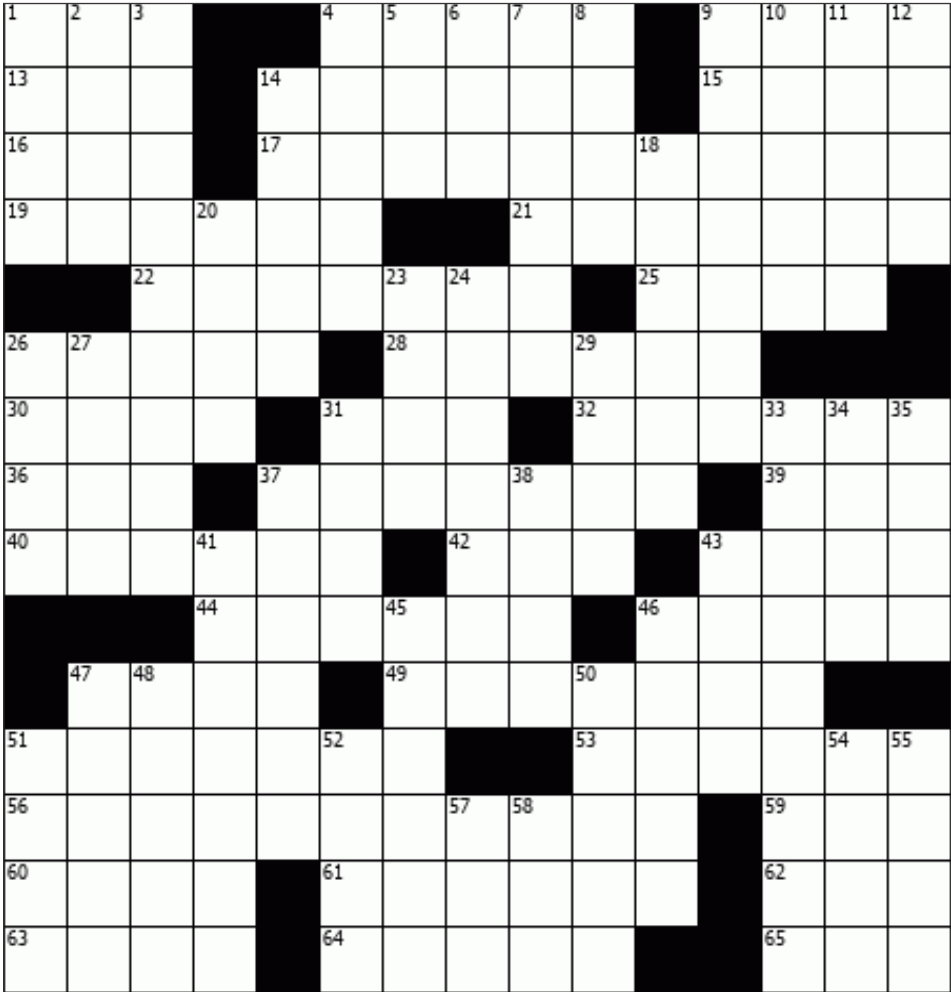

This increased online activity provides more opportunities for scammers, hackers and thieves looking to steal your personal and financial information. Safer Internet Day is a good reminder to take a fresh look at how to protect your finances, identity and safety online."

Attorney General Moody is releasing the following tips to help Floridians stay safe online:

- Use a strong, lengthy password that has uppercase and lowercase letters, numbers and symbols. Create unique passwords for each online account;

- Never give information to an unknown or untrusted source, and always use secure networks to send information;
- Understand personal privacy terms and conditions for any smart-home devices or virtual-personal assistants in use;
- Monitor children's internet and technology use with Parental Controls; and
- Proceed with caution when using public wireless networks as they are accessible to the public, including hackers. Avoid staying logged in to accounts when accessing these networks to help prevent hackers from accessing personal information.

**Attorney General Moody Secures \$40 Million for Florida**

### from Company Marketing Opioid Medications

TALLAHASSEE, Fla.—Attorney General Ashley Moody is securing millions of dollars for Florida through efforts to hold accountable corporations responsible for helping fuel the deadly opioid epidemic. Attorney General Moody today announced the results of a multimillion-dollar action against a marketing company that helped turbocharge the opioid epidemic through a marketing collaboration with Purdue Pharma.

Florida joins a coalition of attorneys general from 47 states, the District of Columbia and five U.S. territories in the

\$573 million action with one of the world's largest consulting firms, McKinsey & Company. The multistate action resolves investigations into the company's role in working for opioid companies to help promote products that fueled the opioid epidemic. As a result, Florida will receive more than \$40 million—a majority of which will be made available for allocation by Florida lawmakers during this critical time.

Attorney General Ashley Moody said, "I'm pleased this money will be available to help Floridians very soon, and I will work alongside our great legislative leaders to ensure funds are allocated to areas hit hard by the opioid crisis. While securing these funds is a great win for Florida, our work is

far from over, and I remain committed to fighting tooth and nail, both inside and outside the courtroom, to stop the death and destruction inflicted on Florida families by opioid abuse."

Florida House Speaker Chris Sprowls said, "Thank you Attorney General Moody for holding companies accountable for their role in perpetuating the opioid crisis. This epidemic has impacted families across Florida and this settlement is another step toward righting these wrongs."

Florida Senate President Wilton Simpson said, "Today's announcement is the product of years of hard work, and I am very grateful to General Moody for her leadership in bringing this tremendous settlement across the finish line. Opioid abuse has plagued our communities for far too long, tearing apart families and taking so many lives way too soon, while the COVID-19 pandemic has left many people struggling with this addiction feeling isolated and alone. As a state, we are doing all we can to address this terrible problem, and Floridians can take great pride in the fact that our Attorney General is a national leader in this effort. This settlement is welcome news, but I also know it is really just the beginning of General Moody's tremendous efforts to hold these companies accountable."

The money will be used to abate problems caused by opioid abuse in Florida. In addition to providing funds to address the

crisis, the multistate action calls for McKinsey to prepare tens of thousands of internal documents detailing work for Purdue Pharma and other opioid companies for public disclosure online.

McKinsey also promises to adopt a strict document retention plan, continue an investigation into allegations that two of its partners tried to destroy documents in response to investigations of Purdue Pharma, implement a strict ethics code that all partners must agree to annually and stop advising companies on potentially dangerous Schedule II and III narcotics.

Today's filings describe how McKinsey contributed to the opioid crisis by promoting marketing schemes and consulting services to opioid manufacturers, including OxyContin maker Purdue Pharma, for more than a decade. The complaint, filed with the settlement, details how McKinsey advised Purdue on how to maximize profits from its opioid products, including targeting high-volume opioid prescribers, using specific messaging to get physicians to prescribe more OxyContin to more patients and circumventing pharmacy restrictions in order to deliver high-dose prescriptions.

When states began to sue Purdue's directors for their implementation of McKinsey's marketing schemes, McKinsey partners began emailing about deleting documents and emails related to working for Purdue.

The filing is the latest action Attorney

ballots—only voters who request a ballot should receive a ballot.

Vote-by-mail requests must be made each election year.

Vote by mail ballot signatures must match the most recent signature on file.

### Transparency in the Elections Process

Political parties and candidates cannot be shut out from observing the signature matching process.

Supervisors of Elections must post over-vote ballots to be considered by the canvassing board on their website before the canvassing board meets.

Prohibits counties from receiving grants from private third-party organizations for "get out the vote" initiatives.

### Transparency in Elections Reporting

- Requires real-time reporting of voter turnout data at the precinct level.

Supervisors of Elections must report how many ballots have been requested, how many have been received, and how many are left to be counted.

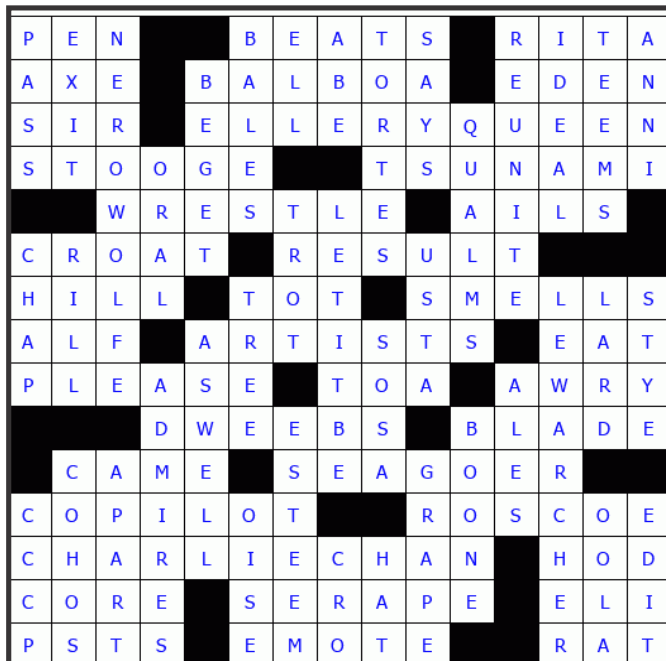
