1. Let me tell you about A Banyan Residence. What services are available at the facility?

a. A Banyan Residence is an assisted living and memory care resort that is owned and operated by the founding family. Our family started in assisted living and memory care in 1998 with a unique concept that emphasized an independent and outdoor lifestyle that we've built into our design here in The Villages area. By dedicating three full acres to botanical butterfly gardens, waterfall koi fish ponds, walking paths, gazebos, and the like, we find seniors are able to relax peacefully in a home-like and comfortable environment. We also offer a giant clubhouse full of amenities to keep residents active from sun up to sun down. We have amenities such as a movie theater, hair salon, physical fitness gym, ice cream parlor, bistro, crafts room, library, and a state-of-the-art sensory room showing off cutting edge technology geared for senior living.

Beyond the building design itself, we are staffed and trained to provide any necessary assistance to keep our residents independent for as long as possible while still making sure their daily needs are met. Our custom culinary program is designed to provide exquisite meals that would go unrivaled in the industry. Our enrichment program keeps seniors of all types stimulated, active, and

social with both on-campus daily events but also in the community, such as attending polo matches, live concerts, restaurant openings, and so on. Finally, our care program allows for seniors to rely on our staff to bridge the gap physically and mentally to achieve independence in their day-to-day lives while maintaining dignity and integrity.

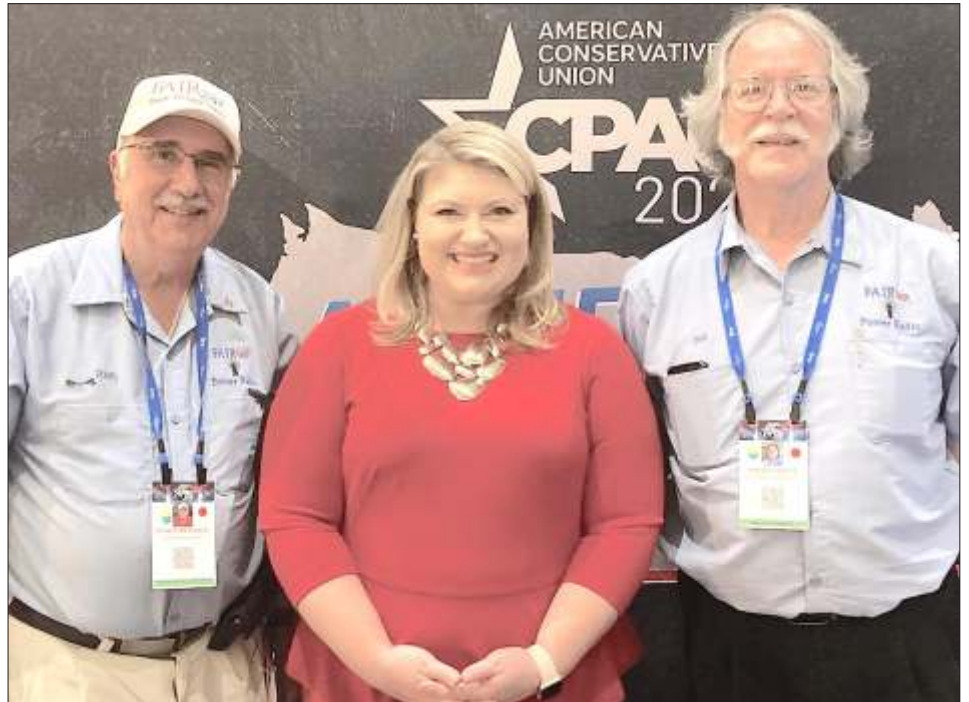
What is unique to our design is that our entire facility is considered both assisted living and memory care, so all of the amenities and grounds can be enjoyed by all. This characteristic allows families to rest easy that no matter what happens physically or mentally due to aging, they know that their loved one will never have to move rooms because the same level of care can be provided anywhere on property.

2. How long has opening this facility in the area been in the works?

a. Our family began discussing building a community in The Villages nearly four years ago. Our founder, Greg Anderson, has a degree and background in construction prior to starting in senior living in the 90's. What is amazing is that over the past four years, Greg has been able to take a blank slate and combine his construction and design background with decades of assisted living experience to custom-design a community that structurally addresses issues seen in the industry. The entire process has been a collaboration among our family as partners and it's unbelievable to see the finished product. The attention to detail is extraordinary and some of the finer points can be overlooked if people don't take a tour with one of the owners.

3. Why open in The Villages area?

a. The culture in The Villages is something we have not ever experienced

before but immediately fell in love with once we began to immerse ourselves. The population is friendly, social, active, and full of life, which is exactly the culture what we've aimed to create in our communities for decades. Our family felt the need that the growing community had for senior living options and we thought our values and principles were well-aligned with the soul of the community. We think that our unique concept and design is needed in every community that serves the assisted living and memory care population, but the local culture made it very easy for us to call this area our new home.

4. How do you feel about now being officially open?

a. Finally being open is such an amazing feeling! This has been our largest, most complex, most difficult, and most rewarding project of our family's history. We used entirely local labor to help build the project and we can't thank them and the supporting community enough. We had plenty of sleepless nights and that doesn't even consider the global pandemic that was looming overhead threatening to alter the course of our destiny at any given moment. We're so grateful to have had a successful ribbon cutting and the blessing and support from local elected officials as well as our own congressman. We're hopeful that we can contribute back to the community to thank them for the support we've gotten to this point.

5. Jennifer told me that the facility is designed almost inside out so every room is open to the outside and residents have free range of the area. Why design the facility in that way?

a. Seniors have had unrestricted access to nature and the outdoors their entire lives... why should that change when they move into a senior living community? It seems too easy for a community to be

built with a labyrinth of fluorescent-lit hallways that have to be navigated before being able to get fresh air and our principles fundamentally disagreed with that idea. Many of these people owned homes where they could step out of their back door onto their patio to enjoy their own gardens. We took that same experience and projected it throughout our community, which is why we have butterfly gardens, fruit trees, fish ponds, waterfalls, etc. There is automatic value in being able to relax peacefully surrounded by nature and that lifestyle being just at your fingertips out your front door. It encourages enriched livelihood, independence, activity, and natural energy. The exposure to nature's light cycle also has very well-documented positive impacts on sleep schedules, moods, and behaviors. For someone that enjoys being outdoors in a lush tropical environment with sunlight and a breeze, we think we are the only community designed to capture that feeling.

Florida State Senate

Dear Friends,  
This is the last column of the 2021 Legislative Session and by next month we will be ready to report on what all transpired during our time in Tallahassee. This session may be one of the most impactful years we've had in the Florida Senate. Even though we've filed less bills than previous years, the substance of the few that we have are some really big lifts.

Here's an update on some of those.  
SB 90, a bill filed by your Senator, addresses a number of issues related to election administration and vote-by-mail. Simply put, we're looking to eliminate potentially weak areas of our voting process and ensure Florida's citizens that it will be easy to vote, but very hard to cheat. One provision in SB 90 addresses ballot harvesting so that no person may possess a ballot other than his or her own and those of



immediate family members. We are eliminating the use of drop boxes so that the ballot harvesting prohibition can be enforced and to prevent bad actors from having the opportunity to spoil ballots. The second largest provision in the bill expands the timeframe for canvassing vote-by-mail ballots, providing that one vote-by-mail ballot request is good for all elections through the next regularly scheduled general election. Current law states that one request is good for all elections through the next two general elections. This change is necessary to provide voters with more flexibility to decide which method of voting they want to utilize, instead of being locked in for two cycles.

Just this week the Florida Senate passed SB 72, which shields businesses and health care providers acting in good faith from lawsuits related to COVID-19. The threat of frivolous lawsuits shouldn't be hanging over these organizations who have sacrificed much and are trying to safely reopen. Your Senator was a proud co-sponsor of this very good legislation and we're excited that this was one of the first bills to pass this session.

The Committee on Government Oversight and Accountability just approved SB 1606, which designates November 7 as the Victims of Communism legal holiday in the State of Florida. While largely symbolic, this bill will serve as a reminder to our citizens that the voices of millions of victims throughout history cry out against the evils of communism and that we must be vigilant in putting down any attempt to normalize or accept this philosophy in our culture.

This is just a very small glimpse of some of the work that we are doing on your behalf in Tallahassee, and I look forward to providing a more detailed report upon our return to the district. ### Distracted Driving is Dangerous

Anything that takes your attention away from driving can be a distraction. There is no doubt that the improvement of

technology in today's society has greatly benefited our society as a whole. But, sending a text message, talking on a cell phone or using a navigation system creates hazardous road conditions. These and any

other distractions, such as tending to kids or passengers in the back seat, eating, watching an event outside of the vehicle, interacting with passengers, unsecured pets, putting on makeup or grooming, adjusting radio or climate controls, checking your GPS app or daydreaming. These distractions can endanger you, your passengers, and others on the road.

There are three main types of distraction:

- Visual-taking your eyes off the road,
- Manual-taking your hands off the wheel
- Cognitive- taking your mind off driving.

Texting while driving has been proven

dangerous beyond dispute due to the fact that it requires all three distractions at once to complete. Taking one's eyes off the road for the average 5-6 second text, is enough to travel the length of a football field at 55 MPH.

According to the CDC related to 2018 statistics, over 2800 people were killed and an estimated 400,000 were injured in crashes involving distracted driving. About 1 in 5 of the people who died in crashes were not in vehicles. They were walking, riding their bicycles, or outside of their vehicle.

Young adult and teen drivers are the most at risk for distracted driving. In 2018, 25 percent of distracted drivers involved in fatal crashes were young adults aged 20-29. Drivers aged 15-19 were more likely to be distracted than drivers aged 20 and older among drivers in crashes where someone

died. It is important for parents to speak to their teen drivers about the risks of driving while distracted. Remind them that driving requires their full attention. This must also be done by setting the example for them. A parent/guardian who drives while distracted will likely not be taken seriously by their young driver.

Section 316.305, Florida Statutes allows law enforcement to stop motor vehicles and issue citations to motorists that are texting and driving. A person may not operate a motor vehicle while manually typing or entering multiple letters, numbers or symbols into a wireless communications device to text, email and instant message.

Section 316.306, Florida Statutes, is a prohibition on using wireless communications devices in a handheld manner in school and work zone. A person may not operate a motor vehicle while using a wireless communications device in a handheld manner in a designated school crossing, school zone or active work zone area. Active work zone, as it pertains to Section 316.306, Florida Statutes, means that construction personnel are present or are operating equipment on the road or immediately adjacent to the work zone area.

The men and women of the Lady Lake Police Department remind you to be safe out on the road and pay careful attention to the new road patterns due to the construction along US Hwy 441.

## Reaching Carbon Neutrality \$1/Day

(NAPSI)—Zero net emissions of carbon dioxide from energy and industry can be achieved by 2050—and it could cost only about \$1 a day. That's the finding of a new study by James Williams at the University of San Francisco and Margaret S. Torn at the Lawrence Berkley National Laboratory. The study can be found in the peer-reviewed journal AGU Advances, which publishes high-impact, open-access research and commentary across the Earth and space sciences.

### Why It Matters

According to the Intergovernmental Panel on Climate Change (IPCC), the world must reach zero net carbon dioxide emissions by mid-century to avoid the most dangerous effects of climate change.

### How To Do It

- The researchers say it can be done by:
- Increasing energy efficiency.
- Switching to electric technologies.
- Using clean energy (especially wind and solar power).
- Deploying a small amount of carbon capture technology.

### Why It Works

The cost of rebuilding the U.S. energy infrastructure to run primarily on renewable energy is lower now than even five years ago,

according to the study. The net costs range from 0.2% to 1.2% of GDP, depending on different trade offs, including how much land is given to solar and wind farms.

### Transforming Infrastructure

"The decarbonization of the U.S. energy system is fundamentally an infrastructure transformation," explained Margaret Torn, a senior scientist at Lawrence Berkeley National Laboratory. "It means that by 2050 we need to build many

gigawatts of wind and solar power plants, new transmission lines, a fleet of electric cars and light trucks, millions of heat pumps to replace conventional furnaces and water heaters, and more energy-efficient buildings—while continuing to research and innovate new technologies."

In this transition, very little infrastructure would need "early retirement," or replacement before the end of its economic life. "No one is asking consumers to switch out their brand-new car for an electric vehicle," Torn added. "The point is that efficient, low-carbon technologies need to be used when it comes time to replace the current equipment."

### Doing Well By Doing Good

There's even an economic upside to doing all this.

"All that infrastructure build equates to jobs in the U.S., as opposed to sending money overseas to buy oil from other countries," Torn said. "There's no question that there are a lot of jobs in building a low-carbon economy."

The cost figures should be lower still considering the economic and climate benefits of decarbonizing energy systems. For example, less reliance on oil will mean less money spent on oil and less economic

## Homicide Arrest

### DELAND MAN ARRESTED FOR HOMICIDE

Lake County sheriff's deputies responded to a reported stabbing Saturday evening at approximately 6:40 p.m. at a residence located at 44721 Lake Mack Drive in DeLand.

The suspect, 30-year-old Kolby Allen Parker, initially reported to deputies that he was attacked by his 77-year-old grandfather, Ronal Wells, Sr., who also resided at the residence with Parker. Parker initially claimed the two were smoking marijuana together and a confrontation began, at which time he said Wells came at him with a knife. Parker stated he was able to disarm Wells and use the knife against him.

The 77-year-old Wells was located deceased on the front porch of the home with apparent stab wounds.

While talking with responding deputies, Parker produced two human ears from his pants pocket, which were later discovered to be those of the decedent. He then became

violent towards the deputies, attacking and fighting them and trying to disarm them. He was secured and placed under arrest for Battery on a Law Enforcement Officer and Resisting with Violence.

Detectives arrived on scene to further the investigation, during which time they executed a search warrant for the property. Detectives located a baseball bat in the corner of the porch with what appeared to be blood-like stains, as well as a large butcher knife on the kitchen table and dripped blood on the kitchen floor.

Parker later confessed to striking his grandfather multiple times in the head with the baseball bat and then stabbing him with the butcher knife numerous times. He also admitted to cutting the victim's ears off and stated he wanted his grandfather to be with his deceased grandmother.

In addition to the charges of Battery on a Law Enforcement Officer and Resisting with Violence, Parker was charged with Second-Degree Murder (Domestic Violence) and was booked in with no bond.

## Help For Family Caregivers

### Free Professional Help For Family Caregivers

"Military caregivers have always struggled with the enormous responsibility on their shoulders, but the risks and restrictions of COVID-19 have sent rates of caregiver burnout, depression and isolation soaring," said Steve Schwab, CEO of the Elizabeth Dole Foundation. "We developed this emergency assistance program to give America's hidden heroes the precious time they need to rest, relax and recharge."

The Foundation is managing the program in partnership with the U.S. Department of Veterans Affairs, CareLinx, Wounded Warrior Project, AARP, and Bob Woodruff Foundation. The professional caregivers are provided by the trusted and licensed professionals of the CareLinx network and follow CDC guidelines to ensure everyone's safety.

"I was skeptical that using respite care would actually help — I thought it might be more work than it was worth," said veteran caregiver Jennifer Mackinday. "But it was game-changing. It was the first step for me to start taking better care of myself mentally and physically."



#### Who Can Get Help

If you assist a service member or veteran with dressing, bathing, transportation, managing medication, physical therapy, or dealing with the symptoms of post-traumatic stress, you may be a military caregiver.

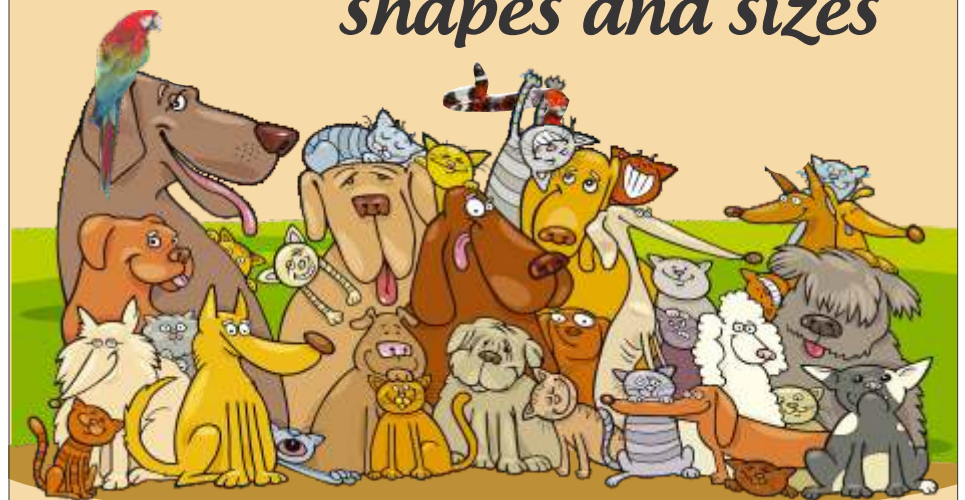

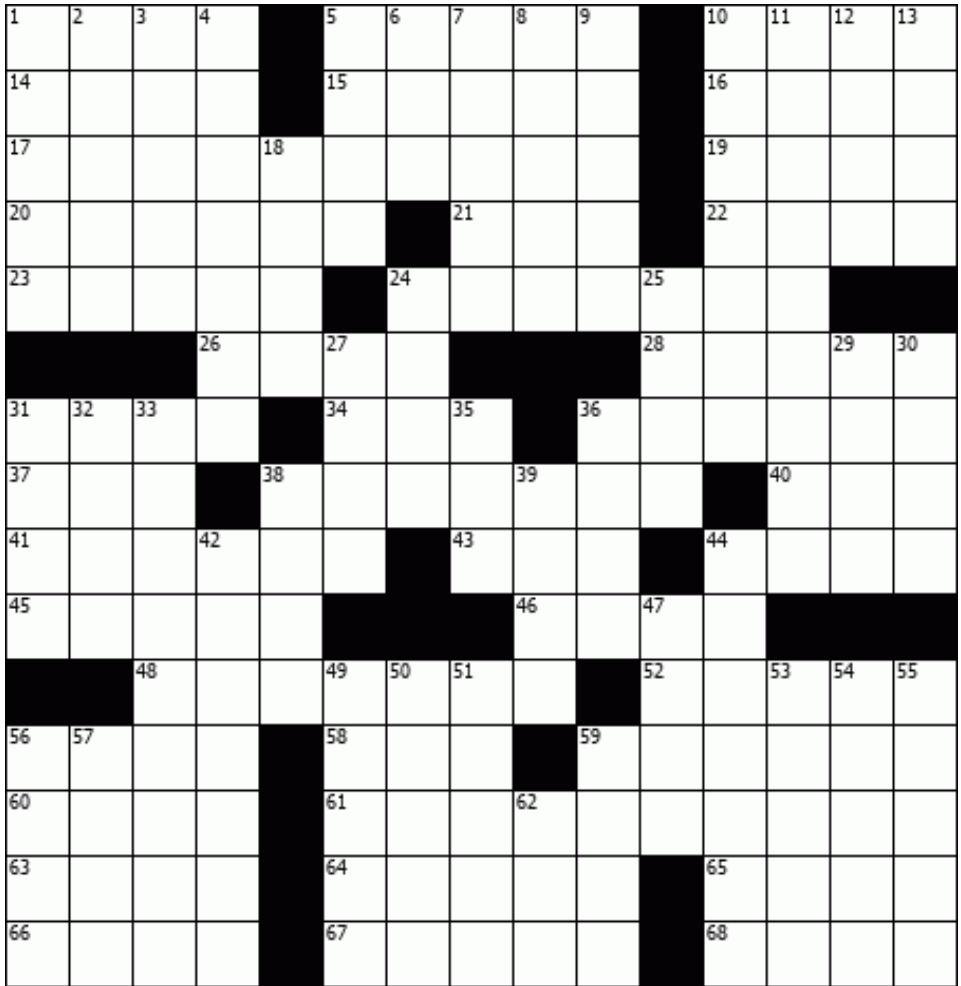

## FROM THE DESK OF ATTORNEY GENERAL MOODY



### Beware of Resurgence in Stimulus Payment Scams as Millions of Floridians Anticipate Direct Payments

TALLAHASSEE, Fla.—Attorney General Ashley Moody today issued a Consumer Alert warning Floridians of the possibility of a resurgence in stimulus payment scams as another round of direct payments from the federal government head to Florida. As part of a massive COVID-19 relief package, direct payments from the Internal Revenue Service are headed to the bank accounts and mailboxes of millions of Floridians—creating the potential for new stimulus payment scams. Anytime a government benefit or program rolls out, scammers will try to exploit the situation for their own benefit.

Attorney General Ashley Moody said, “With many Americans set to

receive direct payments from the federal government, we expect scammers will devise schemes to exploit the massive spending to trick recipients into parting with personal or financial information. Be smart. Seek out trusted sources of information about when your payment will be received and never respond to solicitations asking you to provide personal information or payment to receive a stimulus check.”

Floridians expecting stimulus payments should know:

- The IRS will never call a consumer directly, nor will the IRS send unsolicited emails, texts or social media messages;
- Recipients will not be required to make a purchase to receive a stimulus check;
- Offers advertising expedited delivery of the stimulus payment for a fee are suspicious and can be scams; and
- Solicitations asking receivers

to click a link or provide sensitive information are probably scams.

Some common signs of scams include:

- Unsolicited calls or emails;
- High-pressure tactics or too-good-to-be-true offers;
- Threats of loss if immediate action is not taken; and
- Requests for immediate payment by wire transfer, credit, prepaid debit or gift cards.

Last December, to highlight

potential stimulus payment and COVID-19 related scams and provide resources for Floridians to share with loved ones, Attorney General Moody's Scams at Glance program released two new downloadable brochures detailing information about how to spot common COVID-19 and stimulus scams to stop fraud in its tracks. The brochures are printable and available in both English and Spanish.

Attorney General Moody launched the Scams at a Glance webpage in July 2020 to offer

### Attorney General Moody Takes Action Against Google for Anticompetitive Practices

TALLAHASSEE, Fla.—Attorney General Ashley Moody is taking action against Google for multiple violations of federal and state antitrust and consumer protection laws—including anticompetitive conduct, exclusionary practices, and false and deceptive misrepresentations in connection with its role in the multitrillion-dollar online-display advertising industry. Google also made false and deceptive misrepresentations to consumers regarding Google's privacy practices. Google's monopolization of online-display advertising involves an anticompetitive agreement with Facebook, making misrepresentations to users and customers, and suppressing competition. Attorney General Moody is joined by a bipartisan multistate coalition of 14 other state

attorneys general in the lawsuit in the U.S. District Court for the Eastern District of Texas.

Attorney General Ashley Moody said, "For far too long, Google has used its size and position as one of the largest tech giants in the world to manipulate and unfairly monopolize the marketplace. The core of American economic success lies on our foundation of capitalism and a free, fair and competitive marketplace.

"Google knowingly and willingly monopolized the products and services used by advertisers in online-display advertising. The company also engaged in false and deceptive acts while buying and selling the online-display ads. Through their monopolization and deceptive acts, Google greatly decreased other publishers' ability to monetize their content while simultaneously increasing costs to advertisers. Most of all, Google harmed consumers, including the millions of Floridians who use the search engine daily."

The internet revolutionized the way people consume content and the type of ads that companies can purchase to reach consumers,

including online-display ads. In addition to representing both the buyers and sellers of online-display advertising, Google competes directly against the buyers and sellers they separately represent—all while operating the largest exchange on which these ad products are bought and sold. Google exchanges trades in billions of ad impressions a day.

This action alleges that Google monopolized or attempted to monopolize products and services used by advertisers and publishers in online-display advertising. The complaint also alleges that Google engaged in false, misleading and deceptive acts while selling, buying and auctioning online-display ads. These anticompetitive and deceptive practices demonstrably diminished publishers' ability to monetize content, increased advertisers' costs to advertise and harmed consumers.
