## AS I SEE IT

Who is our enemy – Putin or the Russian People?

The German government has accused the American commander of the allies in Europe, Gen Philip Breedlove of, disseminating 'dangerous propaganda' by minimizing the extent of Putin's military in his annexation of parts of Ukraine. Putin denies that his military is fighting with the Pro-Russian separatist fighters in Ukraine. He claims that the people in that area are fighting for 'freedom' as they try to add parts of the Ukraine to Putin's 'empire'.

But US Lt Gen Ben Hodges, commander of the US Army in Europe, says that, in fact, at least 12,000 Putin troops are inside UKRAINE capturing more and more territory for Putin's 'separatist army' which is directly proven to include Putin's soldiers through satellite imagery, which anyone in the world can view for themselves. Hundreds of Russian soldiers have been killed in the separatist area of the Ukraine.

NATO and US analysis, have seriously underestimated how many soldiers Putin has sacrificed there.

As I See It, we should be more careful to note that Putin should be help accountable, not the Russian people. Putin's invasion of Ukraine has sacrificed over 80,000 of his own people.

Meanwhile, several courageous teachers who have refused to endorse what Putin calls his 'special military operations' in Ukraine, face retaliation and sanctions. Human rights activists have been arrested, tortured and prosecuted and defense lawyers, threatened and intimidated.

Estimates suggest that over 6,000 civilians have been killed and almost 10,000 innocent people injured.

In Russia, almost 5 million citizens have left the country. Former Soviet countries saw a huge increase in arrivals after Putin invaded the Ukraine.

But, apparently, most older Russians support Putin, but the younger generation opposes the invasion and are much more skeptical towards the Putin dictatorship. They say that they are feeling the effect of sanctions.

A poll found that over 50% said Ukraine is

resisting the invasion more strongly than they expected and that life for ordinary Russians had got worse over the last 20 years, also Russia's international reputation had been damaged.

Those aged 18-24 were more likely to say they opposed the invasion. They were much more likely to reject Putin's claim that the invasion was needed to protect Russia, and to demilitarize and de-Nazify Ukraine. They also had an unfavorable view of Putin and they were more likely to recognize President Zelensky as Ukraine's legitimate leader. More than half (54%) said they favored withdrawing Russian forces from the Ukraine.

For whatever reason, US and other Western leaders do not want to label Putin's military action as an 'invasion' of eastern Ukraine and Crimea. They ignore his retaliation, arrests and intimidation of anyone who opposes his illegal actions.

Non-Kremlin Russian media regularly witness the burial of dead Russians soldiers, and report on the brave opposition of the Russian people against the Putin Dictatorship, but of newspapers and our media reporters tell us almost nothing. For whatever reason, its important to our major networks that we hate the Russian people and put no direct blame on Putin, their Communist ruler.

Apparently, our 'World Leaders' have agreed that its ok for them to kill and maim one another's citizens, but bumping off a murderous dictator is not permitted.

'Hirohito' the warlike Japanese leader in WW2 had to be protected, so we 'nuked' a million civilians in Hiroshima and Nagasaki instead. Italian Nazi Dictator Mussolini, was spared.

Idi Amin, reportedly one of the most brutal dictators in the world died peacefully in Saudi Arabia.

He was eccentric, but he was also a genius best known for inventing the modern alternating current electricity supply system. In 1934, in an interview with "The New York Times," Tesla explained in part what helped his genius thrive. Seclusion, he argued, was vital to the creative mind: "The mind is sharper and keener in seclusion and uninterrupted solitude. No big laboratory is needed in which to think." For Tesla, solitude was the key to innovation. "Be alone," he said, "that is the secret of invention; be alone, that is when ideas are born."

Dr. Christina Baumann says, "In 2020, the western states, in particular, had the largest increases in fentanyl availability in the illegal drug market; and in our state, there was nearly a 70% increase in drug overdose deaths in compared to 2019."

Florida Attorney General Ashley Moody has launched the [One Pill Can Kill website](#) with resources about the dangers of fentanyl. More and more, she says the opioid is being hidden in drugs like marijuana and cocaine, unbeknownst to the user.

"People need to know that just one pill laced with fentanyl is enough to kill a full grown adult," Moody says in a video about the new website. "Fentanyl is now the leading cause of death for American adults between the ages of 18 and 45."

# Detectives Make Arrest

## Lake Sheriff's Detectives Make Arrest For Death By Unlawful Distribution Of Fentanyl

A 33-year-old Leesburg man is in custody following an investigation into a drug-related death that occurred in June 2022.

Detectives began the death investigation at a home located at 4100 Holly Hill in Lady Lake on June 25 when the deceased, 38-year-old Harry Cooper, was found in a bedroom along with evidence of drug use. The Medical Examiner's Office ruled Cooper's death as an accidental drug overdose of fentanyl.

Detectives have worked diligently throughout the course of this investigation and based upon phone records and surveillance video, they determined that 33-year-old Albert Robert Springs of Leesburg is the man responsible for dealing the lethal drugs to Cooper.

Detectives obtained an arrest warrant for Springs and he was taken into custody on Wednesday, November 16. He was booked in at the Lake County Detention Center with no bond on a charge of Death by Unlawful Distribution of Fentanyl.

#### Driver Awareness Tips

The holidays are a great time for family and friends to create many memories together. Safety when you leave

the house and travel is an obvious concern but please remember, safety begins with you. Every holiday season, from November 1 through January 1, MADD asks you to display a MADD ribbon in a visible location to remind everyone to always designate a non-drinking driver. That message is especially important when holiday travel, parties and family gatherings put more people on the roads. <https://www.madd.org/the-solution/drunk-driving/tie-one-on-for-safety>

Follow these tips to help ensure we all Arrive Alive this holiday season:

**Never drive impaired.** Celebrate responsibly and do not get behind the wheel if you have been drinking or have taken prescribed drugs that cause impairment. Plan ahead and find a safe way home every time – designate a driver or use a ride service.

**Check your tires.** Tires are a vehicle's first line of defense on the road. Check your tire pressure, tread depth and spare tire especially before long trips. Do not over load your vehicle, it can result in premature wear and tire blowouts.

**Buckle up.** A seat belt is your vehicle's most important safety feature. Florida law

requires that all drivers, all front seat passengers and all passengers under the age of 18 wear seat belts or the appropriate child restraints. Seat belts save lives, so buckle up every trip, every time.

**Register or update your Emergency Contact Information (ECI).** ECI is a secure system allowing law enforcement, nationwide, to contact designated family or friends in response to an emergency situation.

**Observe and obey all speed limits.** Speed limits may change as you drive through different types of roadways, so make sure you adjust your speed accordingly. In Florida, the limit will never be over 70 mph.

#### Keeping Your Home Safe

We all want our homes to reflect the joy of the season, but avoid displaying gifts where they can be seen from a window or doorway.

Arrange to have packages delivered to a neighbor if you're not home to receive them. Packages left on porches or doorsteps are "easy picking" for thieves. It also draws unwanted attention to your home.

Consider simple outside decorations. Elaborate decorations are sometimes stolen right off the lawn.

Be sure not to obscure the view from your windows. You need a clear view of your property.

Always lock your home's doors and windows, even if you're only gone for a few minutes.

Dispose of gift packaging discreetly. Often criminals will spot something you've discarded and can target you for their next burglary or theft.

#### Remain Alert While Shopping

Always lock your car and close the windows, even if you're only gone a few moments. When possible, lock all merchandise or packages in the trunk of your car. Load your packages before departing and not at the next destination.

Shop with at least one other person. Have your car or house key in your hand as you approach the door.

Stay alert to your surroundings and the people around you. Look inside your car and around it as you approach.

Be mindful of your purses and wallets. Be sure that your purse is secured as you travel to and from the store and don't leave it in a shopping cart unattended. Keep wallets in a side pant pocket or an inside pocket of a coat, if possible.

Avoid carrying large quantities of cash.

## Homicide In Umatilla

## Distribution Of Fentanyl

### Lake County sheriff's detectives make arrest for death caused by the unlawful distribution of fentanyl

On July 17th 2021 Lake County Sheriff's Deputies along with EMS responded to 16815 Sarah's Place, Clermont regarding an unresponsive male in a vehicle in the parking lot. The individual was identified as Pavel Mata who was transported to Four Corners ER where he was pronounced deceased. An autopsy was performed on Mr. Mata however a cause of death was undetermined pending toxicology testing.

On August 23rd 2021 toxicology testing returned indicating a lethal dose of Fentanyl was present in Mr. Mata's blood; the cause of death was updated to indicate "Accidental".


Detectives continued their lengthy investigation to include DNA testing and forensic digital searches. As a result it was learned that an individual named "Kevin"



**TALLAHASSEE, Fla.** — Today, Governor Ron DeSantis announced continued record visitation to

Florida in the third quarter of 2022. VISIT FLORIDA estimates that Florida welcomed 35.1 million visitors between July and September 2022, marking a 6.9 percent increase from Q3 2021, and the fifth consecutive quarter of overall visitation surpassing pre-pandemic levels. **Florida Creates Jobs for the 30th Consecutive Month, Shows Economic Resiliency Despite Impacts of Hurricane**

**More Floridians Enter the Workforce While National Labor Force Shrinks**

**TALLAHASSEE, Fla.** — Today, Governor Ron DeSantis announced that Florida’s economic data continues to show strength even with impacts from Hurricane Ian in Southwest Florida. In the October 2022 economic data report, Florida’s labor force grew by 36,000 and Florida’s private sector added 35,000 jobs. This is the 30<sup>th</sup> consecutive month that Florida created jobs, while private sector job growth has exceeded the nation’s for the past 19 consecutive months.

Over the month, Florida’s labor force grew by 36,000, while the national labor force shrank, and Florida’s private sector employment growth was double the national growth rate. Florida’s private sector employment grew by 5.6 percent over the year in October 2022 (+447,800 jobs), faster than the national growth rate of 4.0 percent.

Florida’s unemployment rate increased by 0.2 percentage points to 2.7 percent, which is still historically low, and remains a full point below the nation’s 3.7 percent mark. Much of the increase in the unemployment rate is due to increased unemployment in Southwest Florida following Hurricane Ian. The unemployment rate in the Fort Myers area was 3.9 percent during the month, up 0.5 points. Still, this slight increase in unemployment in Florida shows that despite the impacts of a Category 4 storm, Floridians and Florida’s economy remain resilient. The Department of Economic Opportunity (DEO) and CareerSource Florida continue to provide resources to help Floridians find employment if they

were impacted by the storm. “Florida’s economic resiliency is unmatched in the country – no other state could withstand the direct impact of a Category 4 hurricane and continue to grow jobs in the same month,” said Governor Ron DeSantis. “We have made record investments in our infrastructure and workforce while building a record budget surplus and providing record tax reduction for Floridians.”

“More Floridians enter the workforce each month because they are confident in the opportunities available to them under Governor DeSantis’ consistent leadership,” said DEO Secretary Dane Eagle. “DEO is proud to support the Governor’s mission through workforce education and development opportunities that help Floridians realize their potential and support our state’s major industries.”

Florida’s statewide unemployment rate was 2.7 percent in October 2022, remaining 1.0 percentage point lower than the national rate of 3.7 percent. Florida’s statewide unemployment rate has been lower than the national rate for 23 consecutive months since December 2020.





### Attorney General Moody Recognizes Utility Scam Awareness Day with Tips to Avoid Scams

TALLAHASSEE, Fla.—Attorney General Ashley Moody is recognizing Utility Scam Awareness Day by issuing tips for Floridians to avoid utility scams. Fraudsters aiming to swindle consumers may pose as representatives of utility companies, and claim immediate payment is needed or the customer's service will be cut off—or scammers may attempt to obtain personal information from an unsuspecting consumer. Attorney General Moody wants to ensure Floridians don't fall victim to these schemes.

Attorney General Ashley Moody said, "Utility scammers will prey on the fear of losing an important service such as power or gas in order to elicit an immediate payment. Don't fall for these imposter scams. If you receive a suspicious message or phone call, do not provide any personal or financial information. Instead, call the utility company directly and check on the status of your account."

Attorney General Moody suggests Floridians use the following tips to avoid utility scams:

- Understand that scammers pressure customers to act fast, so do not rush to act on an unsolicited call or email;
- Verify information given by purported

utility representatives by checking the latest bill;

- Never provide or confirm personal information to a solicitor, whether by phone, in-person or email, purporting to be a utility company representative;
- Know that utility companies will not demand immediate payment;
- When in doubt if a call is legitimate, hang up and call the utility company directly using the number listed on the company's website;
- Be wary of anyone demanding payment by a reloadable card, gift card or cryptocurrency; and
- Authenticate the identity of someone posing as a utility representative who comes to the door. Look for company ID and logo, and know whether the visit is expected or not.

### Attorney General Moody Secures \$390 Million Through Historic Multistate Action Against Google Over Location Tracking Practices

TALLAHASSEE, Fla.—Attorney General Ashley Moody today announced a historic multistate action against Google over the tech giant's location tracking practices. The announcement follows a historic multistate investigation by Attorney General Moody and 39 other state attorneys

general into the company's location tracking practices and cybersecurity disclosures. As a result of the investigation, the business will pay the states \$390 million—including \$26 million to Florida. Google must also provide consumers more information and clearer options as it relates to tracking practices.

Attorney General Ashley Moody said, "Big Tech is watching us, but Silicon Valley needs to know that we are watching them too, and if they violate our consumer protection laws, we will take strong action to protect our citizens. This is a historic case for the privacy of Americans and the protection of consumers nationwide, and I am proud our office helped lead this massive, nationwide investigation."

Location data is a key part of Google's digital advertising business and is among the most sensitive and valuable personal information the company collects. Even a limited amount of location data can expose a person's identity by tracking routines that can be used to reveal personal details.

The attorneys general initiated the multistate investigation following a 2018 Associated Press article that revealed the company records users' movements, even when explicitly told not to. The article focused on two account settings: Location History and Web & App Activity. Location History is turned off by default, but Web & App Activity, a separate account setting, is automatically turned on when users set up a Google account, including all Android phone customers.

As detailed in the agreement, the attorneys general found that Google allegedly violated state laws by misleading consumers about location-tracking practices in various ways since at least 2014.

Specifically, the company caused confusion among those who thought location tracking could be limited by turning off Location History, while Web & App Activity continued to track users' locations.

Under the agreement, Google agreed to a series of provisions designed to give consumers more transparency into the company's practices, including:

- Showing additional information whenever account settings are turned on or off;
- Making key information about location tracking unavoidable; and
- Creating an enhanced Location Technologies webpage where users can get detailed information about the type of location data Google collects and how it's used.

The agreement also places limits on the usage and storage of certain types of location information and requires account controls to be more user-friendly.

Florida took a leading role in the investigation and agreement negotiations, represented by Consumer Protection Division Multistate and Privacy Bureau Chief Patrice Malloy.

Attorney General Moody is joined in this final action by the attorneys general of the following states: Alabama, Alaska, Arkansas, Colorado, Connecticut, Delaware, Georgia, Hawaii, Idaho, Illinois, Iowa, Kansas, Kentucky, Louisiana, Maine, Maryland, Massachusetts, Michigan, Minnesota, Mississippi, Missouri, Nebraska, Nevada, New Jersey, New Mexico, New York, North Carolina, North Dakota, Ohio, Oklahoma, Oregon, Pennsylvania, South Carolina, South Dakota, Tennessee, Utah, Vermont, Virginia and Wisconsin.

(who had been known to be present with Mr. Mata prior to his death) was in fact Kevin Richardson (06/01/1997). Surveillance video from the parking lot showed Mr. Richardson in the vehicle interacting with Mr. Mata. Mr. Richardson was located and interviewed by detectives at which time he admitted to obtaining what he claimed to be a Percocet pill from an unidentified drug dealer and provided it to Mr. Mata. Mr. Richardson stated that he observed Mr. Mata to need medical attention after ingesting the pill but claimed Mr. Mata declined; thereafter Mr. Richardson left Mr. Mata's presence. According to detectives the alleged Percocet pill was likely counterfeit and contained a lethal dose of Fentanyl.

Detectives worked with the State Attorney's Office to obtain a warrant for Mr. Richardson's arrest. On November 2nd 2022 he was taken into custody and booked into the Lake County Jail with no bond.

## Diabetes Management



**Diabetes Management: It Takes a Team**

(NAPSI)—

Almost every American has a family member or friend affected by diabetes, and more than 1 in 10 Americans have the disease. Diabetes occurs when your blood glucose, also called

blood sugar, is too high. Diabetes can damage many of your organs, including your eyes, kidneys, nerves and heart, and is linked to some types of cancer.

If you have diabetes, working with a team of health care professionals can offer you the personal care you need to improve your health. Your team may include your primary care provider, a nurse, an eye doctor, a certified diabetes educator, a pharmacist and others. Your team can give you advice, recommend a program to manage your diabetes and answer any questions you may have.

"Working with a team helps ensure people stay on top of their self-care plan, including having their blood pressure, feet and weight checked regularly," said National Institute of Diabetes and Digestive and Kidney Diseases (NIDDK) Director Dr. Griffin P. Rodgers. "Routine health care will help people find and treat health problems early, or help prevent them altogether."

But remember, you are the most important participant in your diabetes care. Here are some tips to help you manage your diabetes.

Become an expert on your disease, and don't be afraid to ask for help.

Talk with your primary care provider and other members of your health care team about ways to manage your diabetes as early as possible. Your health care team can also help you develop a plan to prevent diabetes-related health problems.

Get routine medical exams to check your blood glucose, cholesterol, blood pressure and weight. Keep a list of your numbers so you can see how they are changing.

Have routine eye, foot and dental checks, because you may not have any symptoms until you develop serious health problems.

If you smoke or use other tobacco products, stop.

Ask your primary care provider what vaccines you should get to reduce your risk of getting sick, such as a flu shot, pneumonia shot or COVID-19 vaccines.

Healthy habits can also help manage your diabetes. Set a goal to be physically active on most days of the week. A daily walk with a friend or a family member is one way to be physically active. If you are not active now, ask your health care team about the types and amounts of physical activity that meet your needs.

Following a diabetes meal plan can help manage your blood glucose, blood pressure and cholesterol. Choose foods that are lower in calories, saturated fat, trans fat, sugar and salt, such as fruits and vegetables, whole grains, lean meats, tofu, beans, seeds and nonfat or low-fat milk and cheese. Your primary care provider may refer you to a registered dietitian to help you create a meal plan that is easy for you to follow and has the nutrients to help manage your diabetes.

Stress can lead to unhealthy habits such as smoking, poor sleep and excessive eating. Take part in a diabetes education program or support group that teaches you techniques for managing stress. You can also ask for help if you feel down or overwhelmed. Talking with a mental health counselor, friend or family member about your feelings may help you feel better.

Working with your diabetes health care team makes it possible to get the care you need to live a healthy and fulfilled life.

## Skin Cancer



### What You Need To Know About Skin Cancer

(NAPSI)—If you or someone you care for is ever among the 5 million people diagnosed with basal cell or

squamous cell carcinoma every year in the U.S., here are a few facts it would be healthy for you to know.

#### Skin Cancer Stats

1. Skin cancer is the most common type of cancer in the U.S.
2. Basal cell and squamous cell carcinoma account for 95% of all skin cancers.
3. Your risk increases with age.

#### Skin Cancer Signs

A change in your skin is the most common sign of skin cancer, advises the Centers for Disease Control and Prevention (CDC). This could be a new growth, a sore that doesn't heal, or a change in a mole. If you notice any of these, see your dermatologist. Nearly all skin cancers can be treated effectively if they are found early.

It's a good idea to protect your skin from UV rays from the sun, and from tanning beds and sunlamps advises the CDC. Here's how:

Wear clothing that covers your arms and legs.

Wear a hat with a wide brim to shade your face, head, ears, and neck.

Wear sunglasses that wrap around and block both UVA and UVB rays.

Use a broad spectrum sunscreen with a sun protection factor (SPF) of 15 or higher.

Avoid Indoor Tanning. A tan does not indicate good health.

#### Types of Treatments

If, despite such precautions, you still develop skin cancer, there are several kinds of treatments that can remove or destroy basal cell skin cancers explains the CDC. These cancers very rarely spread to other parts of the body, although they can grow into nearby tissues if not treated. One of the most common is surgery. That, however, can leave scars and have other serious side effects.

In addition, radiation therapy, chemotherapy, photodynamic therapy, immunotherapy, and other drug therapy

may be tried. Each has its benefits and drawbacks.


The clinic's new name honors Antisubmarine Warfare Chief Andrew

Kenneth Baker of Middleburg, Florida who was killed during a SEAL training event when the Trident 615, an H-60 Seahawk, crashed at sea on March 13, 1997.

The House version of the bill—H.R. 1960—honors Chief Baker's birth year and his decorated career. Chief Baker served on the USS Carl Vinson and USS Coral Sea as a Ship's Serviceman and completed training in Search and Rescue Swimmer School in Pensacola and Fleet Replacement Aircrewman training at NAS Jacksonville, earning his "Wings of Gold." Chief Baker then reported to HS-9, serving on the USS Nimitz, then in HS-3, assigned as the Training and Operations Chief. "Honoring U.S. Navy Chief Petty Officer Andrew Kenneth Baker's legacy of bravery and service to our country is the right thing to do," said **Senator Rubio**. "The new VA clinic in Clay County provides quality care to our veterans who have dedicated their lives to serve, just like Chief Petty Officer Baker." "Our veterans make countless sacrifices to defend our nation. We must do everything possible to provide them with the support and care they need. I'm proud that this legislation honoring the legacy of U.S. Navy Chief Petty Officer Andrew Kenneth Baker has passed the House and is now headed to the president's desk," said **Senator Scott**.

"The clinic is a tremendous beacon for our veterans' community, offering lab work, primary care, telehealth services, and mental health counseling," **Cammack**
