Vehicle of Interest

DETECTIVES RELEASE IMAGES OF VEHICLE OF INTEREST IN WEIRSDALE DOUBLE HOMICIDE

Marion County, Florida (February 4, 2017) – Marion County Sheriff's Office (MCSO) Major Crimes detectives have released images of a "vehicle of interest" in a double homicide that occurred in Weirsdale on January 29, 2017. The vehicle is described as a 2015-2017 blue in color Chrysler 200. Detectives are asking for the public's help in locating this car, as well as helping us identify its owner and any occupants that may have been in it.

Deputies responded to 14241 SE 151st Place Road in Weirsdale last Sunday

morning after receiving a 911 call. Deputies discovered that an apparent home invasion robbery had occurred with two fatalities inside the home. At this time, detectives are not releasing the manner of death. 18 year old white male, Bailey Zylo (DOB: 8/21/1998) and 38 year old white male, Andy Fockler (DOB: 8/14/1978) were pronounced dead on scene. The suspects were described as two black males, both wearing masks.

Tourism Breaks All Records

FLORIDA— Governor Rick Scott announced that Florida set another record in tourism by welcoming the highest amount of visitors in the state's history with 112.8 million visitors in 2016. This is the sixth consecutive record year for visitation to Florida, exceeding the previous high of 106.6 million in 2015 by 5.9 percent. Tourism jobs also hit a record high in 2016 of 1.4 million jobs, exceeding the previous record in 2015.

Governor Scott said, "Today, I am proud to announce that Florida has once again

welcomed a record number of tourists with 112.8 million visitors to the state in 2016. Visitors spent \$109 billion and supported a record 1.4 million Florida jobs in 2016 – a testament to the vital importance of tourism to our growing economy.

"I have seen firsthand how tourism impacts our state. Since I have been in office, we have made important investments in VISIT FLORIDA and broken record after record of visitors, added more than a million new residents and seen Florida's private sector create more than 1.25 million new

Man Shooting At Sabal Pipeline Flees From Area Killed During Officer Involved Shooting

MARION COUNTY, FL

(February 26, 2016)

At approximately 9:00 a.m., on Sunday, February 26th, Marion County Sheriff's Office (MCSO) deputies were dispatched to a call regarding a man using a high powered rifle to shoot at the Sabal Pipeline and equipment.

As MCSO deputies were responding to the Sabal Pipeline located at the 12500 block of Highway 200 in Dunnellon, the suspect fled into Citrus County. Citrus County Sheriff's Office (CCSO) and Florida Highway Patrol (FHP) then located the suspect's vehicle and a pursuit was initiated. The suspect was involved in a crash near Floral City Park, at which time he brandished a weapon at CCSO deputies and was subsequently shot and killed. At this time, the identity of the suspect is being withheld pending next of kin notification.

The Florida Department of Law Enforcement (FDLE) will be investigating the shooting. No law enforcement personnel or citizens were injured as a result of this incident.

I was acting for my brother who is in and out of the VA hospital fighting for his life. We agreed to a settlement with them to lease the space the pipeline is buried forever! The attorney did a good job closing the deal. I will have more to say about the Golfer tortoise and the lizards that the environmentalist searched for on our little farm.

The First Amendment of the U.S. Constitution clearly states that Congress shall make no law respecting an establishment of religion, or prohibiting the free exercise thereof; or

abridging the freedom of speech. This freedom from the establishment of a state religion and the protection of free speech establishes the protection of religious speech and expression as well. There have been many challenges by the ACLU and others at public schools across America and in Florida to sterilize the schools of religious expressions using the establishment clause; however, this clause was intended to declare religious freedom in the US and to escape the establishment of state religion as was common in governments of the old world.

After much case law, it is time to articulate in statute how Florida school policy will apply this free speech to our school administrators, teachers, staff, and students. We owe them clarity.

This proposed bill is not in response to a crisis or high profile case. The time to clarify is not in the middle of a crisis, but the trend is clear to people of faith. Expressions of faith have been stifled in our public schools. This proposal is not intended as a criticism of our school administration; we have left them

without clarity on this issue. Free speech does not stop at the school property line and this statute will give clarity and direction on how to preserve this constitutional right without authorizing disruption and disharmony.

Rep. Daniels, a Democrat African-American House Member brought this language to me, a Republican Caucasian Senator. It is a bi-partisan and bi-cameral proposal brought in harmony to the legislative body. It is much like an "enabling bill" often done to apply a constitutional amendment when added to the Florida constitution by the voters. How refreshing to work across the aisle and across the chambers to clarify how the free speech of our citizens will be protected at our schools.

Without this free religious expression, we are in fact establishing a state sponsored religion—secular humanism.

Florida House is Playing Politics with Families' Jobs

The Florida House of Representatives has decided to push legislation to undo economic development funding in Florida and defund our state's tourism agency. A House panel voted for this job killing legislation two weeks ago and the House Appropriations Committee will be voting on it tomorrow.

That's correct, many of your elected members of the Florida House have decided their top priority this year is to eliminate funding for Florida's economy. They want to eliminate Visit Florida and Enterprise Florida.

They say that they don't want government intrusion in the free market. Of course, there is government financing in the areas of healthcare, transportation, education, housing, and social services. But, they have decided to try to totally eliminate funding for the one area where we can easily show a major return on the investment of your tax dollars - jobs are being created by more companies moving to our state and our tourism industry has recruited a record-breaking number of visitors over the last few years.

Even more absurd, the politicians in the Florida House who already voted for this bill say they don't necessarily want to abolish these programs but instead want

to advance a "conversation" ...meaning they voted for something they don't support. This is hypocrisy at its best and these are the kind of games I came to Tallahassee to change.

I ran for Governor to fight this sort of politics and bring common sense from the business world to our government. The plan has worked, as Florida has added more than 1.26 million new jobs.

Many politicians spend a lifetime in government and they simply don't have any understanding of how business actually works. These are the facts that confirm the negligence of eliminating our jobs and tourism agencies generating jobs:

- Before I came into office, state incentives were often awarded before goals, like job creation, were met.
- But, today Florida companies only receive economic incentives after an independent third-party audit proves stringent requirements are met, including proven job growth and wage requirements to ensure a great return on investment for Florida families.
- This means NO MONEY is given as "corporate welfare" because no money can be awarded until contract requirements like jobs are created.
- Because of our economic development programs, several companies like Hertz, Northrup Grumman, and Blue Origin – to name a few - have located or expanded in our state to create thousands of jobs.

The Florida House likes to rely on inaccurate information to push their narrative of "corporate welfare," by

Light it Up!



Simple tips to keep your home safe: Remember - Light it UP!

Many people ask, how can I keep my house safe from potential burglars? Here are a few tips about home

security lighting to help prevent break-ins to your home:

Keep the outside of your home well lit! Keeping the outside of your home well lit can help to deter any would be criminals by shedding light on all possible areas of entry into your home. This can be done

with flood lights or well-placed landscape lighting.

Front porch/entry lighting: Keeping your front porch light on while you are away can give the facade of being home even if you are on a week-long vacation. This can be achieved by purchasing a timer that will turn the lights on and off at certain times of the day that can be set differently for each day to give the illusion that you are home.

Keep random lights on in different rooms via plug in timers. Having lights go off and on at random times throughout the house will make it seem like the house is occupied. This is a huge deterrent to any lookouts or criminals that may be out. Make sure the lights you choose are in areas that can be seen from the street or as

someone approaches your home.

Set up motion sensor lights on the outside of your home. Setting up motion sensor lights on key portions outside of your home can not only let you know when there is movement, but let your neighbors know as well.

OK, are you ready to take a quick test? **What is your Security Quotient?**

The following test will help you evaluate your "Security Quotient" or the degree to which you have reduced a criminal's opportunity to gain access to your home. Naturally, we expect a score of 100% and we do hope this questionnaire will serve as a guide for you to make your home and your neighborhood a safer place to live! Put a check mark next to each question you answered yes to and discover your "Security Quotient".

- I have trimmed all shrubbery that would conceal entrances to my house.
- My house number is clearly marked on my residence and illuminated by my

entrance light for quick recognition by emergency personnel.

- The exterior doors to my home are constructed of solid wood or metal and have strike plates and hinges installed with 3-inch screws.
- I leave exterior lights ON, front and back, during the hours of darkness, whether I am home or not.
- have deadbolt locks or other recommended secure locks on all exterior doors, and I use them!
- All windows in my home are locked (not just latched) while I am away.
- When I leave my home unoccupied, I leave a radio on and lights on timers. In other words, my home has that lived-in look while I am gone.
- I keep shed or garage doors securely locked when I'm gone.
- When I'm away overnight or longer, I alert neighbors to watch my house and ask a trusted neighbor or friend to pick up mail and or newspapers, change lights, mow lawn, etc.
- When my neighbors are away, I keep an eye on their house for them.

Give yourself 10 points for each point checked.

- . 0 - 50: attention is necessary
- 50 - 70: consider improvements
- 70 - 90: you're doing a good job
- 90 - 100: excellent, way to go!

jobs. Unfortunately, even with these incredible successes, politicians in the Florida House are trying to eliminate VISIT FLORIDA. I don't understand how anyone can look at Florida's booming tourism industry, and the more than 1.4 million jobs it supports, and vote to kill it. The legislation the Florida House is pushing puts more than 1.4 million jobs at risk and we cannot let that happen. highlighting the failed deal of Digital Domain. Let's look at the facts: EFI recommended that the state **not** fund Digital Domain. Ironically, politicians in the Florida Legislature chose to ignore EFI's recommendation and circumvented EFI's strict process in 2009 by funding the failed project FROM THE LEGISLATURE.

Both Visit Florida and EFI have made mistakes over the years. In both cases, we have made changes to ensure transparency of taxpayer dollars and brought in new leadership. That is what you do in business; you make changes and get it right. But what you do not do is close up shop.

former military persons who have impaired vision can learn to lead more independent, pleasant and productive lives.

There are two basic kinds of facilities. The Blind Rehabilitation Programs support blind and low-vision veterans and active-duty servicemembers in regaining their independence and quality of life to enable their successful integration into family and community life.

These places also support family and significant others to better understand visual impairment and foster the provision of appropriate support, to assist in enhancing home environments and to reduce caregiver burden.

The Visual Impairment Services Outpatient Rehabilitation (VISOR) programs use a team approach to provide services based on a thorough assessment of the veteran's strengths, needs and personal goals.

Veterans and their families are encouraged to identify these goals and provide ongoing feedback regarding progress.

To enhance the quality of life for veterans and servicemembers experiencing vision loss, the Blinded Veterans Association (BVA) works with VA to help keep these places up to par. Recently, that organization's Training Coordinator, Wade Davis, conducted a comprehensive and individualized Veterans Care Review at each of the 13 Blind Rehabilitation Centers

nationwide. He is currently doing the same with the VISOR programs.

What Davis Does

Over several days, Davis visits each facility and meets separately with the staff and the veterans involved. He considers various aspects of the programs: orientation and mobility, living skills, manual skills, low-vision therapy, computer access training, low-vision clinic, optometry, eye clinic, ophthalmology, recreation therapy, social work, psychology, nursing, diabetic education, and pharmacy. He also talks to the Visual Impairment Services Team (VIST) Coordinators individually. Davis' aim is to evaluate the full curriculum of care and to share findings with staff and the administration to promote and expand each facility's successful procedures and generally make the facility as productive and safe as it can be for blinded veterans.

He also holds information sessions for the veterans and provides literature about BVA.

Davis' BVA evaluations have brought about a number of improvements to blind rehabilitation services, such as making sure each of the facilities has the training and equipment it needs.

What BVA Does

All this is just one way BVA fulfills the mission it's pursued since the end of World War II: to promote the welfare of blinded veterans so that, notwithstanding their disabilities, they may take their rightful place in the community and work with their fellow citizens toward the creation of a peaceful world. Through its free service programs, regional groups, resources, and



advocacy before the legislative and executive branches of government, it makes life better for blinded veterans.

What You Need To Know Before Hiring A Tax Pro

(NAPS)—When it comes to dealing with the IRS, there are a few more initials it may pay for you to know about.

These can include PTIN, CPA, Esq., AFSP, EA and NAEA. Here's what it all means:

PTIN: By law, whomever you hire to do your taxes must have a Preparer Tax Identification Number (PTIN). Checking for a PTIN is a good place to start in making sure your preparer is on the level.

CPA: Certified public accountants are licensed by the state and must pass tests and report continuing education. CPAs must pass a four-part test, one part of which centers on taxation. CPAs can have a variety of specialties, from accounting audits to estate planning.

Esq.: Attorneys often have Esq. (for esquire) after their names and sometimes JD for Juris Doctor. Like CPAs, lawyers are licensed by the state and may or may not specialize in taxes. Attorneys have unlimited rights to represent taxpayers before the IRS but not many of them prepare taxes. They are more often called on by taxpayers already in trouble with the IRS.

AFSP: This stands for Annual Filing Season Program. It's a voluntary program for preparers that shows they've passed a

basic test and agreed to complete some continuing education each year.

EA: Enrolled agents earn their credential by passing a comprehensive exam administered by the IRS that covers individual, business taxation, and IRS representation. They represent and prepare tax returns for individuals, partnerships, corporations and any entities with tax-reporting requirements. NAEA: The EAs who belong to the National Association of Enrolled Agents provide three more unique benefits to taxpayers.
