To help with Economic Development, the County has welcomed new commerce such as Chewy and Auto Zone. They are also reviewing options to develop tracts of land in Belleview. Michelle recognizes how important it is to preserve land while offering opportunities for development.

In her fight to protect our water Michelle is learning a lot about how to appropriately develop space at Silver Springs in a protective manner. She reminded us all that we will soon be a part of the 220 miles of biking trails across Florida.

Medical Marijuana is also a hot topic as we learn what regulations and ordinances will be in place.

# Two Suspects Arrested in Weirsdale Double Homicide

MARION COUNTY, FL (May 18, 2017) - Marion County Sheriff's Office (MCSO) Major Crimes Detectives identified Emanuel Angelo Tuggerson (B/M DOB: 8/11/1997) and Isaiah Ishmael Richard (B/M DOB: 1/1/1997) as suspects in the homicides of Baily Zylo (DOB: 8/21/1998) and Andy

Fockler (DOB: 8/14/1978) on January 29, 2017, in Weirsdale.

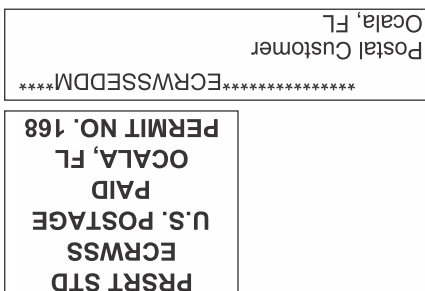
Richard was located and arrested by the Alachua County Sheriff's Office and Tuggerson is at the Marion County Jail on unrelated charges, and will be served with an arrest warrant for these charges while in

custody.

On January 29, 2017, deputies responded to 14241 SE 151st Place Road in Weirsdale after receiving a 911 call. Deputies discovered that an apparent home invasion robbery had occurred with two fatalities inside the home. 18 year old Bailey Zylo and 38 year old Andy

Fockler were pronounced dead on scene.

Richard and Tuggerson are being charged with two (2) counts of Murder in the First Degree and are being held on no bond. At this time MCSO Major Crimes Detectives are still collecting information, we will release more information as it becomes available.

One of the two primary goals of the CEP is to create and retain jobs in our community. Four of our five core areas are organized around this goal. You will often see our five-year goal of impacting the announced creation of 4500 new jobs if you attend a CEP event or browse our website. However, job creation is more than just the projects that we directly impact. In fact, if we are doing our jobs then the community should see greater economic impact and job creation.

One way many people track the status of the job market is through the unemployment rate. While there are some real challenges with this approach, it does provide a good barometer of what is happening in our community. Using the latest numbers available (March 2017), the current unemployment rate in the Ocala MSA (Marion County) is 5.1 percent. This is a tremendous improvement from just a few years ago when it surpassed 14 percent. Additionally, when you look at the three-county workforce the numbers remain very positive. Marion County is the center of a regional workforce shed so these numbers are important. The unemployment in this region was 5.2 percent with nearly 5,900 more people employed than a year ago.

While the unemployment numbers are a popular benchmark and often discussed in the news, it is another metric which we track more closely. The private, non-farm payroll report is for the CEP a much better reflection

of the workforce and employment. You often hear this number discussed when the Federal Reserve is meeting. In the Ocala MSA, this number shows the region has created more than 13,000 jobs in the last few years which is a 14 percent increase. The resulting annual job growth rate for our community remains around 4 percent which is one-third higher than the Florida average and 2.5 times the national rate. Regardless of the measurement you choose, it is hard to deny the significant job creation which is occurring in our community.

### New Chapter

Two and half years ago, Best Version Media partnered with the CEP on the creation of a new magazine, *Partner Connections*. While they are the experts at neighborhood publications, this was something new and different for them. Yet, they have been an incredible partner throughout this run. They came forward with a willingness to partner and we are so grateful for them.

However, like all good things, this particular publication has run its course. BVM is still a CEP partner and we will work with them on future opportunities. This will be the last issue of this magazine. The CEP will continue to tell the stories of our partners and the exciting things happening in this community with a couple of new publications later in the year. They will be different from *Partner Connections* but we hope will help continue to develop this medium with our partners. ## Region's Jobless Rate Drops Below 5%

OCALA, Fla. (May 19, 2017) – The unemployment rate for the CareerSource Citrus Levy Marion region was 4.8 percent in April, down half a percentage point over the month and 0.8 percent lower than the same time last year.

It is also the first time since the slow slog of economic recovery began that joblessness dropped below 5 percent for the area.

Out of a labor force of 200,630, which tightened by 914 over the month, there were 9,730 unemployed, a drop of 917 since March and 1,278 fewer than April 2016. While the number of employed remained virtually unchanged in the region – inching up by three over the month to 190,900 – that represents 5,684 more employed than a year ago when the unemployment rate was 5.6

percent.

According to today's employment summary by the Florida Department of Economic Opportunity (DEO), Levy County continued to post the lowest jobless rate in the region dropping from 4.6 to 4.2 percent (the last time it was at 4.2 percent was January 2007); followed by Marion County which was 4.7 percent, down over the month from 5.1 percent, the lowest it has been since June 2007; and posting its lowest rate since October 2007, Citrus County came in at 5.5 percent rate, dropping from 6.0 percent. Florida's not seasonally adjusted rate was 4.0 percent, down over the month from 4.4 percent; and the nation's rate was 4.1 percent, down from 4.6 percent.

For the fourth consecutive month, the

The 2017 Legislative Session has come to an end! We have worked hard to secure good policy for our constituents and the people of Florida. During our time in Tallahassee this year, some big issues were

addressed: tax cuts, increased homestead exemption, more clarity on our self-defense and religious freedom rights, and increased funding for bright futures and higher education institutions.

This year, the legislature passed \$180 million in broad based tax-cuts for Floridians. This includes a three day back to school sales tax holiday, a reduction to the business rent tax, a disaster preparedness sales tax holiday, and the elimination of sales tax on feminine products. A bill was also passed that will provide significant tax savings for homeowners across Florida. The increased homestead exemption bill will propose an amendment to the Florida Constitution to provide an additional homestead exemption of \$25,000. Homestead property owners will receive an exemption from ad valorem taxes, except levies by school districts, for the assessed valuation greater than \$100,000 and up to \$125,000. If approved by Florida voters in November 2018, the amendment will take effect January 1, 2019.

We all have a right and responsibility to defend ourselves against harm. This year a bill was passed that requires that at the pretrial hearing the prosecution prove, by the standard of clear and convincing evidence, that the defendant's use of force

was not justified. The requirements of the bill are consistent with the foundation of our criminal law that a person is innocent until proven guilty.

I was able to pass SB 436 this year, which will protect all students and school personnel in their choice of religious expression. This legislation makes it clear that the Legislature supports the constitutional rights of Freedom of Speech and Freedom of Religion for everyone associated with our public school system. While the government cannot impose a religion, they should not take away people's right to free speech and their right to practice their faith. By codifying these religious liberties, we will ensure that the first amendment rights of our students are not hindered. This bill protects the expression of all religious beliefs, and protects a student's decision not to express any religion.

We also passed historic increases to need and merit based financial aid and tuition assistance programs. This ensures the Bright Futures Florida Academic Scholars award covers 100% of tuition and fees and a \$300 per semester textbook stipend. This will keep Florida's top high school students in the state and help them to graduate with minimal student loans. It will also provide Bright Futures for summer term enrollment, in order to help students graduate on time and enter the workforce earlier. Additionally, it creates the Florida Farmworker Student Scholarship Program, to provide college opportunities to our state's dedicated agriculture industry.

We have worked hard this year for the people of Florida, to ensure our liberties and freedom remain protected. Our constituents are always our priority.



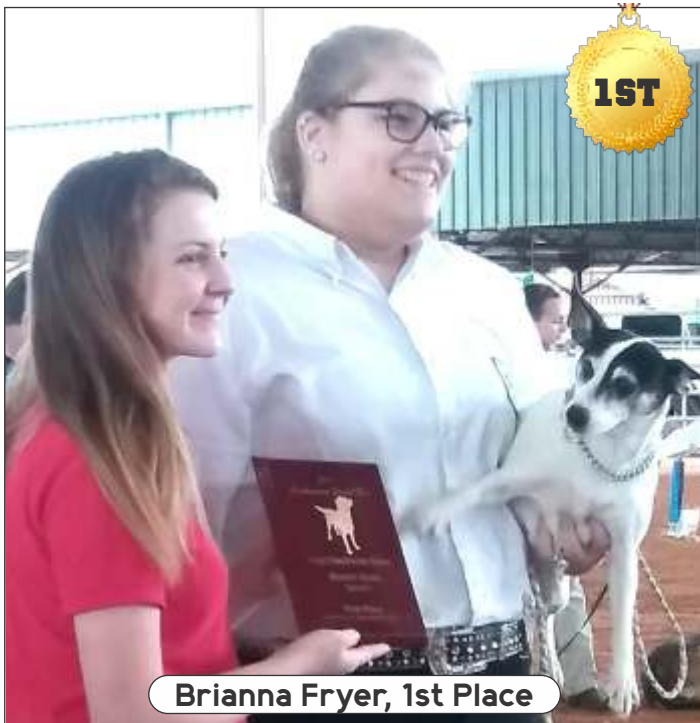

## Protecting Floridians



Pam Bondi, State Attorney General, Weekly Briefing

This week, standing with representatives of the Federal Trade Commission, I announced three new actions in Florida to shut down tech support scams targeting consumers nationwide. We are teaming up with our federal partners to combat tech support scams and warn consumers about the dangers associated with the scams.

The scam typically begins with a pop-up ad claiming a computer is infected with a virus. The ads urge users to call a tech support specialist and provide a phone number. Once the victim calls, the scammer instructs the user through a series of commands to give them virtual control over the victim's computer. With remote access, scammers can install malware, steal passwords or access financial accounts.

Mostly, the scammers claim to fix the nonexistent problem, charge the user a few hundred dollars and set up monthly tech support payments. Often the victim thanks the scammer for fixing the problem—not realizing they were just swindled.

In Florida we are fighting these tech support scammers every day—and we have had a lot of success. My office has more filed cases against these types of scams than any other state agency in the country.

If you or someone you know has received one of these solicitations, record the name, number and any other pertinent information associated with the solicitation. Then call my office at (866) 9NO-SCAM. Knowing what to look for, reporting suspicious solicitations and working together we can stop scammers targeting Floridians.

## Region's Jobless Rate Drops Below 5%

Ocala metropolitan statistical area (MSA) continued to hold the fastest annual job growth rate compared to all metros in Florida in professional and business services, at 9.7 percent. The Ocala MSA had the third fastest job growth rate in mining, logging and construction at 10.4 percent.

Rusty Skinner, chief executive officer for CareerSource CLM, noted that modest employment gains in Levy and Marion counties offset slight losses in Citrus County, while unemployment continued to drop in all three counties. "I won't call this report 'lukewarm' because there are lots of positives in it and we are certainly moving in the right direction," Skinner said. "But what we also see is that the dip in the labor force is more a reflection of fewer people out of work than a robust increase in employment."

Skinner noted that five years ago, the region's unemployment rate was 9.6 percent – the first time it had hit single digits since November 2008. At that time, there were 19,495 people out of work and employment was 183,512 or 17,118 fewer than April 2016.

"It's important to keep things in perspective," he said. "That said, we're going to continue to work with business, economic and education partners to help ensure that everyone who wants a job can get one here in our communities or within a reasonable commute of our area."

DEO's preliminary data for the area's three

counties shows that in April, Citrus County's labor force contracted over the month by 393 to 47,758, the number of employed fell by 155 to

45,120, and the number of those without jobs also fell by 238 to 2,638. That is 241 more employed and 414 fewer unemployed since April 2016 when the jobless rate was 6.4 percent.

Levy County's labor force shrank by 55 to 16,889, the number of employed increased by four to 16,175 and the number of unemployed dropped by 59 to 714. That's 428 more employed and 86 fewer unemployed than a year ago when the jobless rate was 4.8 percent.

Marion County's labor force decreased by 466 to 135,983, the number of employed increased by 154 to 129,605 and the number of jobless decreased by 620 to 6,378. Compared to April 2016 when the unemployment rate was 5.4 percent, that reflects an increase in employment of 5,015 and 778 fewer unemployed.

**Please note the rate for April 2017 was 4.7 percent, down over the month from 5.1 percent and down from 5.4 percent in April 2016. That's the lowest rate since June 2007 when it was also 4.7 percent.**

Among the counties, Citrus County continued to hold the third highest rate behind Sumter County at 5.7 percent and Hendry County at 6 percent; Marion County held at 11th; and Levy County was 24<sup>th</sup>.

The Villages MSA continued to post the highest rate among the states metros at 5.7 percent, Homosassa Springs (Citrus County) was second and Ocala was fifth.

The Ocala metro posted 103,500 nonfarm jobs in April, an increase of 2,600 new jobs for a 2.6 percent growth rate over the year. That narrowly outpaced the state average job growth rate of 2.5 percent and tied with West Palm Beach and Tampa for the 10<sup>th</sup> strongest job growth rate among all Florida metros. Neighboring metro areas of The Villages and Gainesville posted the second and third fastest growth rates at 4.4 percent and 3.9 percent.

Industries gaining jobs over the year were professional and business services (+900); trade, transportation and utilities (+700 jobs); mining, logging and construction (+500); education and health services (+400); manufacturing (+200); and other services (+100); and other services (+100).

In addition to professional and business services job rate growth of 9.7 percent, other industries that grew faster in the Ocala metro area than statewide over the year were mining, logging and construction (+7.2 percent); and trade, transportation and utilities (+3.1 percent).

Information and financial activities each lost 100 jobs over the year. Leisure and hospitality and government industries were unchanged.

The Homosassa Springs MSA had 33,500 nonfarm jobs in April, the same as the previous month but a decrease of 200 (-0.6 percent) over the year.

The May employment report will be released on Friday, June 16.

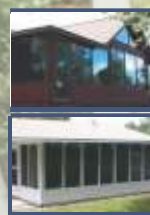

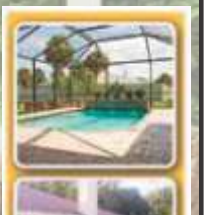

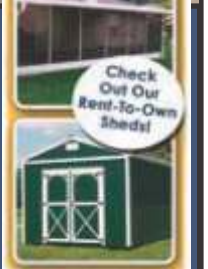

## Lunch Hour Accident Results in Roll-Over at MLK JR. Avenue



(OCALA, Fla.) May 11, 2017 – A vehicular accident reported at 12:12 PM, resulted in an SUV rolling over at the intersection of NW Martin Luther King Jr.

Ocala Fire Rescue responded to a two motor-vehicle accident, with possible entrapment, this afternoon. Upon arrival, Fire Engine #3 encountered two vehicles obstructing the road; a pick-up truck with moderate damage to the impact site, and a heavily damaged SUV which had rolled-over. Inspection of the vehicles revealed that the driver and passenger of the SUV needed assistance in exiting. # Preparedness For The 2017 Hurricane Season Starts With Simplicity



"It's better to be ready for a nonevent than it is to be caught off guard by a strong storm," said Russ Minick, chief marketing officer at Generac Power Systems. Outages and the need for fuel go hand in hand. During a power outage, you still might need to be out and about—maybe even evacuate the area—so ensuring that your car is fueled is important. In a worst-case scenario, your car can serve as a source of light, heat and electricity. A portable generator is far better suited to provide backup power, though, so make sure it has clean fuel, as well. And make sure any fuel you store is kept in approved containers. The time to prepare an emergency kit is before a hurricane or other disaster strikes.

(NAPS)—The 2016 hurricane season ended a decade-long landfall drought in Florida. Hurricane Hermine struck Florida's north coast in early September, and then Hurricane Matthew tore north along the Atlantic coast in early October. The intensity of that late-season storm left more than 1 million Florida homes and businesses in the dark while 485,000 were without power in South Carolina; 300,000 in Georgia; and more than 127,000 in North Carolina.

The climatological hurricane season is long, running between June 1 and November 30, but it's become increasingly important for vulnerable home and business owners—from the Gulf Coast to New England—to take the necessary steps ahead of the storm warnings and the inevitable rush for emergency supplies.

# Making E-mail Secure Is Just Not That Difficult

E-mail in its stock form is inherently insecure but that does not mean that it must stay that way. With a little bit of effort, one can confidently send secure e-mail with virtually no risk of the contents being compromised.

An analogy is that of a car and a seat belt. Cars are useful and largely safe. But we can make them safer by buckling up. While seat belts were not used regularly for many years, today, we understand their benefit

## E-mail Suffers From Two Problems:

The second problem is guaranteeing your identity or the identity of someone sending you an e-mail. Your identity or that of any sender can easily be spoofed. You have no way to be confident that the e-mail you received was from who it claims to be, nor can anyone be confident that e-mail from you came from you. All one needs is a friendly e-mail server (i.e., one where you have administrator rights) to spoof e-mail “To:” and “From:” addresses.

Encrypting your e-mails end to end (E2E) from within the e-mail client solves the problem by ensuring that they are safe and secure at rest (and in flight). Your content might get hacked but the hackers wouldn't be able to read the content because it is encrypted. If your account has been compromised such that a third party has access, they wouldn't have access to your encryption keys and thus couldn't decrypt your content.



How does one get these protections? First, both sides of the communication need to agree to participate. It also takes an extra step, like buckling up your seat belt—you need to press a button (within your e-mail client) to secure your e-mail.

Modern encryption products such as those offered by Trustera let you encrypt and sign your e-mails using your existing e-mail accounts and using whatever platform you might like to consume and send e-mails. Trustera supports iPhone/iPad, Android, Mac, Windows, and Windows Outlook. Much like with buckling up or backing up your data, we all know we should be more secure with our messaging and now we easily can. There is no better time than now to start encrypting your e-mails. It is just not that hard to make e-mail safe and secure. Though the hackers hope you don't....
