Governor Scott State Attorney Reassignment

Executive Orders 17-188 and 17-189:
Regarding State Attorney Reassignment

Please see Executive Order 17-188 and Executive Order 17-189 which reassign to State Attorney Brad King the investigation, presentation to the grand jury, and all matters related to criminal charges referenced in the Executive Orders against Callene Marcia Barton and Lakesha Chantell Lewis.

On July 7, 2017, Callene Marcia Barton and Lakesha Chantell Lewis were arrested for First-degree Felony Murder and Aggravated Child Abuse after inflicting fatal injuries upon a three-year-old victim. As reported in the Orange County Sheriff's Office arrest affidavit, Lewis attacked the three-year-old with a plastic rod, repeatedly

striking the child until the rod broke apart. The victim's mother attempted to intervene and removed the child to another room, but Barton pursued them and grabbed the child by an arm and a leg, throwing him down a hallway, the impact of which caused his neck to turn and his body began convulsing. Barton prevented the victim's mother from calling the police, but the woman fled from the residence and called the authorities from a neighbor's phone. The minor victim was transported to a hospital, but succumbed to his injuries and was pronounced dead several hours later. The arrest affidavit notes the child had other bruising on his body that had begun to heal, consistent with evidence of prior physical abuse.

Drainage Problems



Publishers Note: My name is Tom Loury Publisher of Ocala DownTown newspaper, Seniors Voice of Ocala, Village Spectator and Lady Lake Magazine. The situation we are writing about is a long time problem. Walter Krumm Jr. a personal a friend ask me to attend a committee meeting Don Browning was organizing. The committee was mostly made up of Ocala Ft King Lions Club members: Jack Mattheus, Walters

Krumm Jr, Bob Cole, Ron White and of course Don Browning and myself.

We went and toured the area and it was clear to see there was a problem. It is a problem created by road engineering from a long time ago and added to by some citizens. For instance there is a big retention pond hundreds of feet away, but someone has fenced a piece of property with no county easement allowed. In other words the fence

is 3 inches from the pavement. At the base of any fence is grass growth and build up which is pushing the water in the direct of this lady's house and yard. Not far from this is the said retention pond and where the water is supposed to go, but someone has piled a mound of dirt so water cannot go in. This looks intentional! A bit further down, there is a make shift patch someone dug, a small relief drainage, which is apparently is not

working. I'm not an engineer but I can see this won't work with the heavy rains we have been having. To add to the problem some very large buildings and a parking area contribute to the problem pushing water from the other side of this area. I think the fix would be getting the county engineers out there and do a permanent fix. Go out while the rains are coming down and look at the results. No one should have to go through this. This lady's front yard turns into a retention pond because of problems created years ago. Let's fix it!

Information furnished by Don Browning

Storm water drainage problem impacting Mrs. Gavins and other persons at the Stanton Weirsdale School community.

Stanton Weirsdale School Road and (167th Terr) and 134th Ave Rd. commonly called the Packing House Road.

Storm Water Drainage off the Packing House and a Willett Boyer Albright Trust property drain into the Stanton Weirsdale School Community.

1956 the School was dedicated, but the roads to the school were never dedicated or set up to handle normal stormwater. Mrs. Sarah Gavan is experiencing hundreds of gallons of stormwater with each rain storm flowing directly into her yard.

Marion County School Superintendent Heidi Maier and Marion County Board of County Commissioners are addressing the problems caused by poor roads used to travel to and from the Stanton Weirsdale School for over 50 years. The Federal Government has allowed what is called Unitary Status for the Stanton School

Preventing And Dealing With Identity Theft



Every person who willfully obtains personal identifying information, e.g., name, address, date of birth, Social Security Number (SSN), mother's maiden name, etc., and uses that

information for any unlawful purpose is guilty of a crime. Identity theft is the fastest growing crime in the United States. Every year about 15 million people become victims. Everyone is vulnerable. Skilled identity thieves use a variety of methods to steal your personal information. These include the following:

- Dumpster diving: They rummage through trash looking for bills and other paper with your personal information on it.
- Skimming: They steal credit- or debit-card numbers with a special storage device when processing your card.
- Phishing, spear phishing, smishing, vishing, and whaling: They send realistic-looking e-mail that asks recipients to go to a bogus website and provide personal information, use text messages instead of e-mails, and send fake e-mails to high-ranking executives to trick them into clicking on a link that takes them to a website that downloads software that secretly records keystrokes and sends data to a remote computer over the Internet.
- Changing your address: They divert your

billing statements to another location by completing a change-of-address form.

- Stealing: They steal wallets, purses, mail (credit card and bank statements, pre-approved credit offers, new checks, tax information, etc.), employee personnel records, etc.

An enormous amount of information is available on various identity theft issues. I will summarize some tips for minimizing risk, things to do if you become a victim or are notified of a security breach involving personal information, and links to many websites. For comprehensive set of links to the websites of a wide range of government agencies and nonprofit organizations that deal with these issues, go to The Consumer Federation of American's website at www.idtheftinfo.org. It contains links that deal with consumer, business, and victim resources, shopping for identity theft services, protecting yourself, statistics and studies, etc.

Protecting Personal Information

Give out credit or debit card, bank account, and other personal information only when you have initiated the contact or know and trust the person you are dealing with. Beware of e-mail or telephone promotions designed to obtain personal information.

Put strong passwords on your credit card, bank, computer, and online accounts. Avoid using easily remembered numbers or available information like mother's maiden name, date of birth, phone number, or the last four digits of your SSN. Passwords should be more than eight characters in length and have at least one capital letter, one lowercase letter, one number, and one symbol. Use of non-dictionary words is also recommended.

Select password reset questions whose answers cannot be found online or from other research tools. Don't compromise a strong password with an easily answered reset question like: What is your mother's maiden name?

Use different passwords for banking, e-commerce, e-mail, and other accounts.

Memorize your passwords. Don't carry them in your purse or wallet.

Keep personal information in a secure place at home, especially if you have

Gov. Scott Recognizes Statewide Zika Preparedness Efforts

MIAMI, Fla. – Today, Governor Rick Scott gave opening remarks at the Florida Department of Health's (DOH) Zika Preparedness Planning Meeting in Miami. DOH hosted the meeting with county health departments and mosquito control districts from across the state, as well as CDC officials, to discuss ongoing efforts to prepare for and combat the Zika Virus.

Governor Scott said, "While Florida does not have any identified areas with active Zika transmission, DOH, mosquito control districts and community partners across the state have been tirelessly working together to help combat the spread of this disease and keep our state safe. We know that summer means more rain, more mosquitos, and more travel-related cases, and that is why we must continue to take aggressive preparedness actions. It is also important that all Floridians do their part to dump standing water and wear bug spray in order to help fight the spread of Zika. We will continue to remain in contact with our federal and state partners and we remain fully committed to doing everything we can to protect our families and visitors."

Surgeon General Dr. Celeste Philip said, "We have learned a lot about how to prepare for and respond to the Zika virus over the past year and it is crucial that we continue to work with our state and federal partners to keep protecting our communities. I appreciate Governor Scott for his leadership in this ongoing fight and the county health departments and mosquito control districts that traveled here today to further discuss ways we can combat the Zika virus in Florida."

It's a good time to be in the Sunshine State! Last month George Mason University released an evaluation they completed "Ranking the States by Fiscal Condition", and Florida came out on top! Florida's No. 1 ranking ends Alaska's three-year reign atop the leaderboard.

We work hard in the Legislature to ensure that Florida remains fiscally sound. That is our first responsibility to our constituents and all Floridians. If our state is not fiscally sound, all the rest of our goals and endeavors in Florida are put in jeopardy.

The group ranked Florida as the state with the strongest fiscal condition based on data collected from each state's most recent audited comprehensive annual financial report. For the ranking, each state was evaluated on the amount of cash it had on hand as well as its budget solvency, long-run solvency, service-level solvency and trust-fund solvency.

We may not get every policy issue right up in Tallahassee, but we take great care to ensure you tax dollars are managed and spent responsibly. 20 million people are counting on us to get our budget balanced and fiscally sound. It is clear, especially in comparison to Washington DC, that we are getting some things right.

After Florida in the ranking came North Dakota, South Dakota, Utah and Wyoming, respectively. The study found that top-performing states tended to have higher

levels of cash, more robustly funded pensions and strong operating positions.

New Jersey earned the unlucky designation of being the state with the worst fiscal condition. The study said New Jersey's revenue only covered 91 percent of its 2015 expenses. Rounding out the bottom five were Illinois, Massachusetts, Kentucky and Maryland.

It is a testament to our fiscally conservative mindset that our budget here in Florida is half that of New York, yet we have more citizens. It is clear that it is not about who spends the most that is successful, but instead who provides the best value for its citizens.

Florida, we have a lot to celebrate!

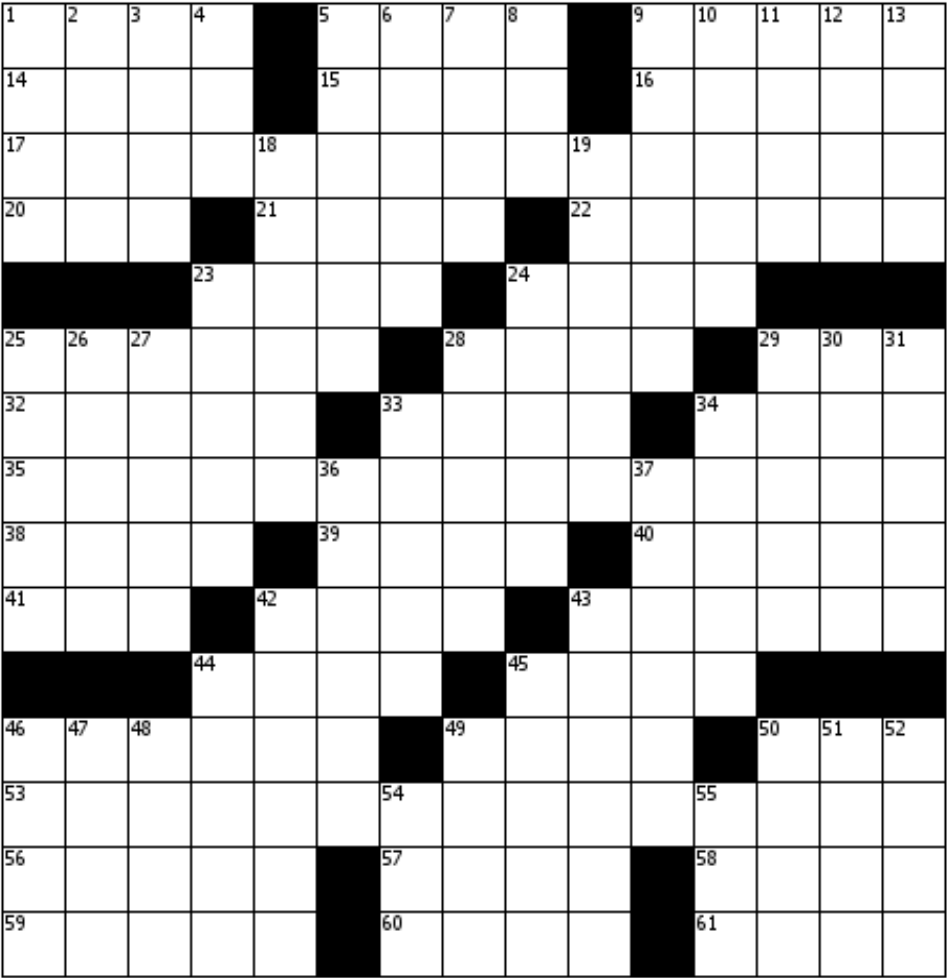

brood, a behavior that has helped reinforce their reputation as “busy bees.”


It’s important to recognize, however, that other insects and animals contribute to pollination, the important process of collecting and distributing pollen to help plants reproduce and bear food. Research conducted in recent years suggests that the combined activity of non-bee pollinators—such as flies, bats and butterflies—can be just as valuable to pollination as bees.

Meet The Lesser-Known Pollinators

A black-and-yellow-striped insect hovering above a flower is not always a bee. Some flies—such as flower flies, or hoverflies—resemble bees; for this reason, they’re called bee mimics. Several plant species—most notably, the cocoa tree—rely exclusively on fly pollination. Without flies, there would be no cocoa beans to produce the chocolate enjoyed throughout the world.

It might come as a surprise that bats are responsible for pollinating hundreds of different plant species. Since bats are nocturnal, they feast on the nectar of flowers that open at night, including the flowering plants and trees that produce bananas, guavas and mangoes. Bats are also found in the desert, where they pollinate the agave

roommates, employ outside help, or are having work done in your home.

Make sure that the copying machines used by you and others who have your personal data, e.g., tax preparers, have data security measures installed to prevent unauthorized access to data on the copier's disk.

Protect your health insurance cards like you would your credit or debit cards. If asked for your policy numbers or any other personal information in a doctor's office, make sure no one else is near enough to hear or see them.

Protect your Medicare card number as you would your SSN. Don't give it to anyone who offers free medical equipment or services and then requests your number. And don't let anyone borrow or pay to use your Medicare card. That's foolish and illegal.

Shred or tear up any documents with

personal or financial information before throwing them in the trash. Use a cross-cut shredder.

Avoid all online games and quizzes that request personal information, including your e-mail address. Providing this information can put your identity at risk.

Omit any information that is not explicitly requested or required on forms, applications, surveys, etc. Information on them may be sold and become publicly available.

Assume that anything placed on social networking websites will be publicly available. Do not post personal or sensitive information, or photos. And use appropriate security settings for anything you do post.

Opting out of the services provided by data vendors can be time consuming and not always possible. There are hundreds

websites that can be used to find addresses, phone numbers, civil and criminal court records, birth and death records, genealogy, etc. These include personal information aggregators like Spokeo that collect and sell public information from all these sources and social networks. Even if you hire a reputation manager to do this, public information will remain available online. You need to find the original source of the information and remove it there, which also may not be possible.

Using Credit and Debit Cards

Never loan your card to anyone.

Pay attention to billing cycles. Check with the credit card company if you miss a bill to make sure that your address has not been changed without your knowledge.

Only put the last four digits of your account number on checks you write to your credit card company. It knows the whole number and anyone who handles your check as it is processed won't have access to the number.

Notify your credit card companies and financial institutions in advance of any address or phone number changes.

Bring home all card receipts and match them against your monthly statements. Look for charges you didn't make.

Dispose of card receipts at home. Never toss them in a public trash container.

Call the credit card company or bank involved if a new credit card you applied for hasn't arrived in a timely manner.

Monitor the expiration dates of your cards and contact the card issuer if new cards are not received before your card expires.

Report all lost or stolen cards immediately and request cards with new numbers. In this case the federal Truth in Lending Act limits your liability to \$50 of any charges made before you report your card lost or stolen. Contact the issuer if replacement cards are not received in a reasonable time.

Sign and activate new cards promptly on receipt. Or write "See ID" on the signature line on the back of the card. Then a thief won't have your signature. A merchant will ask you for a picture ID to make sure you are the cardholder.

Never put a card number on a post card or on the outside of a mailing envelope.

Make sure only the last four digits of your card number show up on your receipts. Cancel accounts you don't use or need. Carry only the cards and identification you need when you go out.

Tear into small pieces or shred any pre-approved credit card offers. They can be used by thieves to order cards in your name.

Ask your credit card company to stop sending blank checks.

Have your name removed from lists supplied by the Consumer Credit Reporting Companies (Equifax, Experian, and TransUnion) to be used for pre-approved/pre-screened offers of credit or insurance.

Don't let your card out of sight. A person taking it to a Point of Sale (POS) device might have a skimmer to steal the information on the magnetic strip, copy your card number and the 3-digit security number on the back of the card, or switch cards. If you do give your card to a waiter or other sales person, make sure you get your card back. And use a credit card instead of a debit card whenever possible. With the former you don't have to pay disputed charges. But with the latter it may take the bank about two weeks to restore the funds to your account.

Make sure your bank and credit card companies have your latest home and cell phone numbers, and e-mail address so they can contact you quickly if they suspect fraud in your accounts.

Put a dollar limit on credit and debit card transactions and withdrawals. And put a number limit on transactions and withdrawals on any day.

Some credit cards now have embedded Radio Frequency Identification (RFID) chips that are designed to be read by secure card readers at distances of less than 4 inches when properly oriented for "contactless payments." Thus, RFID readers that are available to the general public and can operate at ranges up to 25 feet and are essentially useless in stealing the information on your card. And even if that information is "hi-jacked," the cards are said to have security features that make it difficult or impossible to make a fraudulent transaction. Furthermore, the information is on the chip is not the same as that on the

Keep Your Car Breathing Well: Change The Air Filters



(NAPSI)—Just as you need clean air to breathe, so does your car. The vehicle's air filters are what make that possible.

To help them keep doing that and ensure vehicle longevity and interior comfort, car owners should have the engine and cabin air filters inspected and changed regularly.

How They Work

The vehicle's engine air filter traps dirt particles that can cause damage to engine cylinders, cylinder walls, pistons, piston rings and bearings, leading to the engine losing power. The air filter also plays a

critical role in keeping pollutants from contaminating the airflow sensor on fuel-injected cars. A normal-wear item that requires regular checks and replacement, air filters should be inspected at each oil change and replaced annually or when showing other signs of contamination.

The cabin air filter is responsible for cleaning the air entering the passenger compartment. Under normal circumstances, it helps trap pollen, bacteria, dust and exhaust gases that may find their way into a vehicle's heating, ventilation and air-conditioning (HVAC) system, compromising interior air quality and damaging the system. Most cabin air filters are accessed through the panel in the HVAC housing, which may be under the hood or placed within the interior of the vehicle. A cabin air filter should not be cleaned and reinstalled. Instead, it should be replaced every 12,000 to 15,000 miles or per the owner's manual.

Expert Advice

"Air filters are your vehicle's first line of defense against contaminants that reduce cabin air quality and negatively impact engine performance," explained Rich White, executive director of the nonprofit Car Care Council.

The Car Care Council is the source of information for the "Be Car Care Aware" consumer education campaign promoting regular vehicle care, maintenance and repair.

plant.

Butterflies aren't physically able to carry as much pollen as bees can but their quick and graceful movements help them cover a larger land area, drinking nectar with their long tongues and pollinating plants along the way.

Beware of skimmers on self-checkout terminals at grocery stores, gasoline pumps, and other places where you might swipe your credit or debit card.

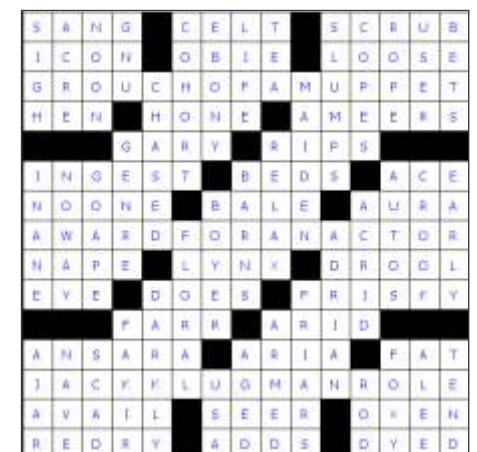
