We are closing in on the finish line of the 2017 Legislative Session. We have worked this session to better our state and its residents, and to protect faith, family, freedom, and opportunity.

This session, The Florida Senate passed Senate Bill 10, authorizing a significant increase in southern water storage to further the goal of reducing, and eventually eliminating, harmful discharges from Lake Okeechobee. This bill dramatically expands southern storage by leveraging existing water infrastructure, and utilizing a combination of state, local, and private land, in a manner that respects the interests of the agricultural community and private landowners.

We also passed Senate Bill 374, the College Competitiveness Act of 2017. This legislation will further elevate Florida's nationally ranked community colleges through a renewed focus on their core mission, which is promoting on-time completion of vital associate degrees and workforce credentials that prepare students for jobs in communities across our state.

Additionally, the Senate unanimously passed Senate Bill 78, Public School Recess. The legislation requires each district school board to provide at least 100

minutes of supervised, safe, and unstructured free-play recess each week for students in kindergarten through 5th grade. Such recess must involve at least 20 consecutive minutes of free-play per day in the public elementary school setting. Senate Bill 78 ensures that recess time is kept separate from standard physical education course time.

We will continue to work hard for the good people of Florida. We will land the plane and ensure that all Floridians are cared for and protected.

you have public and political advantage at that point, as you can see the Constitutional law is no longer effective. They can ruin a career in a heartbeat.

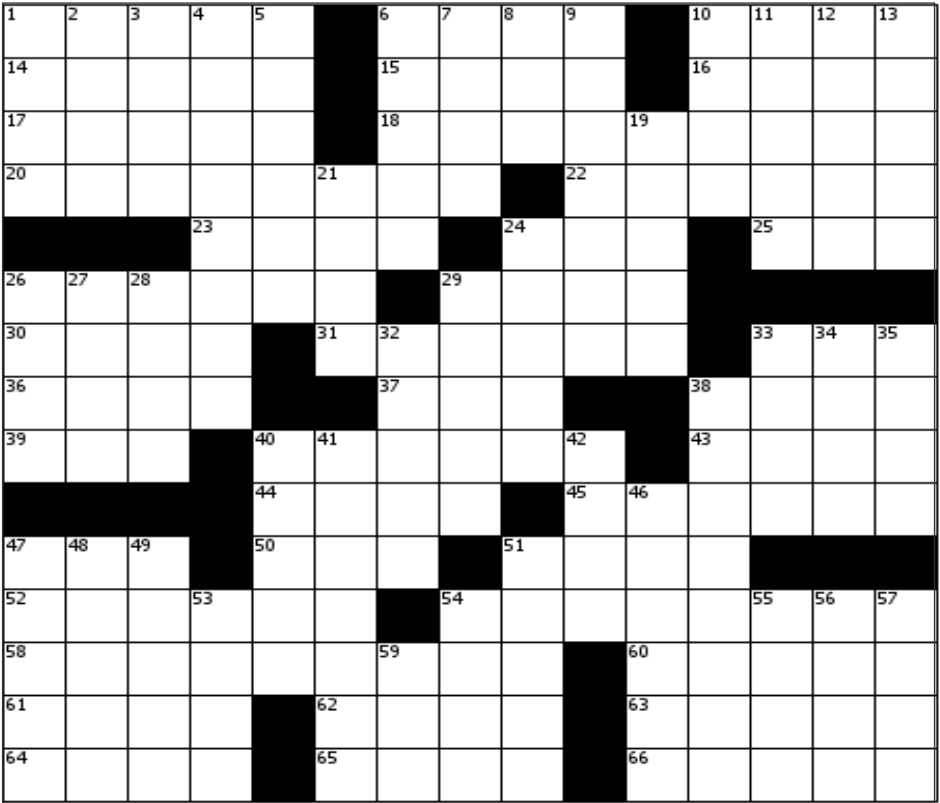
The Governor is now using the local State Attorney's office as hatchet men to prosecute 21 cases from another area.

#### Move Over And Make Way For Emergency Vehicles



Have you ever approached an intersection and heard a siren? Perhaps you have looked in your rearview mirror and saw flashing lights behind you. Chances are that you have passed an emergency

worker or a law enforcement officer who pulled off the roadway with his or her lights flashing. You should be aware that in Florida the law requires that you move over, make way and slow down when approaching all emergency and law enforcement vehicles

stopped on the roadway. The law, known as the Move Over Act, is designed to protect law enforcement officers, firefighters and other emergency workers from needless, accidental tragedy.

After 40 years in law enforcement and public safety, I have learned that driving, especially when responding to calls for service, is the most hazardous duty performed by law enforcement officers, firefighters and emergency service professionals. Many fatalities and injuries to emergency service workers could have been avoided had the driver simply slowed down and moved over.

The Lady Lake Police Department strictly enforces the Move Over Law to help keep

you and all public safety professionals safe. While on the roadway, please be alert, pay attention and remember the following:

- If an emergency vehicle is approaching from behind, put on your turn signal, yield to the right-of-way, slow down or pull over. Once the emergency vehicle has passed, use your turn signal and carefully re-enter the roadway.
- On a two-lane roadway, you are required to slow to a speed that is 20 miles per hour less than the posted speed limit. If the speed limit is 20 miles per hour or less, you must slow down to five miles per hour.
- If you are driving on an interstate or roadway with multiple lanes of travel in the same direction and you approach an emergency or law enforcement vehicle parked along the roadway, you must vacate the lane closest to that vehicle as soon as it is safe to do so.
- When arriving at an intersection where

an emergency vehicle is approaching from the cross street, come to a complete stop and wait until all emergency vehicles have safely passed before continuing.

If you are a driver who violates the Move Over Law, you can be charged with a moving violation, which results in a fine and points on your license. More importantly, by violating this important law, you would be putting both yourself and a dedicated "first responder" at risk.

On behalf of the men and women of the Lady Lake Police Department, I urge you to help protect those who are sworn to serve and protect you. Always remember to make way, slow down and MOVE OVER when approaching an emergency or law enforcement vehicle - it's the law.

### What Else You Can Do

Here are five more tips to help your garden grow:

**1. When you're dealing with Mother Nature, remember Father Time.** Plant as early and as late in the season as you can with the help of row covers, cold frames, tunnels and similar devices.

**2. Go for perennials—let your crops plant themselves.** Plants that come back

year after year save time and maintenance, usually limited to annual weeding, fertilizing and mulching.

**3. Resist rows.** According to Colorado State University, you can quadruple per-square-foot production of many vegetables such as lettuce, carrots and beets by planting them in blocks within wide beds rather than in rows. Block planting makes efficient use of space by keeping the spacing between plants tight and eliminating unnecessary pathways.

**4. Be bright about bulbs.** Keep the local wildlife from dining on your daffodils and onions by staking netting over the bed. Cut holes in the cloth to let the plants grow through.

## Eight Tips For Hiring A Quality Contractor

### For Your Next Digging Project

(NAPS)—An excellent way to celebrate the season is with an outdoor home improvement project: a pool, perhaps, or professional landscaping.

Many such home improvements, including planting trees, involve some type of digging. Selecting a quality contractor will help ensure workers follow proper digging practices while completing the project safely, on time and on budget.

### What To Look For

Here are eight tips to help you select the right professional:

- **Verify that safety is the contractor's top priority.** Because many outdoor home improvement projects involve digging, confirm the contractor will follow the practice of calling 811 at least 48 hours before breaking ground. In some places,

such as the state of Ohio, it's the law, and utilities—including Columbia Gas—will send personnel to mark line locations at no cost. “We urge our contractors to always call 811 to keep everyone safe,” said Sandy Munley, executive director, Ohio Landscape Association. “Workers and homeowners should never assume they know where gas and other utility lines are located.”

- **Consider a specialist for your type of project.** Contractor specialists have the knowledge, equipment and tools for certain projects. You'll want a pool contractor, for example, to build the inground pool with vinyl liner. You'll want a concrete professional to install that winding walkway. Contractor specialists are listed online or you can contact professional associations such as the

Better Business Bureau.

- **Request and check references thoroughly.** Family, friends and other businesses can provide contractor names. When contacting contractors, ask each to supply at least three references—and then call those people. Ask questions. Was the contractor on time and on budget? Were you pleased with the results? Request photos or visit completed jobs.
- **Confirm the contractor is licensed, bonded and insured.** A contractor should provide copies of current licenses and insurance certificates—make sure all workers are bonded and insured. Personal liability, worker's compensation and property damage insurance protect you from liability in the event of injuries or accidents.
- **Ask if the contractor will handle trash removal.** You may have containers, wood, plants and other debris that must be hauled from your property. Verify the contractor will manage this task and will include a dumpster or other trash removal costs in the estimate.
- **Select a contractor who'll commit to a timeline.** It should include when work will begin, when materials will arrive and when most of the work will be completed. Include extra time for unexpected problems or delays.
- **Realize you get what you pay for.** Cheaper isn't always better and, in most instances, you should stay away from the contractor with the lowest bid. Instead, know your needs and prioritize what's most important. You may be able to remove less significant frills to keep your project within budget.



- **Avoid contractors requiring more than 30 percent up front.** Instead, work with one who lets you establish a payment schedule that follows the project's progress. Make the final payment after you thoroughly inspect the finished project and are completely satisfied with the results.

“A professionally designed and installed landscaping project will provide years of enjoyment for you and your family,” Munley said. “Additionally, the project can increase the value of your home while improving curb appeal.”

# Understanding Head And Neck Cancers



(NAPS)—According to the Centers for Disease Control and Prevention, some 42,000 Americans develop head and neck cancers every year. Here's a look at one of them:

## Lewis' Story

Lewis was a busy man. He and his wife, Amy, were running an aerobic exercise group in their community and also volunteering throughout the north Florida area. On a hot and dry day in June of 2011, when the air was filled with smoke from nearby wildfires, Lewis came home from tennis coughing and clearing his throat. He also had sores in his mouth, so he decided to go to his doctor.

"The doctor looked at my tonsil and told me, 'That's either the worst case of tonsillitis I've ever seen in an adult...or it's something else,'" Lewis says. The doctor recommended more testing. After the tests, Lewis was told that it was a malignant (cancerous) tumor.

"When you hear the word 'cancer,' your world changes in an instant," says Lewis.

More testing showed that it was an advanced stage of cancer—Stage IV—and to have surgery on it would require breaking his jawbone and taking out a lot of tissue, permanently changing his appearance and ability to swallow and eat. Oncologists told him that there was just as good a chance that the tumor would shrink with radiation and chemotherapy as it would with surgery. Lewis had seven chemotherapy treatments and 35 radiation treatments over the course of the next seven weeks. By the end of treatment, he could no longer swallow and had to use a feeding tube. But the tumor had shrunk to the point that doctors could no longer detect cancer.

Out of a sense of gratitude for all the help they got, Lewis and Amy decided to start a support group for people with head and neck cancers. They contacted a national organization and got the materials to start a chapter where they live. Lewis and Amy handed out flyers to local doctors' offices and hospitals. At the first meeting, six people showed up—including some they already knew but had no idea were dealing with head and neck cancers. Now, meeting attendance

ranges from 25 to 45 people.

Then, in December of 2015, Lewis found a sore on his tongue that wouldn't go away, even with steroid treatment. His oncologist did a biopsy and found another tumor. He was scheduled for surgery right away, because he was told that he was not a good candidate for more radiation, as he'd had very high doses during the last round four years before. Additional oncologists who reviewed his case thought he might lose his tongue and part of his jaw. But a biopsy after surgery showed no cancer cells remaining on his tongue.

"I still have a high risk of the cancer coming back but I'm still going to live my life," Lewis says.


He recommends that if someone is diagnosed with a head or neck cancer, he or she should listen to the doctors very closely—and carry a notebook to write down details about treatment. He and Amy also say that support groups help both the person diagnosed and the caregiver.

## Cancer Causes

## Get the Better of GERD



(NAPS)—Gastroesophageal reflux disease, or GERD, is abnormally frequent or chronic acid reflux. Acid reflux occurs when stomach fluid backs up, or refluxes, into the esophagus, exposing it to gastric acid and other contents. While occasional reflux is normal, for some, it can be frequent and severe enough to affect daily life.

In fact, it's estimated GERD causes pain for over 80 million Americans at least once a month.<sup>1</sup> Left untreated, GERD can lead to

serious complications, such as changes to the esophageal structure, known as Barrett's esophagus, and even cancer. However, the good news is you don't have to put up with this burden.

### What To Do

Treatment varies depending on the severity of symptoms, and you should always consult a health care professional. GERD is a chronic condition, because the valve is not mechanically functioning—it needs a repair, not a temporary fix from an antacid or proton pump inhibitor (PPI) pills.

For mild GERD sufferers, simple dietary and lifestyle changes may be enough to provide some relief. These can include avoiding foods that trigger symptoms, such as coffee, tea and carbonated beverages; fatty, fried or spicy foods; and citrus fruits,

tomatoes, garlic, onions, peppermint and chocolate. You may also eat smaller meals more often to avoid pressure on the valve between the stomach and the esophagus. Recommended lifestyle changes include watching your weight and avoiding lying down within three hours of eating. When you do go to sleep, raise the head of your bed six to eight inches. Don't smoke. Don't drink alcohol and do wear loose clothes. More tips are available at [www.GERDhelp.com](http://www.GERDhelp.com).

If that doesn't do the trick, you may have to turn to anti-reflux surgery to rebuild the barrier between the esophagus and the stomach. A gastroenterologist can see if you're a candidate for a minimally invasive, incisionless medical procedure that is not major stomach surgery. The Transoral Incisionless Fundoplication—TIF® procedure—treats the underlying anatomical cause of GERD by reconstructing the valve between the

esophagus and the stomach to restore the body's natural protection against reflux. This eliminates both the acidic symptoms of reflux, such as heartburn and sore throat, and the non-acid, atypical symptoms, such as asthma, chronic cough and regurgitation.

“Due to its unique approach, most GERD patients who receive the TIF procedure are less likely to experience long-term side effects commonly associated with traditional anti-reflux surgery, such as trouble swallowing, bloating and gas, and are able to return to normal day activities within a few days post-procedure,” said Dr. Anthony Starnoli, associate director of esophageal endotherapy at Lenox Hill Hospital, New York City.

Since the TIF procedure is performed through the mouth with no abdominal incisions, patients typically return to work in less than one week. Recently published data showed at the three-year post-procedure check-up that:

- 71 percent of patients completely stopped taking their PPIs,
- 90 percent of patients experienced a reduction of troublesome regurgitation,
- And 88 percent of patients maintained elimination of all daily atypical symptoms.<sup>1</sup>

“Most importantly, these positive outcomes are a strong indicator of the TIF procedure's safety and durability, providing patients who no longer benefit from PPI therapy an effective alternative treatment option from chronic GERD symptoms,” adds Dr. Lauren Gerson, director of clinical research, Gastroenterology Fellowship Program at California Pacific Medical Center.

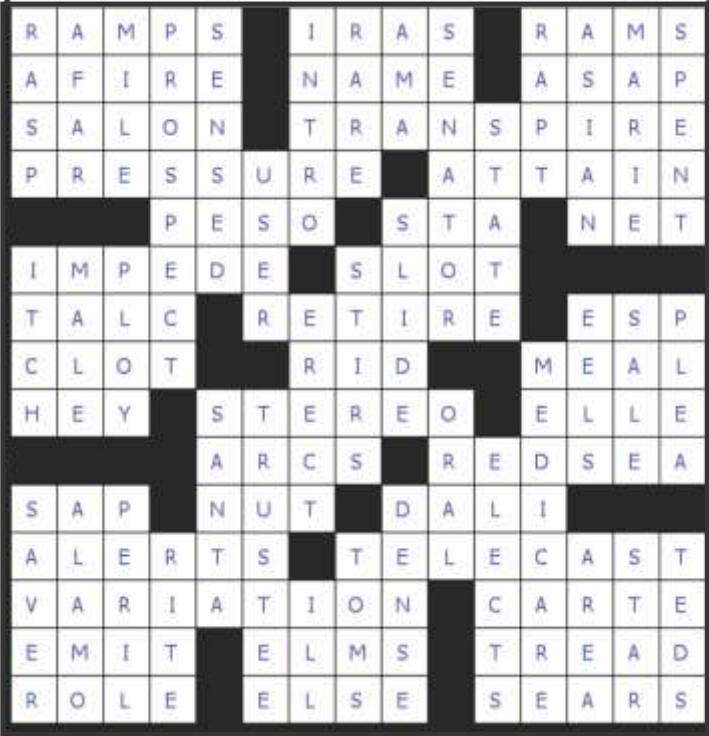
