patterns over time. Just like learning to ride a bike or play a musical instrument, initially challenging movements evolve into seamless actions with consistent practice.

Unfortunately, aging often leads to a gradual decline in strength, power, and muscle mass, potentially compromising the ability to perform these fundamental movement patterns. What was once effortless, such as ascending stairs gracefully like Fred Astaire, can transform into a struggle akin to Quasimodo ascending the bell tower. Hence, it becomes paramount for seniors to adhere to the Law of Specificity and prioritize exercises focusing on the Magnificent 7.

In practical terms, this means replacing isolated exercises like leg lifts or bicep curls with compound movements such as squats and push-ups. Rather than relying solely on stationary equipment like an exercise bike, opt for activities like walking or running that engage multiple muscle groups and mimic real-world movements. The bulk of your exercise regimen — around 90% should revolve around mastering the Magnificent 7, with supplementary exercises added as needed.

Years later we would make friends and my wife and I would invite them to live on the Loury Farm. They did for many years and learned I was not so bad.....

Mean while In about six months there was another demand for a 32 hour work week. I stood up against the union and it did get a little rough near the end of it all. I refused to strike and I gave notice. The company was in it's fifth year of their tax deal with the city. The company ask me to stay, I was getting stale at that job. It was time for me to move on.

I had a job in two days, there was a demand for pressman in the area. I went to the Hollywood Sun Tattler in composition as a trainee. I wanted to go through all the apprenticeships that I could to learn the whole business.

I ran into a co-worker from Chestnut Hill Industries and she told me she unemployed, she explained what happened was the company facing the no tax deal ending with the city and a 32 hour work week they went to their own mail room and mailed all of their high end garments to their warehouses to Boston and went bankrupt.

employees were out of work. Chestnut Hill took their loss losing out of date garments and moved back up north where most of their interest was anyway. They each had their own factory's and ended the experiment of incorporating all of their factory efforts.

So Bernie Sanders is wrong, but he has no example to check it to. He has never run a business he just wants to run everyone else's business!

So that is my story about my 32 hour work week experience. TomL said that! Maybe next month we can talk about my union membership or the lack there of at the Hollywood Suntattler. Tilll next

First of all, the IRS budget for 2023 was over 12 billion dollars with a request for over 14 billion dollars for 2024. That's a lot of tax dollars. One would hope that IRS employees are being well vetted and are

using secure networks but unfortunately that is not always the case. Some agents even after being fired for violations can be rehired due to union contract stipulations. Some agents are also working remotely from their own home computers without benefit of secure networks leaving your financial information vulnerable to hacking. There were nearly 180 million tax return filed in 2021. Under the FAIRtax, there is no need for the IRS to even exist as there total function is to administer to the collection of income taxes. Since the states will be doing the collecting for the FAIRtax, only a small section of the Treasury Department is needed to collect the taxes from each state. 



# Oral Health



#### Vitamins and Minerals: Fortifying Against Poor Oral Health

(NAPSI)—Practicing basic oral hygiene, such as brushing, flossing, and going to regular checkups with a dental professional are some of the most important ways to maintain oral health. However, if these practices are not paired with proper nutrition, oral health can still suffer.

Mindfully incorporating foods that are good for oral health can also contribute to overall wellbeing. Certain vitamins and minerals are particularly beneficial for teeth and gums. Many people take dietary supplements to improve their health or fill gaps in their diet. Supplements can also be a viable alternative for people with dietary restrictions or allergies.

#### Best vitamins and minerals for oral health and where to eat them

Calcium strengthens enamel, which is the hard outer layer of teeth. It is widely known that cheese, low-sugar yogurt, and other dairy products contain calcium, but many seeds, beans, lentils, and leafy greens are also rich sources.

Phosphorous works with calcium to build strong teeth, as well as bones. Meats like chicken, turkey, and seafood are good sources of phosphorus. Sunflower and pumpkin seeds and whole grains are rich in this mineral, too.

Iron is a mineral used in the production of hemoglobin and having an iron deficiency can lead to harmful consequences for the body. Teeth are no exception. Eggs, beans, meat, poultry, fish, and whole grains all contain iron.

Vitamin C helps to synthesize collagen in the mouth. Eating foods containing vitamin C help strengthen teeth and protect against gingivitis, an early form of gum disease. Citrus fruits, such as oranges, strawberries, and bell peppers, are some of the best sources of vitamin C. When taking vitamin C as a supplement, it is best to avoid liquid or gummies as they can erode enamel.

Vitamin K, and more specifically vitamin K2, helps re-mineralize tooth structure. Leafy greens such as spinach, and cruciferous vegetables such as broccoli, Brussels sprouts, and kale contain vitamins K and C, as well as phosphorous.

Vitamin B, and B12 in particular, helps the body absorb calcium. It is found in many animal proteins and some fortified cereals. For those who do not eat meat or have dietary restrictions, B-complex vitamin supplements are available in place of animal

Vitamin D, like phosphorous, helps the body absorb calcium. Few foods naturally contain vitamin D, the exceptions being fatty fish, egg yolks, and some species of mushrooms. Spending time in the sunlight and taking vitamin D supplements are proven ways to increase levels of vitamin D in the body.

#### Eating thoughtfully to support oral health

According to Dr. Greg Theis, Vice President, Dental Services at <u>Delta Dental</u> of Wisconsin, "Dietary choices play an important role in overall oral health, just like brushing or flossing daily. Taking care to eat foods that are rich in essential vitamins and minerals is an important step in keeping teeth strong and healthy.'

Ultimately, eating a vitamin- and mineralrich diet not only promotes overall wellbeing, but directly affects oral health. Taking supplements to compensate for nutritional gaps is a great way to maintain appropriate levels of crucial vitamins.



#### **Who Gets Hurt**

Older Americans are prime targets because they possess most of the nation's individual wealth. People who live on fixed incomes from Social Security and small pensions are especially vulnerable, as they frequently need supplemental sources of income to make ends meet, or are motivated to help younger family members seek out extra funds.

They may be manipulated into believing phony investment offers at a rate disproportionate to the rest of the population. Scammers know some older adults can be more easily disarmed by their convincing messages. These Americans may have difficulty discerning a fraudulent promotion from a legitimate one. It might be alarming to discover how vulnerable an older friend or loved one can be. It's important for family members and friends to understand why older adults are at risk and what steps can be taken to minimize the chance they'll be taken advantage of by fraudsters.

#### Some Scams

Every year, thousands lose between a few dollars and their entire life savings to fraudsters. Even the most experienced investors can be caught up in an investment scam. A perfect example of this is the number of professional money managers who placed their clients' money with Bernie Madoff. And that's just one example.

In a case investigated by Postal Inspectors, a con artist acting as the CEO of an investment firm defrauded investors out of more than \$4 million through a purported financial services firm he controlled. He lied to investors about how much money had been raised, who had invested, how close the firm was to an IPO (initial public offering),

and how he would use investors' money. The scammer appropriated most of the money for his own use or to pay off investors in a Ponzi-like fashion. He was sentenced to prison for his crimes.

Another man was sentenced to four years in prison for his role in two high-yield investment fraud schemes. Postal Inspectors said he and his co-conspirators defrauded vulnerable victims out of millions of dollars. The scammers have been handed down sentences ranging up to 12 years in prison.

In another Postal Inspection Service investigation, a real estate investment scammer defrauded numerous investors who invested in more than a thousand real estate investment properties. The real estate scammer convinced investors by misrepresenting returns, promoting fraudulent information and over-inflating appraisals. He was convicted and sentenced to 10 years in prison and ordered to pay \$17 million in restitution.

#### **Some Solutions**

So, what do you do to protect yourself from these scammers who try to separate you from your hard-earned money?

Education and information are your best defenses against investment fraud. Postal Inspectors urge potential investors to independently research registration of investment firms and be extremely cautious about unsolicited offers to invest through social media or the internet. Think about these things before jumping into an investment:

Anyone can be anyone on the internet. Scammers spoof websites and use fake social media accounts to obscure their identities. You can identify phony accounts by looking closely at content. Pay careful attention to domain names.

Take your time in deciding to

Get all information in writing before you consider investing.

Beware of unsolicited offers and fake client reviews. Scammers often reference or publish positive, yet bogus testimonials purportedly drafted by satisfied customers.

If it sounds too good to be true, it probably is. Be careful of claims that an investment will make "incredible gains," is a "breakout stock pick," or has "huge upside and almost no risk!" "Guaranteed returns" aren't. All investments carry some degree of risk, and the potential profits are typically correlated with the degree of risk.

Rep. Cammack's Organ Transplant Discrimination Prevention Act Passes Through Subcommittee Markup

Congresswoman Kat Cammack's Charlotte Woodward Organ Transplant Discrimination Prevention Act (H.R. 2706) passed the House Energy & Commerce Committee's Health Subcommittee markup by voice vote this afternoon.

The bill is named for Charlotte Woodward, an adult with Down syndrome who received a lifesaving transplant over a decade ago. It prohibits discrimination against people with disabilities in the organ transplant system and upholds, clarifies, and builds upon rights established in the 1990 Americans with Disabilities Act.

Additionally, the bill prohibits covered entities from determining than an individual is ineligible to receive a transplant, deny an organ transplant or related service, refuse to refer the individual to an organ transplant center, refuse to place an individual on a waiting list, or decline insurance coverage for a transplant or related service based solely on the fact that the individual has a disability.

The bill's next step is to be marked up before the whole House Energy & Commerce Committee.

## Coverage for Obesity



## Coverage for Obesity Care is Only Fair

(NewsUSA) - Obesity is an increasingly significant health problem in the United States, especially for women. The disease affects 1 in 3 American women, including 57% of Black women and 44% of Hispanic women.

Although obesity is a chronic, treatable condition, obesity care is not covered by health insurance like other chronic conditions such as heart disease or diabetes. As a chronic disease, it's only fair that people with obesity receive the same

coverage as other chronic conditions.

EveryBODY Covered, a new campaign led by the Alliance for Women's Health and Prevention (AWHP) in partnership with 15 other leading health organizations, is working to change this by empowering women to speak with their employers and elected officials about the need for comprehensive obesity care coverage.


Currently, less than half of employers cover or are considering covering the latest generation of anti-obesity medications. 'Healthcare professionals need to be able to provide the full range of obesity care options for their patients, and patients need access to that care," said Dr. Eliza Chin, Executive Director of the American Medical Women's Association. "Obesity deserves the same level of coverage as any other chronic disease."

The campaign argues that obesity is a women's health issue. Citing data from the National Institutes of Health which shows that women with obesity are more likely to have other chronic diseases, including breast cancer, fertility, and maternal health challenges. Women with obesity also are more likely to face stigma in their professional and personal lives. In fact, women affected by obesity earn as much as 12% less than female peers not affected by obesity.

"Women's health and obesity are linked," says Millicent Gorham, CEO of AWHP, "If

TALLAHASSEE, Fla.—Attorney General Ashley Moody filed an amicus brief in the United States Court of Appeals for the Ninth Circuit in support of <u>Intervenor States</u> seeking to keep the Biden administration from using shadowy gamesmanship to manipulate the president's most vulnerable political liability in an election year: the border crisis. The Biden administration, on multiple occasions, used these tactics in an attempt to provide cover from his historical outright failure to protect the sovereignty of the nation. In this case, the Biden administration appears to have abandoned its defense of the "Circumvention of Lawful Pathways" rule, a rule that allows the Department of Homeland Security to turn away some asylum seekers, seeking instead a settlement agreement with proillegal immigration organizations, such as the East Bay Sanctuary Covenant, an immigration-services nonprofit based in California.

Attorney General Ashley Moody said, "This administration has repeatedly shown that it cannot be trusted, especially as it relates to defending the sovereignty of our nation and safety of our citizens. This president has turned every state in the country into a border state by allowing millions of unvetted and undocumented aliens into the interior. States have a right to be party to any settlement negotiations that will dictate border policy because we have an interest in protecting the safety of our citizens and the resources of our communities.'

Following a 2023 challenge and subsequent <u>vacatur</u> of the Circumvention of Lawful Pathways rule, the Biden administration appealed the decision to the United States Court of Appeals for the Ninth District arguing the rule was absolutely necessary, and "any interruption in the rule's implementation will result in another surge in migration that will significantly disrupt and tax DHS operations." Until just recently, the administration asked the court to delay further litigation pending a settlement negotiation.

Flanked by Volusia County first responders, Attorney General Moody also announced that the Volusia County Sheriff's Office, the police departments of Daytona Beach, Deland, Ormond Beach, Ponce-Inlet and South Daytona, as well as the Volusia County Beach Safety Ocean Rescue team, are now participating in Attorney General Moody's Helping Heroes program. The program provides free access to life-saving naloxone for first responders.

Attorney General Ashley Moody said, "Every year, millions of visitors come to enjoy our beautiful beaches for spring break. While this is an exciting time of year for students looking for a break from the college grind, law enforcement and first responders are on heightened alert due to the national drug overdose crisis, largely driven by illicit fentanyl. Standing with law enforcement leaders today in Daytona Beach, we are warning spring breakers to never use illicit drugs, as just one pill can kill. I'm also excited to announce that Volusia County first responders now have access to free, life-saving naloxone through our Helping Heroes program—another tool in their belt to protect Floridians and visitors alike." AG MOODY'S STATEWIDE PROSECUTORS CHARGE COUPLE OPERATING MASSIVE HUMAN TRAFFICKING RING INVOLVING MORE THAN 30 VICTIMS

ALLAHASSEE, Fla.—Attorney General Ashley Moody's Office of Statewide Prosecution is charging a Florida couple with human trafficking, RICO, sexual battery, money laundering and other serious counts for operating a massive trafficking ring. According to a Homeland Security investigation, Marquett James and Alvson Marquett recruited and forced victims to engage in commercial sex work in various locations in Florida and across the country.

The HSI investigation uncovered James and Marquett used violence against women who attempted to leave the operation. The investigation also uncovered victims branded with tattoos, including James' name. Authorities believe more than 32 victims are involved in this ring.

Attorney General Ashley Moody said, "Through coercion and violence, a Florida couple operated a massive human trafficking ring that victimized more than 30 women. The couple branded these women with tattoos, took control of their finances,

sex acts. Working with law enforcement we shut down this human trafficking ring and rescued victims."

According to the HSI investigation, James and Marquett worked together to operate a trafficking ring, in which James served as the main trafficker and Marquett assisted in several aspects of the operation. On multiple occasions, both James and Marquett used similar threats of abuse and intimidation to force victims into sex work. The investigation revealed that James recruited victims working at nightclubs. The defendants advertised the women's services online and scheduled the victims' dates with other men. After the dates, the defendants took the proceeds. One victim did not have a personal bank account. James took all the funds for the illicit services.

The investigation also uncovered that James opened multiple corporations to attempt to hide the illicit activity when arranging advertising or travel for the victims.

James and Marquett are each charged with human trafficking, conspiracy to commit human trafficking, RICO and conspiracy to commit RICO, sexual battery and money laundering, among other felony charges.

Attorney General Moody's Office of Statewide Prosecution will handle the case.

> "Corneal cross-linking is an effective treatment for stabilizing cornea rigidity to preserve vision and spare patients with KC from possibly having to undergo cornea transplantation," said Dr. Clark Chang, an optometrist at Wills Eye Hospital in Philadelphia. "The WiseEves campaign was created with diagnosed KC patients in mind to provide a clear understanding of what to expect from the FDA-approved treatment and to allay any fears."

ORLANDO, Fla. — Today, Governor Ron DeSantis signed HB 621, which protects

property rights, provides homeowners remedies against squatting, and increases penalties on squatters.

'We are putting an end to the squatters scam in Florida," said Governor Ron DeSantis. "While other states are siding with the squatters, we are protecting property owners and punishing criminals looking to game the system."

"Florida is once again leading the nation, this time in securing our state against squatters," said Attorney General Ashley Moody. "Biden has allowed millions of illegal immigrants to flood across the border. After video evidence of their plan to take over homes emerged, we're ensuring Floridians are protected from this egregious and brazen scheme. I'm grateful to Governor DeSantis for signing this important legislation into law, and to Representative Kevin Steele for carrying this bill through Session."

Under HB 621, a property owner can request law enforcement to immediately remove a squatter from their property if the following conditions are met:

- The individual has unlawfully entered and remains on the property;
- The individual has been directed to leave the property by the owner but has not done so: and
- The individual is not a current or former tenant in a legal dispute.

In Florida, it will be quick and simple to reclaim your home from squatters, avoiding costly delays, litigation, and missed rents.

HB 621 also creates harsh penalties for those engaged in squatting and for those who encourage squatting and teach others the scam. The bill makes it:

A first-degree misdemeanor for making a false statement in writing to

A second-degree felony for any person who unlawfully occupies or trespasses in a residential dwelling and who intentionally causes \$1,000 or more in ATTN: Space Art Contest damages; and

Governor DeSantis Takes Further Action to Address Illegal <u>Immigration and Criminal Activity</u> in Florida

TALLAHASSEE, Fla.— Governor Ron DeSantis signed three bills to combat illegal immigration in Florida. These bills also continue Florida's efforts to maintain law and order and take proactive measures against illegal aliens who engage in criminal activity.

"The federal government has failed in its responsibility to secure our southern border, leaving states to fend for themselves," said Governor Ron DeSantis. "In Florida, we do not tolerate illegal immigration, let alone lawlessness committed by illegal aliens who shouldn't be here in the first place. The bills I signed today further enhance Florida's capabilities to uphold the law."

Under the leadership of Governor Ron DeSantis, Florida has provided a blueprint for other states to protect their citizens against illegal immigration," said Lieutenant Governor Jeanette Nuñez. 'Our administration will not stand on the sidelines and watch as the Biden Border Crisis continues to spiral out of control. I'm proud to serve alongside Governor DeSantis as we take action to protect Floridians in every corner of our state."

Ever since President Biden was sworn in, his administration has taken systematic steps to dismantle our country's public safety immigration laws," said Attorney General Ashley Moody. "I am grateful that here in Florida, we have leaders who will step up to keep Floridians safe. Thanks to Governor DeSantis and our lawmakers. those here illegally committing crimes will face harsh penalties and we will continue to build a stronger, safer Florida."

Governor Ron DeSantis signed the following bills into law:

- SB 1036, which enhances penalties for a crime committed by an individual who returns to the country illegally after an initial deportation.
- A third-degree felony (up to 5 years in prison) after deportation will be charged as a second-degree felony (up to 15 years in prison).
- A second-degree felony (up to 15 years in prison) after deportation will be charged as a first-degree felony (up to 30 years in prison).
- A first-degree felony (up to 30 years in prison) after deportation will be charged as a life felony
  - SB 1036 also enhances penalties for

crimes committed in furtherance of drug

- HB 1451, which prevents counties and municipalities from accepting ID cards issued to illegal aliens by other jurisdictions.
- Florida already prohibits local jurisdictions from issuing IDs or driver licenses to illegal immigrants.
- HB 1589, which increases penalties on individuals who operate a vehicle without a license.
- Increases the maximum sentence from 60 days in jail to one year in jail for two or more offenses, and a minimum mandatory sentence of ten days in jail for three or more

Additionally, Governor DeSantis applauded the Legislature for passing Senate Memorial 1020, which urges the United States Secretary of State to designate the drug cartels which operate at our southern border as Foreign Terrorist Organizations.



## Sausage Pizza w/ Spinach Salad

1 pound pizza dough, at room temperature All-purpose flour, for dusting

1 tablespoon extra-virgin olive oil

1/2 pound sweet Italian sausage, casings removed

3/4 cup whole-milk ricotta cheese

1/2 cup shredded mozzarella cheese 1/2 cup shredded provolone cheese 1/3 cup grated parmesan cheese

2 cloves garlic, minced

1/4 teaspoon dried oregano

1/2 small red onion, thinly sliced

4 cups baby spinach (about 21/2 ounces)

small bulb fennel, trimmed, cored and thinly sliced

1/2 cup chopped roasted red peppers

3/4 cup quartered marinated artichoke hearts, drained and halved

1 tablespoon red wine vinegar Kosher salt and freshly ground pepper Red pepper flakes, for topping

#### **Directions**

Make the pizza: Place an inverted baking sheet or pizza stone on the lowest oven rack; preheat to 475 degrees F. Stretch the pizza dough into an 11-by-15-inch rectangle on a floured piece of parchment paper; trim any excess paper around the dough. Transfer the dough (on the parchment) to a pizza peel or another inverted baking sheet and slide the dough and parchment onto the hot baking sheet. Bake until browned in spots, 10 to 12

Meanwhile, heat the olive oil in a medium

skillet over medium-high heat. Add the sausage and cook, breaking it up into pieces with a wooden spoon, until no longer pink, about 4 minutes.

Remove the crust from the oven. Spread the ricotta on top, leaving a 1-inch border. Sprinkle with the mozzarella, provolone and parmesan; top with the sausage and garlic. Return the pizza to the oven and bake until the cheese is bubbling, 8 to 10 minutes. Sprinkle with the oregano.

Meanwhile, make the salad: Soak the red onion in ice water for 10 minutes, then drain. Toss the spinach, fennel, roasted red peppers, artichoke hearts and red onion in a large bowl with the vinegar and olive oil; season with salt and pepper.

Top the pizza with the salad and cut into pieces. Sprinkle with red pepper flakes.
