Keep Lab-Grown Meat Out of Florida

to prohibit the sale of lab-grown meat in the state of Florida. Florida is taking action to stop the World Economic Forum's goal of forcing the world to eat lab-grown meat and insects, "an overlooked source of protein." While the World Economic Forum is telling the world to forgo meat consumption, Florida is increasing meat production, and encouraging residents to continue to consume and enjoy 100% real Florida beef.

'Today, Florida is fighting back against the global elite's plan to force the world to eat meat grown in a petri dish or bugs to achieve their authoritarian goals," said Governor Ron DeSantis. administration will continue to focus on investing in our local farmers and ranchers, and we will save our beef.'

"Florida is taking a tremendous step in the right direction by signing first-in-the-nation legislation banning lab-grown meat. Honoring Deputy Vial of Life Israel Hughes



Law Enforcement Memorial-**Honoring Deputy Israel Hughes**

Lake County Deputy Israel Hughes worked for the Sheriff's office for seven vears and was a resident of Lake County. Deputy Hughes lost his life in the line of duty while he was investigating an illegal moonshine still in Altoona when he was ambushed and shot. Deputy Hughes died the evening he was shot on April 1, 1925, after being transported to his residence. Upon learning of this historical information, the LCSO Casualty Assistance Team began working to ensure that Deputy Hughes was properly honored for his service and sacrifice. Team members met with surviving family members to gather as much historical family knowledge as possible. The team also researched old newspaper articles, visited Deputy Hughes' gravesite in the Ponceannah Cemetery in Paisley, and gathered any remaining official records that still existed.

In remembrance of Deputy Hughes and his sacrifices, he will be honored at the Lake County Law Enforcement Memorial in Tavares on May 7, 2024, at 9 a.m. Many of the surviving family members will be in attendance. In addition, he will be recognized by the National Law Enforcement Officers Memorial in Washington, DC, during National Police Week for the first time since the Lake County Sheriff's Office received this historical information. The LCSO Casualty Assistance Team members and the LCSO Honor Guard will accompany the family members to the National Law Enforcement Officers Memorial.

The Vial of Life Program is a free program designed for seniors and individuals with a medical condition to provide pertinent medical information to emergency personnel who respond to and treat home emergencies. The Vial of Life contains much of the medical history needed by the responding emergency personnel, such as existing medical condition, allergies, medication currently being taken, and emergency contact information.

HOWITWORKS:

Vial of Life participants complete a medical information form which is placed into a medicine vial. A "Vial of Life" sticker is placed on the vial which is then put in the participant's refrigerator in plain view. Another "Vial of Life" sticker is placed on the front door to alert emergency personnel that medical information is located inside of the refrigerator. In many cases, this information could prove invaluable to the

History of Memorial Day

As the American Civil War came to an end in 1865, communities across the U.S. honored fallen soldiers through local ceremonies at burial sites. On May 30, 1868, the first national ceremony of this kind took place on a day that would come to be known as Memorial Day — though at the time, it was called "Decoration Day."

A few weeks before the ceremony, John Logan, head of the Grand Army of the Republic, a Union veterans organization, issued a proclamation urging Americans to decorate Civil War soldiers' graves with springtime's "choicest" blooms. Logan stated that the May 30 commemoration would be "designated for the purpose of strewing with flowers or otherwise decorating the graves of comrades who died in defense of their country." About 5,000 people gathered at Arlington National Cemetery for the first official Decoration Continued page 4

FAIRTAX



In my previous article, I talked about w h a t S c o t t Rasmussen called the "elite 1%" and

how they crave power and control over the other 99% and how they oppose the FAIRtax for challenging that craving. With so many 1%ers in DC, how will the FAIRtax ever get passed? Although we will never stop trying to win over the federal political elite, we must also work on the state level.

Take Nebraska for example. EPIC, an acronym for "Eliminate Property, Income and Corporate Taxes", is a state level proposal to replace these taxes at all levels of state government in Nebraska with a FAIRtax style consumption tax. Let's look at this proposal:

- 1. EPIC proposes to eliminate property, income and corporate taxes. Inheritance taxes will be eliminated with the income tax. Corporate taxes refer to all business taxes. It proposes to replace the current state sales tax with a consumption tax on new goods and services at the retail level.
- 2. The proposed rate of 7.5% is based on a dynamic model constructed by the Beacon Hill Institute and has been praised by such luminaries as Stephen Moore, Distinguished Visiting Fellow, Institute for Economic Freedom, The Heritage Foundation.
- 3. The proposal is to replace the state sales tax, not local sales taxes. Local taxing authorities will have the ability to impose their own consumption tax. The rate is expected to be much lower than the current sales tax rate because they have much less

revenue to replace than on the state level.

- 4. Because the EPIC plan eliminates all business taxes, not only can Nebraska businesses expect to be the most competitive in the nation, Nebraska retailers can expect to win the so-called "border bleed" battle because their retail products will not have those business taxes hidden in their prices.
- 5. A retail consumption tax puts Nebraska State Government in the same pricing boat as Nebraska retailers. If they impose a tax too high, their net revenue will go down as shoppers go elsewhere. This puts a more effective cap on the cost of government than any plan driven by Nebraska legislators.



washed. When the chicken lays the egg it has a protective layer that when washed off can shorten the expiration time. Wash before cracking.

Cleveland Clinic. After all, some molds can make you sick or cause allergic reactions, so it's best to err on the side of safety on this one. If you start to notice your fruit is reaching its expiration date, pop it in the freezer to extend the shelf life and use the berries later on in smoothies or cooked desserts, says Norah Clark, a professional chef.

Ground Spices

While it's not a food-safety concern, using spices past their prime can mean your meals aren't as flavorful as they should be, Clark says.

"Some spices that lose flavor after expiration include ground cinnamon, paprika, and ground cumin," she says.

Clark recommends storing your spices in airtight containers away from heat and direct sunlight to keep them in their most flavorful state.

Sure, there's no stamped expiration date on the container you take home from a restaurant. But, if you go out to eat over the weekend and pack your restaurant leftovers for a mid-week lunch, you could make yourself sick.

Since restaurant leftovers are at room temperature for a period of time while you drive back home, bacteria can grow on it and

multiply, says dietitian Hannah Byrne, MS, RDN.

"While refrigeration can slow down the bacterial growth, it doesn't stop it completely," she says. "Plus, some restaurant leftovers have a variety of different food groups in them and they all have different expiration dates on them, so for safety it's best to consume them within three to four days."

The taste and texture also changes with leftovers, Byrne says, as they tend to become dry and lose their flavors.

FISH

If you pick up raw fish from your local store, you should first make sure it's being stored on a bed of ice that's not melting. If it's dry or mushy, it's probably old, and not safe to eat. Once you get it home, seafood should be stored in your fridge for just one or two days before you cook it or move it to the freezer, according to U.S. Food and Drug guidelines. If seafood spoils, you'll smell sour, fishy, or ammonia odors, which become stronger after cooking, and food safety officials recommend tossing the food.





TALLAHASSEE, Fla.—Attorney General Ashley Moody's Medicaid Fraud Control Unit announced the arrest of the owner of a home health services agency and a parent of a disabled child for Medicaid provider fraud. Latrena Marie Thomas is the owner of A River's Journey, a home health care agency with residential home care facilities located in Yulee and Jacksonville. Thomas is accused of hiring non-licensed individuals to provide handson personal care services to Medicaid recipients. In addition, Thomas paid Donald Ray Adams II, a parent of a disabled Medicaid recipient, to provide medically licensed care for his own child. In total, Thomas fraudulently billed Medicaid claims for 30 distinct medically needy Medicaid recipients, which caused a total loss of more than \$1.6 million.

Attorney General Ashley Moody said, "This fraudulent billing scheme not only defrauded the Florida Medicaid program out of more than \$1.6 million but did so at the expense of Medicaid-dependent recipients, one being a disabled child. In addition to manipulating the system for extra money, the hiring of unqualified and unlicensed medical staff resulted in poor treatment and medical emergencies for Medicaid patients. I'm grateful for our Medicaid Fraud Control Unit for putting a stop to this scheme."

According to the investigation, Thomas and the agency hired employees not licensed as certified nursing assistants or home-health aides to provide hands-on personal care to Medicaid recipients. Several of these unqualified employees would have failed the Level 2 background screening that is required by the Florida Agency for Health Care Administration. Thomas did not have a Director of Nursing on staff to provide oversight of the licensed practical nurses and other staff employed by A River's Journey. Thomas also falsified the agency's employee roster, progress notes, service logs and plan-of-care documents, and billed for a recipient's 24/7 nursing care while paying Adams. Thomas's negligent assignment of unqualified staff to recipients created three separate medical emergencies, including a trach tube dislodging, extreme sunburn and a delay in contacting Emergency Medical Services.

A River's Journey paid Adams for providing unsigned progress notes for his own child's care. Adams received payments in cash, gift cards and bank deposits from the agency. In total, Adams received \$7,320 for involvement in the scheme to defraud Medicaid.

Thomas faces one count of Medicaid provider fraud. \$50,000 or more: a firstdegree felony. Adams faces one count of Medicaid provider fraud, \$10,000 or less: a third-degree felony.

The Jacksonville Sheriff's Office arrested Thomas and the Clay County Sheriff's Office arrested Adams. Attorney General Moody's MFCU will prosecute the case through the State Attorney's Office for the Fourth Judicial Circuit.

ATTORNEY GENERAL MOODY ACTIVATES PRICE GOUGING HOTLINE FOR STATE OF EMERGENCY FOLLOWING NORTH **FLORIDATORNADOES**

TALLAHASSEE, Fla.—Attorney General Ashley Moody is activating Florida's Price Gouging Hotline following a state of emergency declaration for the North Florida tornadoes. The order follows Governor Ron DeSantis's state of emergency declaration covering Baker, Columbia, Gadsden, Hamilton, Jefferson, Lafayette, Leon, Liberty, Madison, Suwannee, Taylor and Wakulla counties.

The Price Gouging Hotline is now available to receive reports of extreme price increases on essential commodities. Florida's price gouging law only applies to items and services essential to getting ready for, or recovering from, a storm within the areas of a declared state of emergency.

Attorney General Ashley Moody said, "Early morning tornadoes and severe weather ripped through North Florida—causing major damage and widespread power outages. As emergency crews remove road debris and rush to restore power, it is vital that Floridians in hard hit areas heed the advice of local officials. Those consumers who are purchasing emergency supplies should report any incidences of suspected price gouging by calling 1(866) 9NO-SCAM or visiting MyFloridaLegal.com to file a complaint."

During a storm-related declared state of emergency, state law prohibits excessive increases in the price of essential commodities, such as equipment, food, gasoline, hotel rooms, ice, lumber and water needed as a direct result of the event.

Violators of the price gouging statute are subject to civil penalties of \$1,000 per violation and up to a total of \$25,000 for multiple violations committed in a single 24-hour period.

AG MOODY SHUTS DOWN FAKE WEBSITES SCAMMING SUNPASS

TALLAHASSEE, Fla.—Standing with the Florida Department of Law Enforcement and the Florida Department of Transportation at a toll plaza in Orlando today, Attorney General Ashley Moody issued a Consumer Alert warning Floridians about a concerning new smishing scam targeting drivers. The Federal Bureau of Investigation reports that scammers are sending fraudulent text messages to individuals claiming unpaid toll fees and providing links to settle the alleged debts. However, these links are malicious and designed to steal victims' money. These scams are also being seen targeting E-ZPass users. Attorney General Moody's Cyber Fraud Enforcement Unit, working with Mental Health FDLE, recently shut down 10 imposter

Attorney General Ashley Moody said, 'Cybercriminals are sending text messages to thousands of unsuspecting drivers in the hopes that some of them will be tricked into paying a toll fee for a violation that never occurred. While this smishing scam is happening across the nation, our Cyber Fraud Enforcement Unit worked closely with FDLE to shut down 10 fraudulent sites. designed to mimic the official SunPass website and steal payments from drivers who received their fake text messages."

Florida Department of Law Enforcement Deputy Commissioner Vaden Pollard said, "FDLE agents believe there could be hundreds of victims in Florida who received a fraudulent text message saying they owed money to SunPass. FDLE's Cyber Fraud Enforcement Unit was able to quickly seize the fraudulent websites, stopping the victimization. Thanks to Attorney General Ashley Moody, FDLE has the investigative resources and expertise to move quickly when it matters most."

Perdue, P.E., said, "The Florida Department of Transportation and Florida's Turnpike Enterprise place our customer's privacy and security at the utmost importance. With that at our core focus, we are grateful for Attorney General Moody's immediate response to stop this scam in its tracks and protect Floridians from these criminals attempting to manipulate customers and gain access to their sensitive information. FDOT proudly stands alongside the Attorney General's office and our law enforcement partners as we continue to go to bat for the people of Florida."

While the authentic Sun Pass web address is SunPass.com, the smishing messages direct targets to fraudulent URLs set up to mimic the official sight. Attorney General Moody's Cyber Fraud Enforcement Unit recently shut down 10 of these fraudulent sites listed below:

sunpass-toll.com sunpass-tolls.com sunpass-express.com service-sunpass.com tolls-sunpass.com web-sunpass.com

Florida is particularly susceptible to this emerging threat as it is home to the most toll roads of any state in the nation—more than 700 miles. These roads are necessary to help the 22 million Florida residents and 130 million Florida visitors get to destinations safely and on time.

Attorney General Moody offers the following tips to Floridians to avoid toll smishing scams:

Avoid Clicking Links: Refrain from clicking on any links provided in unsolicited messages, especially those claiming to be from SunPass, E-ZPass or FDOT;

Americans face unique mental health stressors and barriers to accessing care, but those living i n rural

communities also boast unique support mechanisms that they can tap into to flip the script on mental health stigma.

An Answer

An example of those unique support mechanisms can be found in rural Georgia, where community leader Adaris Rivera has found hope in the resilience that living in a rural community presents. "Each person's journey with mental health is deeply personal and unique, yet there's a universal truth that support and hope are within reach for everyone. No one should feel isolated in their struggles," she said. This is what inspired her to share her own story as part of a national public service advertisement (PSA) campaign called "Love, Your Mind" from Huntsman Mental Health Institute and the Ad Council.

Rivera experienced hardship while growing up in Puerto Rico, moving to the Midwest and eventually laying down roots in rural Georgia. In the PSA video, she talks about her story, saying "I've been through a lot" including trauma, anxiety and depression. For Rivera, the goal of sharing her story is to help others who may be going through the same thing. She advocates for people to seek professional help when needed, and shares how daily practices can also be helpful—such as spending time in nature, journaling and finding time for prayer or reflection.

On her mental health journey, Rivera found solace in one unique benefit of living in a rural place: easy access to nature. 'When I come home exhausted, there's nothing more rejuvenating than stepping into my backyard. Cooking with the door open, letting the breeze in and stealing a few moments on my deck to listen to a mental health podcast.'

Another benefit of rural living that has supported her healing: having a close-knit

Governor DeSantis Ensures Order on Florida's University and College Campuses

GAINESVILLE, Fla. — Today, Governor Ron DeSantis touted Florida's success in maintaining order and

ensuring student safety on Florida's campuses. In Florida, pro-Hamas encampments were disbanded in minutes, and Jewish students were kept safe from harassment.

"In Florida, we prioritize order and student safety on campus," said Governor Ron DeSantis. "While other states allowed their college campuses to be vandalized and taken over by antisemitic agitators, Florida held the line."

"The Florida Highway Patrol is proud to protect citizens from the intentional and unlawful criminal actions and antisemitic behavior that threaten the safety of our college campuses and communities," said Executive Director of the Florida Department of Highway Safety and Motor Vehicles Dave Kerner. "Through the direction and support of Governor DeSantis, Floridians can rest assured that FHP will not tolerate antisemitic agitators and will not stand on the sidelines, but instead will take immediate action to ensure public safety from radicalized intimidation and violence."

"Over the last few weeks we witnessed a descent into chaos across the country," said Chancellor of the State University System of Florida Ray Rodrigues. "Under the leadership of Governor DeSantis, we were able to maintain law and order by taking necessary security measures. Campus presidents had every resource at their disposal to protect all students and ensure that no student missed his or her 2024 commencement ceremony. Antisemitism will not be tolerated at our universities in the free state of Florida."

Governor DeSantis also directed colleges and universities in Florida to ensure commencement ceremonies are not canceled or disrupted. To view the memo, click here.

Additionally, Governor DeSantis further announced support for the following budgetary items to provide student safety funding:

\$569 million for K-12 school safety funding;

\$20 million to protect Jewish Day Schools; and

\$20 million to protect Florida's Historically Black Colleges and Universities (HBCUs).

Governor DeSantis will approve this funding when he signs the Focus on Florida's Future budget for 2024-2025. Since 2019, Governor DeSantis has invested a total of \$1.4 billion for all K-12 student safety initiatives for public school and Jewish Day School campuses. This includes nearly \$196 million for school hardening and over \$43 million for security guards and security infrastructure at Jewish Day Schools.

Additional Student Safety Measures

This week, Governor DeSantis signed HB 1473, which makes improvements to school safety across the state. In part, this bill:

Requires classroom doors and gates to be locked at all times:

Streamlines the process for former law enforcement officers to become school guardians;

Mandates instruction to students on using the Fortify Florida tool, which is the state's anonymous tip reporting tool; and

Prohibits the operation of a drone over a school campus or Jewish Day School.

Protecting Jewish Students

Following the terror attacks in Israel on October 7th, Governor DeSantis directed the State University System of Florida and the Florida College System to waive certain transfer application requirements for Jewish students at schools in other states who have a well-founded fear of antisemitic persecution at their current institution.

Executive Order 23-242 did the following:

Waived credit hour requirements for transfer applications that would typically affect first-and second-year postsecondary students.

Waived application date windows for transfers that would otherwise burden academically eligible students who are seeking to flee discriminatory circumstances.

Additionally, Governor DeSantis urged colleges and universities to use, at their discretion, their existing statutory authority to grant out-of-state tuition waivers on a case-by-case basis for those students who may face financial hardship when transferring to a Florida postsecondary institution from another state.

community. When it comes to mental health, one key step is finding people with whom you can talk openly. Rivera is a strong supporter of this idea, saying "Accepting help means that we are allowing somebody to bless our lives."

She has also found ways to share that hope with her community. She organizes group activities to create "mental health boxes" for individuals who are struggling or being seen for inpatient mental health care. The boxes contain such things as reminders of family and loved ones, items to help with daily selfcare and positive messages and quotes.

Expert Opinion

The notion of leaning into your community for support is one that's also backed by experts. Dave Eldredge from Huntsman Mental Health Institute says, "The reality is, we all have mental health—just like we all have physical health. And when we take care of our minds, we can show up stronger in our work and for the people we care about."

Eldredge grew up in both rural Utah and rural Idaho and knows that talking about orders arrive can be stressful—but there are mental health in rural communities can feel steps you can take to make things easier. difficult at first. "A big part of the challenge can be our mindset. We pride ourselves on being self-reliant, and that can be a wonderful thing. But when we open up to others for a helping hand or just a listening ear, we can actually be stronger."


