OFR Responds

OFR Responds to Plane Crash at Ocala International Airport

Ocala Fire Rescue responded to a plane crash at the Ocala International Airport on Saturday, June 8, at 7:51 p.m. The initial dispatch included Aircraft Rescue and Firefighting (ARFF), Engine 4, Squad 7, Battalion Chief 11, and a Safety Officer, following a distress call from a pilot who reported his aircraft had crashed.

Upon arrival at 1770 SW 60th Ave., crews discovered an experimental aircraft with its tail elevated, nestled against a tree line just outside the airport's fence line. The pilot, who was the sole occupant of the aircraft, was alert but unable to exit the plane due to its precarious position and the surrounding trees.

Given the challenging offroad location, first responders utilized a smaller vehicle to reach and extricate the pilot. Once the pilot was assessed and stabilized by emergency personnel, he was carefully helped out of the wreckage and escorted to a waiting ambulance for transport to a medical

Engine 6 and Rescue 6 were initially added to the response but were cancelled prior to arrival. Marion County Fire Rescue, Ocala International Airport Personnel, and the Ocala Police Department also responded.

The Federal Aviation Administration and the State Warning Point were notified.

From the Desk of Senator Dennis Baxley----

With the elections I wanted to share with you the constitutional amendments that will be on the ballot for the

General Election on November 5th, 2024.

Amendment One – Partisan Election of Members of District School Board – HJR 31 passed by the Legislature 2024...This will require members of a district school board to be elected in a partisan election rather than a nonpartisan election and to specify that the amendment only applies to elections held on or after the November 2026 general election.

Amendment Two - Right to Fish and Hunt - CS/HJR 1157 passed by the Legislature 2024...Preserving the forever fishing and hunting, including by the use of traditional methods, as a public right and preferred means of responsibility managing and controlling fish and wildlife.

Amendment Three – Adult Personal Use of Marijuana – Allows adults 21 years or older to possess, purchase, or use marijuana products and marijuana accessories for nonmedical personal consumption by smoking, ingestion, or otherwise; allows Medical Marijuana Treatment Centers, and other state licensed entities, to acquire, cultivate, process, manufacture, sell and distribute such products and accessories. Applies to Florida law; does not change, or immunize violations of, federal law. Establishes possession limits for personal use.

Amendment Four - Limit Government Good morning Interference with Abortion

- No law shall just around the corner, prohibit, penalize, delay, or restrict abortion before viability or when necessary to protect the patient's health, as

determined by the patient's healthcare provider. This amendment does not change the Legislature's Constitutional authority to require notification to a parent or guardian before a minor has an abortion.

Amendment Five - Annual Adjustments to the Value of Certain Homestead Exemptions - Requires an annual adjustment for inflation to the value of current or future homestead exemptions that apply solely to levies other than school district levies and for which every person who has legal or equitable title to real estate and maintains thereon the permanent resident of the owner, or another person legally or naturally dependent upon the owner is eligible. This amendment takes effect January 1, 2025.

Amendment Six - Repeal of Public Campaign Financing Requirement -Repeals the provision in the State Constitution which requires public financing for campaigns of candidates for elective statewide office who agree to campaign spending limits.

It's not too early with the primary coming up on August 20, 2024, to make sure your voting registration is in order and you know where your voting precinct is located.

Onward & Upward

Rainbow Springs State Park

Babe it's HOT outside! That means Rainbow Springs State Park is getting very, very busy. This news letter is going to be a reminder to everyone about the dos and don'ts of the park weather your new to our area or here year-round, it's always good to review. The weekends are extremely busy and as most have seen Hwy.41 north and south bound lanes are backed up. This creates a very dangerous situation. Therefore, you will notice a Sherriff Officer monitoring the park, the park entrances and exits on the weekends to ensure safety. To keep the traffic flowing, off of Hwy 41, you might be redirected out. So don't be surprised when we have reached capacity and the park is closed that you are informed of this. Plan you day early as there are many times we reach capacity within 1-2 hours and may not reopen. We do this for safety reasons. In our swim area the water is very deep so be prepared with either a life vest, which MUST be worn, you cannot use it to float on top of. Styrofoam noodles not plastic noodles are the only floatation allowed in the water. No tubes, rafts, Kayaks or paddles boards are allowed in the swim area. If you are on a vessel you can dock it at the boat ramp rental area and walk to the swim area to swim. No swimming is allowed outside of the swim area, no scuba

diving is allowed in the State Park aquatic area. Please remember we are an aquatic preserve. If you swim outside the area you are disturbing the underwater life and growth. Infants can be in the 2 holed tube float and handicapped individuals can use their approved handicapped device. The swim dock is small so we ask that no chairs, strollers, tables and personnel belongings are on the dock, no sun bathing as well as this becomes a trip hazard. Leave you radios up on the lawn area and not on the swim dock. Parents, please keep an eye on your children we do not have life guards and things can happen quickly. Lastly, do not hang on the rope lines, when you do this it wears away the coating on the ropes causing them to stretch, and then the ropes sink to the bottom. Do not climb on the big orange buoys. Boats that are powered by gas and trolling motors are not permitted in the River of the State Park. Trolling motors must be lifted and you must paddle into the aquatic area. Our Patrol Boat has an electric motor and that is how we are able to patrol the water. Rainbow Springs State Park welcomes you and we want you to have a great memorable time so please help us to keep you safe as well. We are looking for volunteers on our Boat Patrol, Wednesday crew, parking and gift shop. If you have just a few hours please contact Thea.M.Knott@FloridaDep.gov. Office:352-465-8518.

Private School Choice

One Million Students Now Using flexibility to be in the driver's seat of their Outage Private School Choice

(NAPSI)—Here's news many parents may be interested to learn: According to the most recent data available, 1,038,487 K-12 students are currently enrolled in an education savings account (ESA), voucher, tax-credit scholarship, tax-credit ESA, or refundable tax credit program. While some states provide data for the most recent school year, others lag behind, so actual participation is likely higher.

When Milton and Rose Friedman founded EdChoice in 1996 to lead the way for universal education freedom, there were about 10,000 students participating in choice programs," said EdChoice President and CEO Robert Enlow. "Today, that number has grown a hundred-fold. Over 1 million students can learn in the environment of their family's choosing thanks to policies that empower parents with the freedom and

child's education."

Trends in Education

steadily in recent decades, with rapid growth taking off around 2020, and roughly doubling since. At the same time, policymakers across the country have been increasing student access to private school choice programs at record pace. In 2021, West Virginia created the nation's first school choice program with universal eligibility, and the following year, Arizona made its ESA program available to all students. Today, 12 states offer educational choice programs for all or nearly all choice programs spread across 33 states, plus Washington, D.C. and Puerto Rico.

In all, nearly 22 million students, or 40%, now have access to a private school choice program. With so many families gaining

As states increase access to school choice programs, we know the gap in parent preferences and actual enrollment will continue to close, and students will be happier and more successful because of it."



- 3. Have the right fuel on hand and charge batteries ahead of bad weather. Most gasoline-powered equipment uses E10 or less fuel and most manufacturers recommend adding a fuel stabilizer. Fuel that is more than 30 days old may phase separate and cause running problems, so it's important to purchase fuel just ahead of a storm. Store fuel safely and only use an manufacturer-recommended batteries.
- 4. Pay attention to your energy level and outage and storm cleanup can be taxing. Do not operate power equipment when tired or take regular breaks. Always use safety gear such as chaps, gloves, eye protection and hearing protection when operating equipment.

TALLAHASSEE, Fla.—Attorney General Ashley Moody's Office of Statewide Prosecution today announced the arrest of six fraudsters for stealing nearly \$250,000 from Florida seniors through grandparent scams. The Miami-Dade Police Department's Vice Intelligence Squad reports that the defendants contacted seniors posing as lawyers or legal representatives of one of the victim's grandchildren. The fraudsters told the targets that the grandchildren were arrested after hitting a pregnant woman with a vehicle and needed bail money, then arranged for the victim to send payment.

Attorney General Ashley Moody said, "These fraudsters know that most grandparents would do anything to help a grandchild in need, and through a convincing imposter scheme they used fear
