## Where is the Social Security Fund?

Where is the Social Security fund we have been paying into all our lives?

Social Security is financed through a dedicated Payroll Tax.

Employers and employees each pay 6.2 percent of wages up to the taxable maximum of \$160,200 (in 2023), while the self-employed pay 12.4 percent. The payroll tax rates are set by law, and for OASI and DI, apply to earnings up to a certain amount.

In listening to the financial news a comment was made about "China is our largest debtor". Not true the largest debtor is our own Social Security Fund! Politicians can't stand the fact the Social Security Fund had money in it. So they have been using the money for things other than the aging. Actually they are budgeting in advance for other things not related to the elderly before they have it in hand.

Social insurance, as conceived by President Roosevelt, he would address the permanent problem of economic security for the elderly by creating a work-related, contributory system in which workers would provide for their own future economic security through taxes paid while employed. Thus it was an alternative both to reliance on welfare and to radical changes in our capitalist system. In the context of its time, it can be seen as a moderately conservative, yet activist, response to the challenges of the Depression.

One of the first American books on social insurance was by a Columbia University

economics professor named Henry Seager. He explained the principle of old-age security based on social insurance in his 1910 book, "Social Insurance, A Program of Social Reform". But they are not using it all for the aging. Today and last years they are sending checks to people who now don't want to work. If they don't work they don't pay into Social Security and that is a drag on the fund. "As changing economic conditions are rendering the dependence of old people on their descendants for support increasingly precarious, new obstacles are arising to providing for old age through voluntary saving. . . The proper method of safeguarding old age is clearly through some plan of insurance. . . for every wage earner to attempt to save enough by himself to provide for his old age is needlessly costly. The intelligent course is for him to combine with other wage earners to accumulate a common fund out of which old-age annuities may be paid to those who live long enough to need it." I ask you??? In other words they are using the money to support the Illegals. If you die before retirement age the Government consumes it, but they owe it to you! I say all these people that died of COVID were elderly. Where is all that money going that they don't have to pay any more? Next question how did this pandemic start? Social Security was a form of safe guard, as long as the retirement check were spent a deep depression could not happen because money was moving.

## LL Library \$1 Million Grant

Lady Lake Library receives \$1 million grant for expansion project

Lady Lake – The Lady Lake Library is proud to announce it has been awarded a \$1 million Lake County Library Impact Fee grant to support its ambitious expansion project. This allocation will contribute to the Children's Library portion of the

project, with the Town of Lady Lake funding the remaining cost that includes an expansion of the Information Technology Department and addition of the Growth Management annex.

The project aims to enhance the library's offerings by enlarging the youth library area from 4,560 sq. ft. to 7,697 sq. ft., a 69% increase. It includes an expanded lobby, an additional public elevator, and a landing area for the new second floor Children's Library, adding more than 3,000 sq. ft. to the public spaces.

"This expansion is crucial for meeting the growing needs of our community," said Library Director Aly Herman. "We have quickly outgrown our current youth library, and this project will allow us to significantly enhance the library's collection and programs, benefiting all our patron's

The county's impact fee grant is justified by the library's extensive reach and the expected Town population growth. The Lady Lake Library, part of the Lake County Library System, serves over 16,000 registered cardholders and welcomes approximately 14,500 visitors each month. With the town anticipating a dozen new development projects with an estimated population increase of 8,500 people within the next four years, the expansion is timely.

"The Lady Lake Library is a vital resource for our community," Town Manager Bill Lawrence said. "This expansion will ensure we can continue to provide excellent services to accommodate our growing community. We are thankful for the generosity and support we have received

from Lake County towards realizing this vision."

The expansion will provide much-needed space for additional shelving, reading areas, a larger storytime room, a multipurpose room, and more study spaces. The library hopes to grow its children's collection by 25% and the expanded space will allow for a greater number of programs.

"We are proud to assist our member libraries, such as Lady Lake, in worthy projects that not only benefit their municipalities, but also the community as a whole," said George Taylor, Director for the Office of Library Services for the Lake County Library System. "I would like to thank the library directors for their thoughtful applications, our dedicated Library Advisory Board for their recommendations and the Board of County Commissioners for their support of these projects."

## Endictment

Julie Ann Sulpizio Indicted for Principal to Murder in the First Degree of a Law Enforcement Officer

Today, in Lake County, a grand jury was convened by the State Attorney's Office of the Fifth Judicial Circuit to determine whether there was sufficient evidence to charge Julie Ann Sulpizio for her role in the August 2 ambush that claimed the life of Master Deputy Bradley Link and injured Deputies Stefano Gargano and Harold Howell. The grand jury returned a true bill of indictment for the following charges:

· PRINCIPAL TO MURDER IN THE FIRST DEGREE OF A LAW ENFORCEMENT OFFICER – PREMEDITATED

· PRINCIPAL TO ATTEMPTED FIRST DEGREE MURDER OF A LAW ENFORCEMENT OFFICER (3 counts)

· CONSPIRACY TO COMMIT MURDER IN THE FIRST DEGREE – PREMEDITATED

· BATTERY ON A LAW ENFORCEMENT OR OTHER OFFICER

· BATTERY (3 counts)

A grand jury is required in Florida for all cases in which the death penalty could be sought. Principal to Murder in the First Degree of a Law Enforcement Officer is one such charge. The State Attorney's Office has 45 days to make that decision and will do so after a thorough review of all available evidence. That decision has not yet been made.

Sulpizio remains in custody on no bond status in an area detention facility.

The IRS is cracking down on more tax cheats this year but failed to enforce this standard on thousands of its employees. While 96% of IRS employees fulfilled their tax obligations last year, a significant share were delinquent, owing nearly \$50 million in taxes to the IRS, a new oversight report found. GOTCAUGHT!

Sen. Joni Ernst (R-IA) is pushing for a regular audit of the Internal Revenue Service after a new inspector general report found that nearly 6,000 employees owe nearly \$50 million in back taxes.

The July 24 report, requested by Ernst and conducted by the Treasury Inspector General for Tax Administration, found that while 96% of employees were compliant with tax obligations, over 5,800 IRS and contractor employees owed nearly \$50 million in overdue taxes, and only 20 of the agency's employees who were failing to pay taxes were terminated.

The senator also took issue with a figure in the report that found over 500 former IRS employees with tax compliance issues or performance issues, "including criminal misconduct, sexual misconduct, inability to perform duties, fighting and assault, and unauthorized access to tax return information," were rehired. Of the rehires, 282 had multiple previously documented conduct and performance issues.

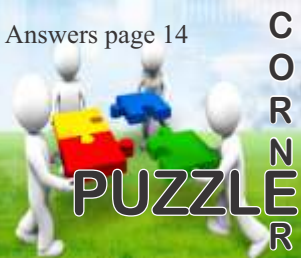
power. These folks' service has been tremendously appreciated this week.

### How to Report Voter Registration Fraud

Attorney General Ashley Moody today in Orlando encouraged vigilance in spotting and reporting voter fraud at the Florida Tax Collectors Association Annual Conference. Tax collector offices around the state are where Floridians go to interact face to face with government. In Florida, tax collectors are independent constitutional officers duly elected by registered voters.

These county government leaders do more than collect taxes. In tax collector offices, Floridians can receive vehicle tags, hunting licenses, driver's licenses and even submit voter registration forms. With the 2024 presidential election around the corner, Attorney General Moody is encouraging tax collectors to display information about reporting voter registration crimes to Florida's Voter Fraud Hotline: 1(877)868-3737.

Attorney General Ashley Moody said, "For many Floridians, tax collectors are the face of the government. Tax collectors help them obtain their first driver's license and can even help them register to vote. Florida has taken great steps to ensure the integrity of our elections. Today, I encouraged tax collectors to help us keep Florida elections secure by posting information about Florida's Voter Fraud Hotline—so Floridians know how and where to report suspicious activity."

In 2022, Governor Ron DeSantis created the Florida Department of State's Office of Election Crimes and Security to conduct preliminary investigations into irregularities or fraud involving voter registration, voting, candidate or issue petition activities, or any other alleged violations of Florida's Election Code. According to the website, OECS has reviewed and investigated more than 3,000 complaints and allegations of election fraud. Additionally, OECS has initiated more than 1,300 independent investigations.

At the annual conference, Attorney General Moody asked tax collectors to post the OECS information in offices across the state, so Floridians know where and how to report illegal voter registration. The call follows efforts by Attorney General Moody to encourage elected leaders to provide the public with information to anonymously report criminal activity through \*\*TIPS and display other public-safety messages aimed at spotting and preventing consumer fraud.

**As Colleges and Universities Begin a New Academic Year, AG Moody Advises Higher Education Officials About Legal Protections and Shared Commitment to Jewish Students in Florida**

As colleges and universities begin a new academic year, Attorney General Ashley

Moody today sent a reminder to higher education officials in Florida about their duty to protect Florida's Jewish students from harassment, intimidation and other incidents of antisemitism. The reminder comes in the wake of radical antisemitic protests continuing around the nation and following the destructive protests witnessed at colleges and universities in the previous academic year.

Attorney General Ashley Moody said, "Last year, my office circulated a memo advising higher education officials of the zero-tolerance policy for antisemitism in our state. Florida offered an example to the rest of the country with swift action while other states witnessed their colleges and universities overtaken by chaos and, in some instances, crime. Let this serve as a reminder, there is no room in our state for lawlessness or antisemitism. As a new school year begins, we are renewing our commitment to making Florida a safe state for Jewish students."

The letter states, "In the days and months following the horrific October 7 attacks on Israel, America saw university administrators across the country utterly fail to protect Jewish students and maintain law and order. Many schools allowed encampments and demonstrations to disrupt student life and school operations...Some of these schools even tolerated overt acts of antisemitic harassment and violence. And because school administrators allowed this unconscionable conduct to continue throughout the entire school year, some universities were forced to cancel graduation ceremonies."

The letter points out that in Florida, schools stood by Jewish students and ensured that Florida's campuses remained institutions of education, "instead of cesspools of lawlessness and hate."

Attorney General Moody goes on to remind school officials that there are legal risks for colleges and universities if they fail to uphold protections for Jewish students. "I also want to advise you that failing to protect Jewish students would create significant legal risk for Florida colleges and universities. For example, a federal court in California recently entered an injunction against UCLA after the court found that 'Jewish students were excluded from portions of the UCLA campus because they refused to denounce their faith,' a fact the court called 'unimaginable' and 'abhorrent to our constitutional guarantee of religious freedom.' Such failures may also put federal funding at risk."

The letter calls for a renewed commitment to making Florida the "best state in the nation for education and the safest state for Jewish students."

**Attorney General Moody Urges Older Floridians to Watch Out for Fraud Ahead of National Senior Citizens Day**

Ahead of National Senior Citizens Day, Attorney General Moody is asking older Floridians to watch out for fraud. Florida is home to more than 5.5 million seniors. Attorney General Moody is highlighting efforts to protect these Floridians from fraudulent schemes. After taking office in 2019, Attorney General Moody launched Florida's Senior Protection Team, an intra-

agency group of experts working together to fight fraud. Last year, the team secured more than \$1 million in financial relief for Florida seniors.

Attorney General Ashley Moody said, "Florida may be known as the Sunshine State, but we are also a silver state—and we prioritize protecting those who choose to live out their golden years here. Ahead of National Senior Citizens Day, we're asking older Floridians to watch out for fraud and highlighting efforts to help seniors avoid falling victim."

Attorney General Moody's Senior Protection Team consists of members from the Office of Statewide Prosecution, Consumer Protection Division and Medicaid Fraud Control Unit. Together, the team fights elder abuse and fraud as well as develops strategies to help seniors avoid falling victim to scammers or criminals. Since Attorney General Moody took office in 2019, the Senior Protection Team secured more than \$8 million in financial relief for Florida seniors.

Attorney General Moody also:

Hosted a symposium for seniors in June at The Villages and shared tips on how to avoid falling victim to cryptocurrency schemes and honored outstanding volunteers of the Seniors vs. Crime program;

Launched the Scams at a Glance initiative to provide low-tech, in-depth resources to educate older Americans about major scams; and

Released the CyberCrime and Seniors Guide that highlights common schemes targeting older Floridians and offers tips about how to spot, report and avoid falling victim to fraudulent schemes.

## Treatm Chronic Low Back Paid

**The ABCs of vertebrogenic low back pain**

After examining Megan's symptoms, Dr. Naidu reviewed an MRI of her low back. He identified specific changes in her vertebral endplates, called [Modic changes](#), that indicated she likely had vertebrogenic low back pain.

This type of pain is a relatively new discovery and caused by vertebral endplates that get damaged due to age, wear, tear and everyday living. While approximately 5.3 million people in the U.S. are living with vertebrogenic pain<sup>1</sup>, this condition did not have an official diagnosis until recently, let alone a treatment.

Dr. Naidu thought Megan would be an ideal candidate for a procedure utilizing Boston Scientific's [Intrasept™ Intraosseous Nerve Ablation System](#), which provides a minimally invasive, same-day treatment specifically designed to address vertebrogenic pain.

"Patients with vertebrogenic pain are the same type of low back pain patients we have seen for years," said Dr. Naidu. "The frustration we had as providers is that we could identify these patients but there was little we could do to effectively treat them. The Intrasept system changed that."

The Intrasept system targets a specific nerve in the lower back—the basivertebral nerve or BVN—that transmits pain signals from the damaged vertebral endplates to the brain. The Intrasept system uses a radiofrequency probe to heat the BVN and prevent it from sending these signals. Megan underwent her procedure with the Intracept system in November 2023. Her pain relief was immediate and, as time went on, Megan ramped up her physical activities without the accompanying low back pain.
