The Marion County Sexual Assault Center marked a milestone Aug. 15, 2025, as the nonprofit celebrated its official certification with a ribbon cutting at its facility on SW 1st Ave. in Ocala. The Ocala Metro Chamber & Economic Partnership joined Executive Director Besty Weber, her staff, board, and community supporters to recognize the center's mission of providing round-the-clock services to survivors of sexual violence.

Weber praised her staff for their work, noting that the center is available 24 hours

a day, seven days a week to those in need. With statistics showing one in four women and one in 26 men experiencing sexual violence or attempted sexual violence in their lifetimes, the center's role is more important than ever. Alongside offering critical support services, the Marion County Sexual Assault Center is committed to raising awareness, educating the community, and working toward prevention. These efforts reflect the generosity and philanthropic spirit that define Marion County.

Efforts to Correct Census Undercount

LAKE WORTH, Fla.— Governor Ron DeSantis announced his support for an update to the 2020 Decennial Census, which could potentially yield additional congressional seats for Florida. Governor DeSantis was joined by Attorney General Uthmeier, who has been a leading voice in the fight for a corrected census and proper reapportionment to ensure that Floridians have the representation they deserve in Congress.

"Even the Biden administration acknowledged that Florida got shortchanged in the reapportionment stemming from the last census," said **Governor Ron DeSantis**. "My office is working with Attorney General Uthmeier in our mission to secure Floridians' due representation in Congress and to fix mistakes that have been identified in the aftermath of the 2020 Census."

"Florida was robbed by the left's multi-year effort to rig the 2020 Census, and

Floridians didn't get the representation they deserve in Congress," said **Attorney General James Uthmeier**. "President Trump called for a new census, and I'm ready to work with Governor DeSantis to bring solutions to the president and get it done."

Updated data provided by the U.S. Census Bureau's 2022 Post-Enumeration Survey shows that Florida was one of the most undercounted states during the 2020 Decennial Census. Florida's population in 2020 was undercounted by nearly 3.5% [according to PES data](#). Additionally, Florida has gained nearly 2 million new residents since 2019, many of whom are not accounted for by the Census Bureau's initial 2020 reports. All of these factors display how Florida is vastly underrepresented in Congress under the Census Bureau's current apportionment.

In addition, the PH crew has participated in the 5K Run for the Springs and the club continues to do a road clean-ups on Southwest 60th Avenue (Airport Road) four times a year.

“We've also begun doing quarterly donations to local organizations,” Marjorie explains. “Back in September, we presented a check for \$1,000 to the FIDO program run through Marion County Animal Services. This is near and dear to my heart, as my husband Mike and I are the proud owners of Josey Wales, a FIDO-trained dog that we adopted in 2022.”

Lastly, the group has partnered with the Hawk's Nest, a local venue for house concerts. Parrot Heads from all over enjoy these concerts, which are hosted by the club's current president and his wife. This year, the club turns 29!

Apart from her Parrot Head fun, Marjorie also received a very prestigious honor this year. She was inducted into the FCSAA (Florida College System Activities Association) Hall of Fame, which is comprised of administrators, coaches, advisors, officials, students, and other nominees that have contributed a minimum of ten years to FCSAA or one of its member institutions. Marjorie made a positive impact upon the students of CF as an educator, mentor, and maternal figure in their lives.

“What is most significant about winning this is being nominated by my peers across the state,” says Marjorie, who was one of a very small group nominated out of the 28 state colleges in the system. “It was amazing that I was also presented this award in Ocala, allowing for Mike, several of my former students, and my college administration to be present for the induction. It still feels like a bit of a dream, that I am in a 'Hall of Fame' for doing something that I love so much.”

Cammack, Pallone Introduce Bipartisan Bill Supporting Aquaculture and Seafood Producers

Washington, D.C.—Congresswoman Kat Cammack (R-FL-03) and Congressman Frank Pallone (D-NJ-

06) introduced the *Supporting Equity for Aquaculture and Seafood (SEAS) Act*—bipartisan legislation which ensures aquaculture and seafood producers are eligible for USDA grants, scientific research opportunities, and agricultural development initiatives.

"America's national security is closely tied to our food security. As aquaculture continues to advance with new technologies and techniques, it offers the promise of more affordable, sustainable, and safe seafood for American families. Florida's aquaculture industry generates over \$165 million in annual sales, ranking among the top states nationwide," said Congresswoman Cammack. "I'm proud to work alongside Rep. Pallone in strengthening and supporting USDA's aquaculture initiatives."

"Aquaculture has enormous potential to strengthen our food system, reduce our seafood trade deficit, and expand access to safe, sustainable American seafood," said Congressman Pallone. "But for too long, USDA programs have overlooked coastal producers. The SEAS Act fixes that by putting seafood on equal footing with traditional agriculture and making smart investments to help this industry grow."

Background:

Despite the growing importance of aquaculture in the U.S. food supply, many seafood producers have historically been excluded from USDA resources and programs that benefit traditional agriculture. The *SEAS Act* addresses this gap by:

- Ensuring aquaculture and seafood producers are eligible for key USDA programs, including conservation, research, and technical assistance initiatives.

- Directing the USDA to develop a strategy to integrate aquaculture more fully into its mission, including coordination across agencies.

- Promoting equity for coastal and inland aquaculture producers, including those producing fish, shellfish, and other aquatic organisms.

- Supporting research and development for innovative, sustainable practices in seafood production.

By aligning federal support for aquaculture with that of traditional agriculture, the *SEAS Act* helps meet rising demand for U.S.-grown seafood, bolsters food security, and strengthens coastal economies across the country.

Cammack Introduces Truth in Women's Healthcare Act

Washington, D.C.—Congresswoman Kat Cammack (FL-03) introduced a House Resolution reaffirming the importance of accurate medical information and guidance for the public, lawmakers and emergency department professionals, treating pregnant women and their unborn children, particularly in the cases involving miscarriage and ectopic pregnancy.

"No woman facing a medical emergency like a miscarriage or ectopic pregnancy should be left in danger because of confusion or misinformation," said Congresswoman Cammack. "This resolution is about reinforcing the importance of long established and clear guidance for doctors so that patients receive quality care and that the public is properly informed on what current law does—and does not—allow."

Background:

Last May, Congresswoman Cammack experienced a life-threatening ectopic pregnancy—a medical emergency in which the embryo implants outside the uterus and cannot survive. Her case, like thousands of others faced by women across the country, required immediate intervention to save her life.

After courageously sharing her experience in the Wall Street Journal, the

Congresswoman became the target of vicious backlash. She, her unborn child, her family, and even her staff received an onslaught of death threats and harassment. This deeply personal and painful moment laid bare the consequences of today's toxic political environment surrounding women's healthcare.

More alarmingly, it revealed how reckless and dangerous the abortion lobby's disinformation campaign has become—conflating emergency medical care for miscarriages and ectopic pregnancies with elective abortion in order to push a broader narrative. By weaponizing fear and misrepresenting facts, they are not only endangering the lives of patients but also silencing those who speak the truth. Not a single professional medical, health organization or state law regards treatment for miscarriages or ectopic pregnancies as abortion. Cammack's experience underscores the urgent need for educating the general public, ensuring clarity in policy and civil discourse.

The Congressional Pro-Life Caucus, numerous pro-life and women's advocacy organizations have also voiced their strong condemnation of the threats and harassment against the Congresswoman.

Washington, D.C.—Washington, D.C.—The Co-Chairs of the Congressional Pro-Life Caucus—Representatives Kat Cammack (R-FL), Michelle Fischbach (R-MN), Andy Harris (R-MD), Bob Onder (R-MO), and Chris Smith (R-NJ)—released the following statement:

"The death threats directed at Congresswoman Kat Cammack, her unborn child, her family, and her staff are unacceptable. These threats followed the Wall Street Journal profile which detailed her personal experience with a life-threatening ectopic pregnancy—an experience that should spark compassion, not hatred. This response exposed just how reckless and dangerous the abortion lobby's disinformation campaign has become. Let's be clear: not a single major medical organization—including the American College of Obstetricians and Gynecologists

(ACOG), the Mayo Clinic, and the Cleveland Clinic—considers treatment for ectopic pregnancy or miscarriage to be elective abortion. These are life-threatening emergencies that require medical intervention.

It is intentionally deceptive to refuse to distinguish between elective procedures that terminate an unborn life and lifesaving care. Miscarriage is not elective. Treating a rupturing ectopic pregnancy is not a choice—it is a medical necessity. No woman should be denied life-saving care because a doctor or hospital fears legal or political consequences.

The Pro-Life Caucus is working alongside women's health advocates, medical professionals, and bipartisan lawmakers to deliver clear, compassionate policy. Our goal is simple: protect life, defend truth, and ensure every woman gets the care she deserves."

We are inspired and grateful that numerous pro-life and women's advocacy organizations have also voiced their strong condemnation of these threats and stand in support of Congresswoman Cammack and the Pro-Life Caucus' efforts to advance legislation that protects women's healthcare, safeguards unborn lives, and upholds the truth.

FAIRTax



Many people lay claim to the belief that taxes need to be progressive, not regressive, since those who make

less are generally considered less able to pay taxes. So is the FAIRtax actually a more progressive tax system than the current income tax system?

Let's take the example of a family of four who earns and spends \$58,000 a year with no savings and no purchases of any used items. After their \$9,729 prebate, they will pay a net \$3,611 in FAIRtax. That's a rate of 6.2%. That's less than they would pay in payroll taxes alone under the current system. The current payroll tax is 7.65% and is applied to every dollar earned. In addition, part of this family's income would be taxed

at 12% with the remainder falling into the 22% bracket.

The FAIRtax un-taxes basic necessities through the prebate and removes the payroll tax which is the most regressive element of our current system. This allows workers to keep their paycheck without any federal income tax while causing real wages to rise. When purchasing new items under the FAIRtax, workers will be using pre-taxed (not post-taxed) dollars.

Payroll and income taxes imposed on businesses are just another cost of doing business and they are passed along to the consumer in the price of their products and services. The FAIRtax removes these hidden taxes. In addition, employers won't need to "match" the 7.65% payroll tax of each employee reducing the cost of business all through the supply chain. Studies

indicate that, depending on the industry, costs of retail goods will drop from 10% to 25% with the FAIRtax.

The current tax system is a disaster for American companies producing goods for export and is a primary reason so many manufacturing jobs have gone overseas. Most of our foreign competitors operate in countries with a value added tax (VAT) which is added at every stage of a products assembly. When those competitors produce for export, their governments refund all the VAT that has accumulated along the

production chain. The result is that these products can be offered at a much lower price than US based products as our items still contain all the embedded costs of our income/payroll tax system. By removing those embedded costs, the FAIRtax puts American manufacturing back on an even playing field with our foreign competitors and helps our blue-collar factory workers.

Attorney General James Uthmeier Sues Major Textbook Publishers for Overcharging Florida Schools

TALLAHASSEE, Fla.—Attorney General James Uthmeier today announced that his office filed a lawsuit against McGraw Hill LLC and Savvas Learning Company LLC, accusing the companies of systematically overcharging Florida school districts for instructional materials in violation of state law and the Florida False Claims Act.

"Our lawsuit exposes a textbook case of corporate greed—companies charging Florida schools more than the law allows,

pocketing the difference, and sticking taxpayers with the bill," said Attorney General James Uthmeier. "Florida will not be a playground for deceitful profiteers who think they can cheat our students and teachers. We will make sure they pay back every dime and face the full consequences under the law."

The complaint, filed in the Second Judicial Circuit Court, asserts that the defendants failed to comply with Florida's statutory pricing requirements for instructional materials adopted for statewide use. Under Florida law, publishers must give every Florida school district the best price offered anywhere in the nation, automatically extend any price cuts made available elsewhere, and provide free materials to Florida schools whenever they are provided free to others.

According to the State's claims, McGraw Hill and Savvas knowingly charged certain Florida school districts more than the lowest price they offered to other districts, and withheld cost reductions required by statute. The lawsuit contends that these violations resulted in substantial overpayments from Florida's school districts and, ultimately, from Florida taxpayers.

The State of Florida intervened in the lawsuit after an investigation initiated under the Florida False Claims Act, which allows whistleblowers, known as relators, to bring actions on behalf of the State against entities that knowingly submit false or fraudulent claims for payment. The complaint seeks treble damages and civil penalties to prevent

future violations.

Attorney General James Uthmeier Announces Arrest in Constitutional Amendment Petition Fraud Investigation

TALLAHASSEE, Fla.—Attorney General James Uthmeier today announced the arrest of Alexandria Mary Beatrice Tatem for Perjury by False Written Declaration, a third-degree felony under Florida law. The arrest follows a joint investigation led by the Florida Department of Law Enforcement's Office of Executive Investigations and the Elections Crime Unit.

"We will not tolerate fraud, let alone fraud that undermines the integrity of Florida's nation-leading election system or uses the names of deceased voters to change our state's constitution," said Attorney General James Uthmeier. "This arrest shows our commitment to upholding the law and protecting the sanctity of Florida's elections. My office will continue to lead the charge against any form of voter fraud in Florida."

According to the investigation, Tatem, a registered Paid Petition Circulator (PPC), submitted a petition in support of a constitutional amendment initiative titled Adult Personal Use of Marijuana (Amendment 25-01), sponsored by Smart & Safe Florida. The petition falsely claimed to have been signed by Amy Akins, a Florida voter who passed away on January 10, 2024—more than a year before the date the petition was allegedly signed. The petition was submitted to the Hillsborough County Supervisor of Elections.

Per State law, PPCs must swear under

penalty of perjury that each petition they submit was signed in their presence by the named voter. Tatem signed the affidavit on the petition affirming it was completed in her presence. During a sworn interview conducted by FDLE on July 1, 2025, in Killeen, Texas, Tatem confirmed that she signed the affidavit and submitted the petition, even after being shown that the voter listed had died more than a year prior.

The investigation revealed that Tatem had been registered as a PPC with the Florida Department of State's Division of Elections since 2019. Tatem collected and submitted petitions in the Tampa Bay and Sarasota regions. Election officials identified the forged petition due to the voter's death before the date of the alleged signature.

The Office of Statewide Prosecution is charging Tatem with one count of Perjury by False Written Declaration, a third-degree felony, punishable by up to five years in prison.

Governor Ron DeSantis Announces Results Of First-Of-Its-Kind Immigration Enforcement Operation

PANAMA CITY, Fla.— Governor Ron DeSantis announced the results of a first-of-its kind law enforcement operation targeting illegal immigration—Panhandle Immigration Enforcement Operation. This operation led by the Florida Highway Patrol in coordination with federal partners at ICE, Homeland Security Investigations, U.S. Border Patrol, and U.S. Citizenship and Immigration Services is part of a comprehensive, multi-agency immigration enforcement detail targeting illegal aliens with criminal records, fugitives, and repeat immigration violators.

“This week, a first-of-its-kind immigration enforcement operation started in Florida’s Panhandle, led by the Florida Highway Patrol in coordination with federal partners,” said Governor Ron DeSantis. “The Panhandle Immigration Enforcement Operation has apprehended hundreds of illegal aliens—including fugitives with criminal records and repeat unlawful border crossers. Florida continues to deliver on the mandate to secure our interior and protect our citizens from the threat of illegal immigration.”

Panhandle Immigration Enforcement Operation early highlights include:

- 45 FHP troopers and 20 federal personnel carrying out enforcement across Escambia, Santa Rosa, Walton, Okaloosa, Holmes, Bay, Washington, and Jackson counties.

- Nearly 200 illegal aliens apprehended.

- 37 illegal aliens arrested who

previously received final orders of removal and failed to appear in court.

- Eight illegal aliens apprehended who had been deported and illegally reentered the United States—one of which had been deported four times. These individuals will be federally charged.

“The FHP Immigration Enforcement Unit has demonstrated unprecedented success in apprehending illegal aliens,” said Florida Highway Safety and Motor Vehicles Executive Director Dave Kerner. “Working hand in hand with our federal partners, we are creating an enforcement model that can truly impact the illegal immigration crisis.”

Florida state troopers encountered illegal aliens who have fled, resisted arrest, and physically assaulted officers—underscoring the heightened danger posed by criminal illegal aliens. Florida continues to face escalating attempts by criminal illegal aliens to infiltrate our communities, posing a direct and growing threat to the safety of our citizens and visitors.

This operation sends a clear and uncompromising message: Florida will not tolerate lawlessness within its borders. We will continue to deploy every available resource to identify, apprehend, and remove those who seek to exploit our state and endanger our people.

Governor DeSantis also announced that Florida has launched weekly deportation flights out of Tallahassee, in partnership with ICE and the U.S. Coast Guard. Last week, the first deportation flight departed Tallahassee with 20 illegal aliens on board.

Updated data provided by the U.S. Census Bureau’s 2022 Post-Enumeration Survey shows that Florida was one of the most undercounted states during the 2020 Decennial Census. Florida’s population in 2020 was undercounted by nearly 3.5% [according to PES data](#). Additionally, Florida has gained nearly 2 million new residents since 2019, many of whom are not accounted for by the Census Bureau’s initial 2020 reports. All of these factors display how Florida is vastly underrepresented in Congress under the Census Bureau’s current apportionment.

Florida Breaks Its Own Record Again: 34.4 Million Visitors In Second Quarter Of 2025

TALLAHASSEE, Fla.— Governor Ron DeSantis announced that Florida has achieved another historic milestone in tourism, welcoming a record-breaking 34.4 million travelers in the second quarter of 2025.
