Turns out, it was laced with fentanyl and a birthday I'll never forget because it was my last."

The website also includes resources for those who may be struggling from addiction themselves or have family members and friends who are.

Lady Lake Officer Responded

LADY LAKE — A 53-year-old man was arrested on Friday after he forced his way into a 78-year-old woman's home, attempted to steal her purse, and injured her during the struggle.

Lady Lake Police officers responded to a home on St. Andrews Boulevard around 3:28 p.m. on Aug. 8 after the victim reported that a man had knocked on her door asking for her vehicle keys. Police say he then pushed his way inside, grabbed her purse, and tried to find the keys.

The victim bravely fought to hold on to her belongings, stating "You're not getting my car keys." She was able to push the suspect back outside and call 911. Police responded quickly and located the suspect nearby. The victim identified the suspect at the scene.

She suffered swelling and redness to her hand.

Craig Steven Johnson, 53, who is listed as homeless, was taken into custody and charged with burglary of an occupied dwelling with battery, robbery by sudden snatching, and battery on a person 65 years or older.

Johnson told officers he had been fleeing from law enforcement when he broke into the home.

The victim sent a letter to the Lady Lake

Police department thanking all five officers involved in making the arrest. "Because of their fast response and my detailed description of this person, he was apprehended within 20 minutes or so..." she wrote.

"This was a frightening and unacceptable attack on one of our senior residents," said Lady Lake Police Chief Steve Hunt. "I am proud of the quick response from our officers, which ensured the suspect was apprehended before anyone else was harmed."

Census Undercount

Governor Ron Desantis Announces Efforts To Correct Census Undercount

LAKE WORTH, Fla.— Governor Ron DeSantis announced his support for an update to the 2020 Decennial Census, which could potentially yield additional congressional seats for Florida. Governor DeSantis was joined by Attorney General Uthmeier, who has been a leading voice in the fight for a corrected census and proper reapportionment to ensure that Floridians have the representation they deserve in

Congress.

"Even the Biden administration acknowledged that Florida got shortchanged in the reapportionment stemming from the last census," said **Governor Ron DeSantis**. "My office is working with Attorney General Uthmeier in our mission to secure Floridians' due representation in Congress and to fix mistakes that have been identified in the aftermath of the 2020 Census.

"Florida was robbed by the left's multi-year effort to rig the 2020 Census, and Floridians didn't get the representation they deserve in Congress," said **Attorney General James Uthmeier**. "President Trump called for a new census, and I'm ready to work with Governor DeSantis to bring solutions to the president and get it done."

Updated data provided by the U.S. Census Bureau's 2022 Post-Enumeration Survey shows that Florida was one of the most undercounted states during the 2020 Decennial Census. Florida's population in 2020 was undercounted by nearly 3.5% [according to PES data](#). Additionally, Florida has gained nearly 2 million new residents since 2019, many of whom are not accounted for by the Census Bureau's initial 2020 reports. All of these factors display how Florida is vastly underrepresented in Congress under the Census Bureau's current apportionment.

Operation Slow Down

Lady Lake Police Department issues 150 citations during Operation Southern Slow Down

The Lady Lake Police Department issued 91 warnings and 59 citations during a weeklong traffic enforcement campaign aimed at reducing speed-related crashes.

From July 14–20, officers dedicated approximately 80 hours to traffic enforcement as part of the Florida Department of Transportation's annual Operation Southern Slow Down. The campaign is a multi-state initiative involving law enforcement agencies across Florida, Georgia, Alabama, South Carolina and Tennessee.

During the enforcement, Lady Lake police issued 39 citations and 91 written warnings for speeding, 13 citations for aggressive driving, and seven citations for seatbelt violations. No DUI arrests were reported during the campaign.

The goal of Operation Southern Slow Down is to curb dangerous driving behaviors that continue to be a leading factor in traffic crashes, injuries and fatalities across the state. According to the

Florida Department of Highway Safety and Motor Vehicles, speeding and aggressive driving contributed to 437 traffic deaths in Florida in 2023.

"This campaign gives us an opportunity to remind drivers that speeding and aggressive driving put everyone at risk," said Lady Lake Police Chief Steve Hunt. "Enforcement is just one piece—awareness and personal responsibility are just as important."

The Lady Lake Police Department encourages all motorists to drive within posted speed limits, wear seatbelts, and avoid aggressive behaviors behind the wheel.

Students Returned To School

TAVARES — Nearly 43,000 students were expected to report to Lake County Schools classrooms on Monday, Aug. 11, to kick off the 2025-26 school year.

Here's what's new:

A-rating: Lake is starting the school year as an A-rated district for the first time since 2008! Lake students showed improvements in all tested areas, and the district more than doubled the number of schools that earned an "A" for the 2024-25 school year compared to the year before. In 2023-24, three district-operated Lake Schools earned an A. In 2024-25, seven did. The A-rated district operated schools for 2024-25 are Cypress Ridge, Treadway, and Villages of Lady Lake elementary schools; East Ridge Middle; East Ridge and Mount Dora high schools, and Lake Virtual School.

New schools: The district has two new schools opening this year. Minneola Horizon Academy in Minneola will offer a full K-8 science, technology, engineering, and math (STEM) program specific to engineering and coding. Fruitland Park Elementary School will welcome students into a new building that replaces the 100-year-old facility where the students attended school last year. Beverly Shores Elementary students will move into the old Fruitland Park school while renovations and upgrades are made on their campus.

Transportation app: Lake County parents this year will have access to a new app that the district is using to streamline student transportation communications. The My Ride K-12 mobile

app will make it easy for parents to locate bus route information and message the transportation staff with questions, concerns, and feedback. It is available for download on Apple and Android devices. Parents are urged to register all bus riders – even those who were bus riders in previous years – at <https://myridek12.tylerapp.com/> and to download the app at the links below.

Lincoln Park Phase 2: Last year, the district opened Lincoln Park Education Center, which houses a flexible day high school program that allows students to earn their high school diploma while holding a job. Phase 2 of the project started this summer, with Lake Technical College beginning renovations to the site's pre-existing gym. It will be converted this year into an innovative space that will house several technical programs, such as HVAC, advanced manufacturing, and electrical. These are just the start of the workforce programs that will be available on-site for students who want to dual enroll at Lincoln Park and Lake Tech to earn valuable industry certifications.

ESE training site: Lake Hills School will serve as a model site for hands-on training as part of Lake-Sumter State College's new Bachelor of Science in Exceptional Student Education (ESE) program, which the State Board of Education approved in June. The program is designed to address the need for certified ESE teachers in Lake and Sumter Counties.

FAIRTAX



Many people lay claim to the belief that taxes need to be progressive, not regressive, since

those who make less are generally considered less able to pay taxes. So is the FAIRtax actually a more progressive tax system than the current income tax system?

Let's take the example of a family of four who earns and spends \$58,000 a year with no savings and no purchases of any used items. After their \$9,729 prebate, they will pay a net \$3,611 in FAIRtax. That's a rate of 6.2%. That's less than they would pay in payroll taxes alone under the current system. The current payroll tax is 7.65% and is applied to every dollar earned. In addition, part of this family's income would be taxed at 12% with the remainder falling into the 22% bracket.

The FAIRtax un-taxes basic necessities through the prebate and removes the payroll tax which is the most regressive element of our current system. This allows workers to keep their paycheck without any federal income tax while causing real wages to rise. When purchasing new items under the FAIRtax, workers will be using pre-taxed (not post-taxed) dollars.

Payroll and income taxes imposed on

businesses are just another cost of doing business and they are passed along to the consumer in the price of their products and services. The FAIRtax removes these hidden taxes. In addition, employers won't need to "match" the 7.65% payroll tax of each employee reducing the cost of business all through the supply chain. Studies

indicate that, depending on the industry, costs of retail goods will drop from 10% to 25% with the FAIRtax.

The current tax system is a disaster for American companies producing goods for export and is a primary reason so many manufacturing jobs have gone overseas. Most of our foreign competitors operate in countries with a value added tax (VAT) which is added at every stage of a products assembly. When those competitors produce for export, their governments refund all the VAT that has accumulated along the production chain. The result is that these products can be offered at a much lower price than US based products as our items still contain all the embedded costs of our income/payroll tax system. By removing those embedded costs, the FAIRtax puts American manufacturing back on an even playing field with our foreign competitors and helps our blue-collar factory workers.



law: As with other schools across the state, schools in Lake will implement the new Florida law that restricts the use of cell phones in all elementary and middle schools during the instructional day unless permission is granted by the teacher for instructional purposes. High school cell phone usage is also limited during instructional time, with greater flexibility at lunch and other non-academic times.

Also, students will continue to be served breakfast and lunch at no charge under the National School Lunch/School Breakfast

Program. For a full list of applicable schools, please see the article. The instructional day is scheduled for 7:20 a.m. to 2:20 p.m. for high schools, 8:20 a.m. to 3 p.m. for K-8 schools, 8:30 a.m. to 3 p.m. for elementary schools, and 9:20 a.m. to 4 p.m. for middle schools. Exceptions include:

Cammack, Pallone Introduce Bipartisan Bill Supporting Aquaculture and Seafood Producers
Washington, D.C.

—Congresswoman Kat Cammack (R-FL-03) and Congressman

Frank Pallone (D-NJ-06) introduced the *Supporting Equity for Aquaculture and Seafood (SEAS) Act*—bipartisan legislation which ensures aquaculture and seafood producers are eligible for USDA grants, scientific research opportunities, and agricultural development initiatives. *"America's national security is closely tied to our food security. As aquaculture continues to advance with new technologies and techniques, it offers the promise of more affordable, sustainable, and safe seafood for American families. Florida's aquaculture industry generates over \$165 million in annual sales, ranking among the top states nationwide,"* said **Congresswoman Cammack**. *"I'm proud to work alongside Rep. Pallone in strengthening and supporting USDA's aquaculture initiatives."*

"Aquaculture has enormous potential to strengthen our food system, reduce our seafood trade deficit, and expand access to safe, sustainable American seafood," said **Congressman Pallone**. *"But for too long, USDA programs have overlooked coastal producers. The SEAS Act fixes that by putting seafood on equal footing with traditional agriculture and making smart investments to help this industry grow."*

Background:

Despite the growing importance of

aquaculture in the U.S. food supply, many seafood producers have historically been excluded from USDA resources and programs that benefit traditional agriculture. The *SEAS Act* addresses this gap by:

- Ensuring aquaculture and seafood producers are eligible for key USDA programs, including conservation, research, and technical assistance initiatives.

- Directing the USDA to develop a strategy to integrate aquaculture more fully into its mission, including coordination across agencies.

- Promoting equity for coastal and inland aquaculture producers, including those producing fish, shellfish, and other aquatic organisms.

- Supporting research and development for innovative, sustainable practices in seafood production.

By aligning federal support for aquaculture with that of traditional agriculture, the *SEAS Act* helps meet rising demand for U.S.-grown seafood, bolsters food security, and strengthens coastal economies across the country.

Cammack Introduces Truth in Women's Healthcare Act

Washington, D.C. —Congresswoman Kat Cammack (FL-03) introduced a House Resolution reaffirming the importance of accurate medical information and guidance for the public, lawmakers and emergency department professionals, treating pregnant women and their unborn children, particularly in the cases involving miscarriage and ectopic pregnancy.

"No woman facing a medical

emergency like a miscarriage or ectopic pregnancy should be left in danger because of confusion or misinformation," said **Congresswoman Cammack**. *"This resolution is about reinforcing the importance of long established and clear guidance for doctors so that patients receive quality care and that the public is properly informed on what current law does—and does not—allow."*

Background:

Last May, Congresswoman Cammack experienced a life-threatening ectopic pregnancy—a medical emergency in which the embryo implants outside the uterus and cannot survive. Her case, like thousands of others faced by women across the country, required immediate intervention to save her life.

After courageously sharing her experience in the Wall Street Journal, the Congresswoman became the target of vicious backlash. She, her unborn child, her family, and even her staff received an onslaught of death threats and harassment. This deeply personal and painful moment laid bare the consequences of today's toxic political environment surrounding women's healthcare.

More alarmingly, it revealed how reckless and dangerous the abortion lobby's disinformation campaign has become—conflating emergency medical care for miscarriages and ectopic pregnancies with elective abortion in order to push a broader narrative. By weaponizing fear and misrepresenting facts, they are not only endangering the lives of patients but also silencing those who speak the truth. Not a single professional medical, health organization or state law regards treatment for miscarriages or ectopic pregnancies as abortion. Cammack's experience underscores the urgent need for educating the general public, ensuring clarity in policy and civil discourse.

The Congressional Pro-Life Caucus, numerous pro-life and women's advocacy organizations have also voiced their strong condemnation of the threats and harassment against the Congresswoman.


Cammack Applauds \$675.9 Million in Disaster Relief for Florida Farmers Washington, DC

Attorney General James Uthmeier Joins Governor DeSantis to discuss the 2020 Census and Congressional Apportionment

LAKE WORTH, Fla.— Attorney General James Uthmeier joined

Governor DeSantis at Palm Beach State College to discuss the 2020 Census and Congressional Apportionment.

"Florida was robbed by the left's multi-year effort to rig the 2020 Census, and Floridians didn't get the representation they deserve in Congress," said Attorney General James Uthmeier. "President Trump called for a new Census, and I'm ready to work with Governor DeSantis to bring the president solutions and get it done."

Attorney General James Uthmeier Sues Major Textbook Publishers for Overcharging Florida Schools

TALLAHASSEE, Fla.—Attorney General James Uthmeier today announced that his office filed a lawsuit against McGraw Hill LLC and Savvas Learning Company LLC, accusing the companies of systematically overcharging Florida school districts for instructional materials in violation of state law and the Florida False Claims Act.

"Our lawsuit exposes a textbook case of corporate greed—companies charging Florida schools more than the law allows, pocketing the difference, and sticking taxpayers with the bill," said Attorney General James Uthmeier. "Florida will not be a playground for deceitful profiteers who think they can cheat our students and teachers. We will make sure they pay back

every dime and face the full consequences under the law."

The complaint, filed in the Second Judicial Circuit Court, asserts that the defendants failed to comply with Florida's statutory pricing requirements for instructional materials adopted for statewide use. Under Florida law, publishers must give every Florida school district the best price offered anywhere in the nation, automatically extend any price cuts made available elsewhere, and provide free materials to Florida schools whenever they are provided free to others.

According to the State's claims, McGraw Hill and Savvas knowingly charged certain Florida school districts more than the lowest price they offered to other districts, and withheld cost reductions required by statute. The lawsuit contends that these violations resulted in substantial overpayments from Florida's school districts and, ultimately, from Florida taxpayers.

The State of Florida intervened in the lawsuit after an investigation initiated under the Florida False Claims Act, which allows whistleblowers, known as relators, to bring actions on behalf of the State against entities that knowingly submit false or fraudulent claims for payment. The complaint seeks treble damages and civil penalties to prevent future violations.

Attorney General James Uthmeier Requests US DOT to Revoke CDL Programs & Funding from California and Washington; Supports Agricultural and State Law Enforcement Inspection Stations to Combat Illegal Aliens Entering Florida

TALLAHASSEE, Fla.—Attorney General James Uthmeier announced that he is [sending a formal letter](#) to the U.S. Department of Transportation and the Federal Motor Carrier Safety

Administration urging the federal government to revoke commercial driver's license (CDL) program authority and strip related federal funding from California and Washington following the deadly crash on August 12th, 2025, that claimed three lives.

"States like California and Washington ignored the rules, gave an illegal alien a license to drive a 40-ton truck, and three people are dead as a result. A preventable tragedy due to sanctuary state policies," said Attorney General James Uthmeier. "In response, we're supporting our Agricultural Law Enforcement and state police to ramp up inspections at state entry-points for illegal aliens who may be operating large trucks using out-of-state driver's licenses. If you're here illegally or can't speak English, you have no business operating large commercial vehicles on Florida's roads. We commend Commissioner Simpson and his department's 287(g) certified law enforcement officers for turning Florida's interdiction stations into strongholds of immigration enforcement. Together, we will ensure dangerous drivers are taken off the road and criminals serve their time before deportation."

Florida Department of Agriculture and Consumer Services (FDACS) Commissioner Wilton Simpson made the announcement alongside Attorney General Uthmeier at an agricultural interdiction station along Interstate 10 in Live Oak. All FDACS sworn law enforcement officers were certified in July, and they are stationing at interdiction checkpoints to work together with federal and state partners on immigration enforcement and checking for English proficiency for commercial drivers while continuing agricultural inspections. These interdiction stations, which are distinct from FDOT weigh stations, will serve as critical enforcement points to stop human smuggling, fraudulent documents, and unsafe commercial vehicles.

"The crash on the Florida Turnpike tragically took the lives of three Floridians and was a completely preventable

consequence of illegal immigration and sanctuary-state policies. It is also a reminder of why the work of our law enforcement community to combat illegal immigration is so critical," said Florida Commissioner of Agriculture Wilton Simpson. "With 23 inspection stations on Florida roadways and 100 percent of our officers being certified in the 287(g) Program, Agricultural Law Enforcement officers are uniquely skilled and positioned to help prevent another tragedy and be a force multiplier in the fight against illegal immigration and criminal activity."

"By leveraging our agricultural inspection stations and 287(g) certified officers, we are working hand in hand with state and federal partners to identify dangerous drivers, enforce immigration laws, and combat criminal activity," said FDACS Office of Agricultural Law Enforcement Colonel Rick "Lee" Adams Jr. "I want to thank Commissioner Wilton Simpson and Attorney General James Uthmeier for their unwavering leadership in standing up for law and order and ensuring that Florida remains a national leader in immigration enforcement."

"By targeting criminal illegal aliens who undermine the safety and integrity of U.S. immigration laws, the 287(g) program strengthens homeland security," said U.S. Immigration and Customs Enforcement (ICE) Enforcement and Removal Operations Acting Executive Associate Director Garrett Ripa. "We appreciate the Attorney General's support and welcome our newest 287(g) partnership with FDACS as we continue to reinforce the rule of law in Florida."

"The Miami Sector Border Patrol is committed to working with our partners to ensure our enforcement efforts provide the safety and security the State of Florida and the American people deserve," said U.S. Customs and Border Protection Deputy Chief/U.S. Border Patrol Miami Samuel Briggs II.

Governor Ron Desantis Announces Results Of First-Of-Its-Kind Immigration Enforcement Operation

PANAMA CITY, Fla.—

Governor Ron DeSantis announced the results of a first-of-its kind law enforcement operation targeting illegal immigration—Panhandle Immigration Enforcement Operation. This operation led by the Florida Highway Patrol in coordination with federal partners at ICE, Homeland Security Investigations, U.S. Border Patrol, and U.S. Citizenship and Immigration Services is part of a comprehensive, multi-agency immigration enforcement detail targeting illegal aliens with criminal records, fugitives, and repeat immigration violators.

“This week, a first-of-its-kind immigration enforcement operation started in Florida's Panhandle, led by the Florida Highway Patrol in coordination with federal partners,” said Governor Ron DeSantis. “The Panhandle Immigration Enforcement Operation has apprehended hundreds of illegal aliens—including fugitives with criminal records and repeat unlawful border crossers. Florida continues to deliver on the mandate to secure our interior and protect our citizens from the threat of illegal immigration.”

Panhandle Immigration Enforcement Operation early highlights include:

- 45 FHP troopers and 20 federal personnel carrying out enforcement across Escambia, Santa Rosa, Walton, Okaloosa, Holmes, Bay, Washington, and Jackson counties.

- Nearly 200 illegal aliens apprehended.

- 37 illegal aliens arrested who previously received final orders of removal and failed to appear in court.

- Eight illegal aliens apprehended who had been deported and illegally reentered the United States—one of which had been deported four times. These individuals will be federally charged.

“The FHP Immigration Enforcement Unit has demonstrated unprecedented success in apprehending illegal aliens,” said Florida Highway Safety and Motor Vehicles Executive Director Dave Kerner. “Working hand in hand with our federal partners, we are creating an enforcement model that can truly impact the illegal immigration crisis.”

Florida state troopers encountered illegal aliens who have fled, resisted arrest, and physically assaulted officers—underscoring the heightened danger posed by criminal illegal aliens. Florida continues to face escalating attempts by criminal illegal aliens to infiltrate our communities, posing a direct and growing threat to the safety of our citizens and visitors.

This operation sends a clear and uncompromising message: Florida will not tolerate lawlessness within its borders. We will continue to deploy every available resource to identify, apprehend, and remove those who seek to exploit our state and

endanger our people.

Governor DeSantis also announced that Florida has launched weekly deportation flights out of Tallahassee, in partnership with ICE and the U.S. Coast Guard. Last week, the first deportation flight departed Tallahassee with 20 illegal aliens on board.

Governor Ron Desantis Announces Efforts To Correct Census Undercount

LAKE WORTH, Fla.— Governor Ron DeSantis announced his support for an update to the 2020 Decennial Census, which could potentially yield additional congressional seats for Florida. Governor DeSantis was joined by Attorney General Uthmeier, who has been a leading voice in the fight for a corrected census and proper reapportionment to ensure that Floridians have the representation they deserve in Congress.

“Even the Biden administration acknowledged that Florida got shortchanged in the reapportionment stemming from the last census,” said Governor Ron DeSantis. “My office is working with Attorney General Uthmeier in our mission to secure Floridians' due representation in Congress and to fix mistakes that have been identified in the aftermath of the 2020 Census.”

“Florida was robbed by the left's multi-year effort to rig the 2020 Census, and Floridians didn't get the representation they deserve in Congress,” said Attorney General James Uthmeier. “President Trump called for a new census, and I'm ready to work with Governor DeSantis to bring solutions to the president and get it done.”

Updated data provided by the U.S. Census Bureau's 2022 Post-Enumeration Survey shows that Florida was one of the most undercounted states during the 2020 Decennial Census. Florida's population in 2020 was undercounted by nearly 3.5% according to PES data. Additionally, Florida has gained nearly 2 million new residents since 2019, many of whom are not accounted for by the Census Bureau's initial 2020 reports. All of these factors display how Florida is vastly underrepresented in Congress under the Census Bureau's current apportionment.

Florida Breaks Its Own Record Again: 34.4 Million Visitors In Second Quarter Of 2025

TALLAHASSEE, Fla.— Governor Ron DeSantis announced that Florida has achieved another historic milestone in tourism, welcoming a record-breaking 34.4 million travelers in the second quarter of 2025. Domestic travelers accounted for 91.5% of total visitation, with 31.5 million Americans visiting the state. Overseas visitation rose by 11.4% over the year to reach 2.3 million, with an additional 640,000 Canadian visitors visiting Florida.

Key highlights from VISIT FLORIDA's Quarter 2 visitation estimates include:

- An estimated 34.4 million travelers visited Florida in Q2 2025.
- Domestic visitors made up 91.5% of the total, overseas visitors 6.7%, and Canadian visitors 1.9%.
- Overseas visitation increased by 11.4% compared to Q2 2024.
- The domestic air/non-air ratio was 37.7%/62.3%.
- Florida's 19 commercial airports handled 28.6 million total enplanements. Punta Gorda (+22.5%) and St. Petersburg-Clearwater (+14.0%) saw the fastest growth.
- Room demand at Florida hotels rose by 1.2%.

Florida visitation's steady growth shows that visitors from all over the world know that a safe and enjoyable experience can be found in the Free State of Florida.
