



**Colonel Nick Navetta** served thirty years in the U.S. Army and retired in 2010 from his last duty position as the Training Division Chief for U.S. Special Operations Command. He is a Veteran of Desert Shield/Desert Storm, Operation Joint Forge in Bosnia, Operation Iraqi Freedom, and Operation Enduring Freedom. Colonel Navetta is branch-qualified in Field Artillery, Combat Military Police, and Civil Affairs. His awards include the Army Achievement Medal with 3 oak leaf clusters, the Army Commendation Medal with 3 oak leaf clusters, the Army Meritorious Service Medal, the Bronze Star Medal, and the Legion of Merit Medal.

Colonel Navetta's last combat tour of duty was in Iraq from November 2006 to November 2007, serving as the Senior Liaison Team Chief for Multi-National Corps-Iraq. Prior to that overseas deployment, Colonel Navetta served as the Government Team Chief for a Civil Affairs Command. He received orders to report to III Corps Headquarters at Fort Hood, Texas and was in a large auditorium with the Corps Commander, primary Staff Officers, and unit chains of subsequent Corps Commands to find out more about the mission they were about to take on. The Corps Chief of Staff was briefing the Corps Commander then about the responsibilities of a Liaison Team



centered in the U.S. Embassy in Baghdad that would coordinate all U.S. Government agencies/Regional Embassy Offices/ Provincial Reconstruction Teams throughout Iraq, Iraqi host nation Government Ministries/Deputy Prime Minister interactions, and serve as a “center of influence” for most activities taking place in the Green ( or International) Zone in Baghdad. The Corps Commander asked his Chief of Staff --- “Who is this guy that will coordinate all these actions?” The Chief of Staff replied, “Colonel Nick Navetta, Sir”.

With a team of about a dozen Officers, the Liaison Team excelled in their many responsibilities and all members were subsequently awarded the Bronze Star Medal.

There was a 3-month period where 28 friendly forces were killed within the International Zone from incoming enemy rockets and mortars. Colonel Navetta also conducted missions throughout Iraq as well as other countries to include Jordan and Kuwait.

Colonel Navetta was instrumental in setting up the Baghdad Security Plan prior to the U.S. surge of forces under General Petraus and subsequently helping to turn “the tide of battle” during the “Sunni Awakening”. He served as the Corps lead for the Al Anbar II Forum in Ramadi, Iraq where tribal leaders finally sided with U.S. forces to limit the death and destruction that previously went unabated.

In all his combat tours of duty, Colonel Navetta felt that he left each place better than what he found it --- or so at that time. It is frustrating nowadays to see that all that hard work and blood spilled seems for naught. It appears that if a population does not yearn for a free society as much as we want it for them, it most likely won't happen.

Our team recently traveled to Philadelphia for the ACCE (Association of Chamber of Commerce Executives) Annual Convention, where chamber leaders from across the country gathered to share ideas, explore new strategies, and challenge each other to think bigger about how we can drive growth and prosperity in our communities.

Philadelphia provided a fitting backdrop for these discussions. Common themes from the ACCE '25 convention:

## FROM THE DESK OF CONGRESSWOMAN KAT CAMMACK



Cammack, Kamlager-Dove, and Christina Perri Launch Bipartisan Effort to Expand Prenatal Screening to Prevent Miscarriages & Stillbirths

Washington, D.C. — U.S.

Representatives Kat Cammack (R-FL) and Sydney Kamlager-Dove (D-CA) introduced a bipartisan resolution to expand prenatal screening for Antiphospholipid Syndrome (APS), a treatable blood clotting disorder linked to miscarriages, stillbirths, and other pregnancy complications.

This effort builds on the advocacy of multi-platinum recording artist Christina Perri, whose personal experience with pregnancy loss due to undiagnosed APS has fueled her mission to ensure other families do not endure similar tragedies.

*"For too long, women and families have endured the heartbreak of miscarriage and stillbirth without answers—losses that, in many cases, could have been prevented with early detection. By expanding prenatal screening for APS, we have the chance to save lives, protect mothers and babies, and spare families untold grief,"* said Congresswoman Cammack. *"I am proud to partner with Congresswoman Kamlager-Dove on this bipartisan effort, and deeply grateful to Christina Perri for transforming her personal tragedy into a mission to protect others."*

*"Anyone who has experienced the heartbreak of even a single miscarriage or stillbirth knows that one is already too many. Yet, current medical guidelines only recommend testing for Antiphospholipid Syndrome after multiple pregnancy losses—this is unacceptable,"* said Congresswoman Kamlager-Dove. *"Failing to include APS in routine prenatal testing isn't just a medical oversight, it's a glaring failure of our maternal healthcare system. This is not complicated—it's a matter of basic human decency and a call for smarter, more compassionate healthcare policy."*

*"I'm so glad my story has a happy ending with my double rainbow baby Pixie. But let's make a change so no one has to have my story again. Let's not get angry, let's get inspired,"* said Christina Perri. *"This isn't about the past. This is about giving a purpose to my Rosie's life. It's about saving babies and helping all other women, families, and kids avoid the anguish that I experienced. I am here to raise awareness about a blood test that can determine this treatable autoimmune disease."*

*"APS is a treatable disorder, yet without screening, it can lead to heartbreaking losses,"* said Congressman Greg Landsman (D-OH). *"Our bipartisan resolution is a simple fix that would improve birth outcomes and better protect mothers and their babies."*

*"Too many families know the heartbreak of pregnancy loss. Often, this heartbreak is met without answers,"* said Congresswoman Young Kim (R-CA). *"Expanding access to prenatal screening for APS is a critical, commonsense step we can take to give moms peace of mind, help doctors provide the best care, and prevent tragedies that could have been avoided. I'm proud to join Reps. Cammack and Kamlager-Dove in this bipartisan effort to provide clarity for families and raise greater awareness about the importance of expanding access to testing for APS."*

*"I'm proud to stand with my colleagues in working to improve prenatal screening for all women,"* said Congresswoman Sheila Cherfilus-McCormick (D-FL). *"In Florida, over 20% of women received no or inadequate prenatal care in 2023. Early detection of complications like antiphospholipid syndrome can save both mothers and babies. This resolution helps ensure that every woman, no matter where she lives, has access to the care she needs for a healthy pregnancy and future."*

*"While it was a huge milestone to get my Maternal and Child Health Stillbirth Act signed into law last year, we have much more work to do to improve care for expecting mothers and prevent stillbirth and miscarriages. I will continue to be a strong*

*voice for mothers in Congress, and work to ensure all expecting mothers have access to the care they need,"* said Congresswoman Ashley Hinson (R-IA). *"That is also why I am proud to join my colleagues on this bipartisan House resolution to support prenatal screening for Antiphospholipid Syndrome. Thank you to Christina Perri, Rep. Cammack, and Rep. Kamlager-Dove for your advocacy and leadership!"*

**Christina Perri's Advocacy**  
Best known for her multi-platinum hit "A Thousand Years" from The Twilight Saga—one of the most popular wedding songs of the last decade—Perri has become a leading national voice for expanded prenatal screening. In 2020, she lost her daughter Rosie at 38 weeks and later learned she had APS. If detected early, APS can often be safely managed with simple blood-thinning medications.

**Background on APS**  
Antiphospholipid Syndrome (APS) is an autoimmune disorder in which antibodies trigger dangerous blood clots. During pregnancy, APS can cause miscarriage, stillbirth, and severe complications. The condition affects at least 1 in 2,000 pregnancies, though experts believe it is widely underdiagnosed. Critically, APS-related pregnancy loss is often preventable with early detection and treatment.

Currently, most medical guidelines only recommend testing after multiple pregnancy losses. Yet the blood test costs less than \$1,000—far less than the \$15,000 average cost of post-miscarriage procedures. The resolution calls for APS screening to become a standard part of prenatal care, an initiative that could save lives, prevent heartbreak, and reduce healthcare costs nationwide.

August may have been a recess on the congressional calendar, but it was anything but quiet for Team Kat. From traveling across Florida's Third District to advancing key initiatives in Washington, our work never stopped.

From meeting with local leaders and first responders to celebrating workforce and education milestones and preparing for the legislative fights ahead, this past month underscored how important it is to stay rooted in the needs of our community while carrying your voices to Washington.

On a personal level, my husband Matt and I were blessed to welcome our adorable daughter, Augusta Dair—our sweet Baby Peanut, affectionately known as Baby Auggie or Gussasaurus.

As always, it remains the greatest honor of my life to represent you in Congress and to hear directly about the issues that matter most—whether that's lowering costs, keeping our communities safe, supporting our farmers, or ensuring Florida has the resources to thrive

### Leading America's Deportation Efforts

The new Deportation Depot at Baker Correctional in Sanderson, FL is now open and ready to house up to 1,500 detainees just 15 minutes from the runway, modeled after the "Alligator Alcatraz." **Paddock Mall Shooting**  
Suspect Arrested in Mall Shooting

A suspect was identified and arrested in the December 23, 2023, Paddock Mall shooting in Ocala.

Details on the suspect and the case:

- Suspect: was arrested on January 8, 2024, after a 16-day manhunt. He is charged with premeditated first-degree murder and two counts of attempted second-degree murder.

- Victim: The shooting resulted in the death of 40-year-old man. Two other people were also injured.
- Motive: According to police, The suspect and the victim knew each other and had an ongoing conflict, suggesting the shooting was targeted.
- Capture: Suspect was apprehended at a home southwest of Ocala after a standoff with law enforcement, which included the Ocala Police Department and the U.S. Marshals Service.
- Status of the case: Suspect has pleaded not guilty, and prosecutors are seeking the death penalty. His trial is currently scheduled to begin in June 2025.

### Attorney General James Uthmeier Announces Launch of New Portal to Combat Violent Extremism

ORLANDO, Fla.—Attorney General Uthmeier joined Commissioner of Education Anastasios

Kamoutsas at Valencia College to announce the launch of new tool for citizens to help identify and combat politically-motivated violence.

The secure online portal allows the public to submit screenshots, videos, and other evidence of threats of violent extremism directly to Attorney General Uthmeier's Office of Statewide Prosecution. Submissions may be anonymous. Prosecutors will review each report and, where appropriate, prosecute those responsible for the threat. **This portal is not intended for emergencies.** Citizens facing an immediate threat should call 911.

"The idea of someone being assassinated for peacefully opposing such radical ideals is vile and anti-American," said Attorney General James Uthmeier. "Threats of political violence will not be tolerated in Florida. That is why today we are launching a new tool, simply named the Combat Violent Extremism Portal, to report acts or threats of political violence."

"Any individual who makes a threat that violates Florida law will be dealt with immediately," said Statewide Prosecutor

Brad McVay. "We look forward to working closely with our law enforcement partners to enhance the efforts to safeguard the Free State of Florida from political violence."

"Any educator who makes vile, despicable comments celebrating and encouraging violence in schools will be investigated and held accountable," said Commissioner of Education Anastasios Kamoutsas. "Thank you Attorney General James Uthmeier for supporting these efforts and helping us ensure Florida's students have the highest quality teachers leading their instruction."

The announcement follows a troubling rise in politically motivated attacks nationwide. Federal reports show assaults on ICE officers have surged by more than 1000% over the past year. Conservative leader and generational icon Charlie Kirk was recently assassinated, with online threats and celebrations of his murder spreading in the aftermath.

The launch of the Combat Violent Extremism Portal reflects Florida's commitment to proactive prevention. By equipping Floridians with a direct channel to prosecutors, the state is strengthening its ability to identify credible threats, disrupt plots before violence occurs, and ensure accountability for those who attempt to endanger lives or undermine public safety.

### Attorney General James Uthmeier Charges Another Snapchat Predator with Possession of Child Sexual Abuse Material

TALLAHASSEE, Fla.—Attorney General James Uthmeier's Office of Statewide Prosecution is charging Luke Sedlock, Green Cove Springs, with three felony counts of possession of child sexual abuse material (CSAM) as well as three felony counts of unlawful use of a two-way communication device.

"Over and over again, our office is prosecuting predators who are using Snapchat to trade disgusting content and victimize children. Protecting our kids is my utmost priority," said Attorney General James Uthmeier. "Our statewide prosecutors will ensure that this predator is held accountable for his abhorrent behavior."

The investigation was launched by the Florida Department of Law Enforcement in August 2025 based on tips from the National Center for Missing and Exploited Children. On Thursday, September 11, the Green Cove Springs Police Department executed a search warrant at Sedlock's residence. Investigators located his electronic devices, which contained both sexual abuse material involving young children and animals.

Sedlock is currently being held in the Clay County Jail on a \$600,000 bond; he is not permitted to have access to devices with internet capabilities or contact with any person under the age of 18.

Attorney General James Uthmeier Announces Arrests in Organized Fraud Ring, Crackdown on Repeat Offenders

TALLAHASSEE, Fla.—Today, Attorney General James Uthmeier announced that the Office of Statewide Prosecution has charged six defendants with engaging in a multi-year scheme to commit large-scale theft and identity fraud across at least five counties in Florida.

"The broader issue at hand here is that repeat offenders pose a major threat to the safety of our communities," said Attorney General James Uthmeier. "Too often, these criminals are arrested, released, and given another chance to prey on innocent people. In Florida, we don't just arrest criminals—we keep them behind bars where they belong."

"The Office of Statewide Prosecution will deploy every tool to dismantle criminal networks made up of career fraudsters and thieves that prey on hardworking Floridians," said Statewide Prosecutor Brad McVay. "The Office will pursue hefty and enhanced charges to ensure individuals convicted of operating as part of one of these organized crime rings are kept behind bars for a very long time, where they can no longer victimize Floridians."

The defendants are connected to the "Felony Lane Gang," a Fort Lauderdale-based theft enterprise that operates across the state. Between March 2021 and May 2023, they carried out over 200 smash-and-grab burglaries at gyms, parks, and other public spaces. Their targets were wallets and purses containing checkbooks, credit cards, IDs, and even passports. The defendants were then using the stolen personal identification information to commit fraud by cashing forged checks and fraudulently withdrawing money from bank accounts.

**Governor Ron DeSantis Celebrates Continued Everglades Restoration Projects**

This project is the first to break ground under Florida’s new Everglades restoration acceleration agreement with the

**MIAMI-DADE COUNTY, Fla.**—Governor Ron DeSantis marked the official groundbreaking of the Blue Shanty Flow Way project, an important milestone in Everglades restoration which will ensure that more water flows from the to-be-completed EAA Reservoir south into Everglades National Park and Florida Bay.

“We are acting on our historic agreement with the Trump Administration to expedite Everglades restoration using federal funds and state expertise,” said **Governor Ron DeSantis**. “Today’s groundbreaking on the Blue Shanty Flow Way project in Miami-Dade County is a milestone in our Everglades restoration efforts, building on our many previous conservation actions.”

This marks the first event since the State of Florida and the U.S. Army Corps of Engineers signed a [new landmark agreement](#) on July 18, 2025, to accelerate the restoration of America’s Everglades. Under the new agreement, the State of Florida assumed responsibility for the Blue Shanty Flow Way and anticipates that it will be done about two years faster than planned.

The Blue Shanty Flow Way is the final project to “uncork” Tamiami Trail that was planned as part of the Central Everglades Planning Project under the Comprehensive Everglades Restoration Plan.

The Central Everglades Planning Project will deliver an average of 370,000 acre-feet of additional water each year from Lake Okeechobee to the Central Everglades – an essential step in restoring the River of Grass. It includes 8.5 miles of a new Blue Shanty Levee and the removal of older levees to allow water to move naturally.

The benefits of the Blue Shanty Flow Way include:

Restoration of a more natural and historic flow of clean water south.

Improved habitat for fish, birds, and other Everglades wildlife.

Support for outdoor recreation and ecotourism.

Strengthening of the connection between the Central Everglades and Florida Bay.

“With every project, from reservoirs to flow ways, we are delivering real results on time, under budget and with strong returns for Florida's taxpayers,” said **DEP Secretary Alexis A. Lambert**. “Alongside our federal partners, state leadership and communities, we will continue driving restoration projects forward.”

Since taking office, Governor DeSantis has made restoring the Everglades and

improving water quality a cornerstone of his administration. On his second day in office, he issued Executive Order 19-12, which committed \$2.5 billion over four years for water quality and Everglades projects. That goal was exceeded in his first term, with \$3.3 billion invested—more than the previous 12 years combined.

In his second term, Governor DeSantis has continued this momentum. With \$1.4 billion included in this year's FY 2025-26 Budget, the state has now committed \$4.6 billion in the first three years of the term, putting

Florida on pace to exceed his \$3.5 billion second-term goal. Altogether, nearly \$8 billion has been invested since 2019 in Everglades restoration and water quality.

Florida's investments in Everglades restoration are paying off:

- Since 2019, over 75 restoration projects have been completed or launched—more than any administration in history.

- Nutrient reductions now total over 1.8 million lbs. Of nitrogen & 770,000 lbs. Of phosphorous annually.
- South Florida's water storage capacity has tripled to 176 billion gallons.
- The C-44 reservoir is complete, the C-43 reservoir is complete, and the EAA Reservoir, the "crown jewel" of everglades restoration, is projected to be finished by 2029.


