Growth Management Department

Growth Management Department announces new office location

LADY LAKE - The Town of Lady Lake's Growth Management Department is moving to a new, larger and more convenient location at the Municipal Annex located at 221 W. Guava St., next to the Lady Lake Library.

During the transition, Growth Management's office - including Building Services, Planning and Zoning, and Code Enforcement - will be temporarily closed on Tuesday, Nov. 18 and Wednesday, Nov. 19.

As always, most Growth Management services are available online, 24 hours a day by visiting www.ladylakefl.gov and clicking on Growth Management. Online services include applying for permits, information on documentation needed to apply online, making payments, and filing or searching code cases.

All the same in-person services Growth Management provides will be available at the new location beginning Thursday, Nov. 20, including land use applications, rezoning, annexations, plan review, permitting, inspections, and code enforcement. Additionally, as an added benefit to the public, computers will be available in the lobby for searching permits or filling out permit applications.

A hotline will be open during normal business hours to assist customers during the transition and can be reached at 352-751-1511.

Driver Accused of DUI

Lady Lake Police arrest driver accused of DUI after traveling into oncoming traffic

LADY LAKE - Lady Lake police arrested a man late Wednesday night after he was seen driving into oncoming traffic on U.S. Highway 27/441.

Just before 11:30 p.m. on Nov. 12, officers responded to reports of a reckless driver near County Road 25 and Griffin Avenue. Callers reported a red Ford passenger car swerving, crossing lanes and nearly striking other vehicles.

Officer Amanda Hayes soon saw the car turn onto U.S. Highway 27/41, driving south in the northbound lanes as other drivers swerved to avoid a collision. Officers Hayes and Officer Josh Higgins blocked traffic and brought the vehicle to a stop near Water Oak Boulevard.

The driver A male 44, of Wildwood, showed signs of heavy impairment and could not stand on his own. Officers observed open containers of alcohol inside the vehicle. Driver was unable to stand without assistance and gave breath samples of 0.245 and 0.236, nearly three times the legal limit.

Driver admitted to drinking earlier in the night. Officers learned he had prior convictions for driving under the influence and suspended license.

He was arrested and taken to the Lake County Jail and the car was towed from the

scene.

"Our officers acted quickly and decisively to stop this vehicle before someone was seriously hurt," Chief Steve Hunt said. "Driving into oncoming traffic is extremely dangerous, and their fast response prevented what could have been a tragic outcome for innocent drivers."

E-Bike Thefts

Suspect confesses to a series of e-bike thefts.

LADY LAKE - A suspect has confessed to a recent string of thefts throughout Town in October, including four e-bikes and one e-scooter. The suspect, Alfred J. Woods II, was taken into custody on unrelated charges in Marion County on Oct. 25. While behind bars, he admitted to the thefts during an interview with Lady Lake detectives.

The first theft was reported on Oct. 9 at Recreation Plantation. Additional thefts happened on Oct. 20 at the Kohl's bike rack, Oct. 24 behind Ay Jalisco, and Oct. 25 behind Papa John's. In one incident, a victim placed an AirTag on their e-bike, allowing them to track and find it abandoned nearby. Another victim tracked their stolen e-scooter to Recreation Plantation and was able to help police with a suspect description.

When the description went out to law enforcement, Officer Ryan O'Neal recognized Woods as someone he had previously stopped riding an e-bike on C.R. 25A on Oct. 18 for a taillight violation.

Detectives later learned the suspect had been arrested in Marion County while riding an e-bike stolen hours earlier in Lady Lake. During an interview at the jail, the suspect admitted to the thefts and stated that his girlfriend sold the e-bikes to obtain money to support his drug addiction. Detectives are currently attempting to locate the woman involved and recover any remaining stolen property.

"This arrest was a result of thorough investigative work and collaboration," said Lady Lake Police Chief Steven Hunt. "We encourage everyone in our community to take extra steps to secure their property and report suspicious activity immediately."

Tips to Secure Your E-Bike

The Lady Lake Police Department encourages e-bike owners to take the following precautions:

- Use a high-quality U-lock or heavy steel chain lock and secure the frame, not just the wheel
- Lock your e-bike in well-lit, visible areas with high foot traffic
- Remove the battery whenever possible when parked in public
- Register the serial number and take photos of your bike to aid in recovery if stolen
- Consider using an AirTag or tracking device discreetly attached to the bike
- Never leave an e-bike unsecured outside overnight or unattended for long periods

The income tax is riddled with a myriad of deductions, credits, adjustments, exemptions and loopholes so that two families with similar incomes can owe vastly different amounts of tax. The FAIRtax treats everyone the same.

No one pays the FAIRtax on their basic necessities. Beyond that, the more you spend on new goods and services, the more tax you pay.

When compared with the income tax, the FAIRtax delivers a resounding simple solution to our ongoing complex problem of

an impossible tax code with annual illegal tax evasion of \$1 trillion. The FAIRtax is simply a better mechanism to collect our nation's treasury receipts. I think it's quite

My Christmas Story!

This is a true story. When I was a little boy we were being raised Dania Beach Florida by my Grand Mother while our parents worked out of town at the Boca Raton Hotel. One day just before Christmas my friend and I were playing near

The other boy piggy back me to the road and ran to the Fire Chiefs house. Luckily the Fire Chiefs home was close by. He

So the fire Chief took me to a clinic in the next town Hollywood. If the tendon was almost severed back in them days if it was severed you were crippled. They managed to get clamps on my tendon and pull it back into place and staple it. My parents were called. They picked me up at the clinic and I was told I would not be able to start walking for at least two months.

Christmas school brake was a few days away. Christmas was a big thing to me. It was not because of the gifts but the fact that

I would see Santa Claus. After all I only saw him once a year. Every year there was a Christmas parade. That night I was very sad because I could not go, I could not walk. Grandma told my sister she could take my brother and walk two block to where the

parade would come down US 1. Grandma could not walk very far. I was sitting next the slide up window listening for the firetruck that carried Santa Claus in the parade, finally I could hear the siren and the horn on the firetruck. I sat there in the window almost crying because I would not see Santa. The sound of the siren was getting louder as they down the Hwy. On June 28, 1968, Congress passed the Uniform Holiday Bill, establishing Veterans Day as a federal holiday to honor all American servicemembers.



The American people deserve to know the full truth, which is why House Republicans took decisive action to petition the Justice Department to release the files on Jeffrey Epstein. Transparency is long overdue, especially for the survivors who have waited years for accountability.

Although today's vote is a major victory for survivors, we cannot ignore the fact that Democrats have repeatedly worked to shield information and downplay their own involvement. Medical and Cancer Research

New Survey Finds Overwhelming Public Support for Federal Funding for Medical and Cancer Research

(NAPSI)—When it comes to federal spending, the majority of Americans want Congress to make increasing medical research funding a high priority.

A recent national poll conducted by the

American Association for Cancer Research (AACR) found very high levels of support for federal funding for medical and cancer research across the electorate.

Highlights of the survey include:

- 89% of voters favor the federal government using taxpayer dollars to fund medical research to fight diseases and improve public health.
- 71% of voters think increasing federal funding for medical research should be a top congressional priority.
- 72% of voters who believe reducing the national debt and federal spending should be a top congressional priority also think increasing medical research funding should be a "high" or "highest" priority issue for Congress.
- 83% of voters, including 75% each of independents, Republicans, and MAGA supporters and 93% of Democrats, favor increasing federal funding for cancer research.
- Voters have high levels of confidence in cancer researchers and the National Cancer Institute (NCI) to act in the best interests of the public. 71% of survey respondents express a "great deal" or "quite a bit" of confidence in cancer researchers, while 65% express a "great deal" or "quite a bit" of confidence in NCI.
- 77% of voters say they would feel more favorable toward their congressional representative if he or she voted to increase federal funding for cancer research over the next decade.

Funding Leads to Progress for Patients

"As these survey results demonstrate, the American public strongly supports robust federal funding for medical and cancer research," said Margaret Foti, PhD, MD (hc), chief executive officer of the AACR. "Cancer affects everyone. Sustained and predictable investments in the National Institutes of Health and NCI are essential if we are to power new breakthroughs against cancer and other diseases and uphold a national commitment to the patients and families who are relying on lifesaving progress."

Attorney General James Uthmeier Announces Arrests, Deportations in Child Exploitation Operation

S T U A R T , Fla. — Attorney General James Uthmeier today announced that Isaias Coy, David

Desormeaux, Miguel Angel, Antonio Rojas, Mohamed Mesregah, and Jeremiah Gillyard have been arrested on charges relating to the sexual exploitation of children.

"These predators believed that they could hide behind a screen to exploit our children—they were wrong," said Attorney General James Uthmeier. "Several of these defendants are now on ICE detainees and will face prison before deportation. We will never stop protecting kids in Florida; those who target them will be caught and punished."

"These men will soon come to realize that they traveled to the wrong county in the wrong circuit," said Thomas Bakkedahl, State Attorney for the 19th Judicial Circuit of Florida.

"This operation is a powerful example of what can be accomplished when local, state, and federal partners come together with one shared mission—to protect our children," said Martin County Sheriff John Budensiek. "These arrests should serve as a warning to anyone who thinks they can prey on children in our communities. We will find you, we will arrest you, and we will hold you accountable."

"FDLE remains steadfast when it comes to protecting our innocent children from the

dangerous predators lurking online. Working side by side with our state, local, and federal partners, we will continue to strengthen our efforts to safeguard every family and every child," said FDLE Commissioner Mark Glass. "Make no mistake, those who target or harm our children have no place in our communities. We will find them and bring them to justice."

This operation was a joint effort between Attorney General Uthmeier's Office of Statewide Prosecution, the Florida Department of Law Enforcement, Martin County Sheriff's Office, Stuart Police Department, the U.S. Department of State, Homeland Security Investigations (HSI), and the Office of Thomas Bakkedahl, State Attorney for the 19th Judicial Circuit of Florida.

The undercover operation targeted predators who were sexually exploiting children online. The investigation involved undercover law enforcement officers posing as 14-year-old girls on an online escort website. Each of the defendants engaged in sexually explicit and harmful communications with the undercover officers despite being informed they were communicating with a 14-year-old. The defendants each continued to make plans to meet for sexual activity, and were all arrested upon arriving at the agreed upon meeting spot.

These cases are being prosecuted by Attorney General James Uthmeier's Office of Statewide Prosecution, State Attorney's Office for the 19th Judicial Circuit, and the United States Attorney's Office for the Southern District of Florida.

Attorney General James Uthmeier Announces Grand Jury Indictment and Intent to Seek the Death Penalty in Child Sexual Battery Case

BROOKSVILLE, Fla.—Attorney General James Uthmeier announced that a Hernando County grand jury indicted Nathan Douglas Holmberg, 36, on twenty-

five counts, which include seven counts of capital sexual battery on a child under twelve, following an investigation by the Hernando County Sheriff, State Attorney for the Fifth Judicial Circuit, and the Office of Statewide Prosecution. The State of Florida will seek the death penalty in its case against Holmberg.

"If you harm a child, we will find you, we will prosecute you, and we will seek the maximum penalty under the law," said Attorney General James Uthmeier. "The nature of these crimes demanded a statewide special task force, and the investigation is far from over. Hernando County Sheriff Nienhuis and State Attorney Gladson have the full support of our Office of Statewide Prosecution."

"When an individual commits a truly heinous crime, as in this case, the full weight of the law must be brought to bear," said State Attorney Bill Gladson, Fifth Judicial Circuit. "There is no place for mercy when the acts committed against a child are so unspeakable. Accountability will be had, any chance of recidivism will be nonexistent, and justice will be served."

"Florida is a state that is governed by the rule of law," said Hernando County Sheriff Al Neinhuis. "Although it is never acceptable to commit a crime against another person, it is especially heinous to victimize totally innocent and very young children, children who often put their complete trust in adults. Anyone who perverts that trust for sexual gratification can expect the full weight Florida's criminal justice system, and if found guilty, can expect the absolute harshest penalties."

This investigation, which spans multiple judicial circuits, is the first to operate at this level of joint authority, with members of the State Attorney's Office for the Fifth Judicial Circuit and the Hernando County Sheriff's Office operating under a special task force with statewide authority granted by the Attorney General's Office of Statewide

Governor Ron DeSantis Announces Management Proposal for Atlantic Red Snapper Season
FERNANDINA BEACH, Fla.— Governor Ron DeSantis announced that the Florida Fish and Wildlife

Conservation Commission (FWC) formally submitted an Exempted Fishing Permit (EFP) to U.S. Commerce Secretary Howard Lutnick that, upon approval, will allow Florida to assume management of the recreational red snapper fishery in state and federal waters off the Atlantic Coast beginning in 2026.

“State management and expansion of Gulf snapper season have been a major boon for our Gulf of America communities, allowing so many Floridians and visitors to enjoy the Red Snapper our waters have to offer,” said **Governor Ron DeSantis**. “I was proud to announce that Florida anglers will soon be able to enjoy more Atlantic Red Snapper fishing as well. The Trump Administration has taken action to rein in the bureaucracy and return this power to the states, where it belongs. To that end, Florida has submitted a formal request to the federal government for state management of the recreational red snapper fishery. Just as it has on the Gulf coast, Florida’s management of Atlantic Red Snapper fishing will boost local economies along our Atlantic coast, supporting tackle and bait shops, hotels, restaurants, and the entire recreational fishing community.”

Since January, the Trump Commerce Department, under the leadership of Secretary Lutnick, have stood firm for our angling community. Earlier this year, Secretary Lutnick **put fishermen first**, rejecting the Biden Administration’s last-ditch attempt to force sweeping closures off our coast—a move to begin the path of finally **reversing decades of failed federal control and to empower state-led management**. Further, today’s announcement follows recent actions by the [Governors](#), [Attorneys General](#), and [Congressional](#) delegations of Florida, Georgia and South Carolina.

“Florida has proven it can effectively and efficiently manage the Atlantic recreational red snapper fishery,” said **Florida Fish and Wildlife Conservation Commission Executive Director Roger Young**. “Under Governor DeSantis’ leadership, the state has expanded access for and delivered greater opportunities for anglers in the Gulf year after year—demonstrating a strong commitment to both conservation and the fishing community. We are excited and ready to bring this level of expertise to manage the Atlantic recreational red snapper fishery.”

As submitted to the National Oceanic and Atmospheric Administration (NOAA), Florida would implement a 39-day Atlantic Red Snapper season, a dramatic expansion from the two-day federal season allowed in 2025, an 1850% increase in fishing. The proposed season includes:

Summer: From May 22 (Memorial Day Weekend) through June 20

Fall: Three-day weekends in October (Oct. 2–4, 9–11, and 16–18)

Florida’s application leverages the same process used in the Gulf, where state management has produced results that support the species and anglers. Since assuming management in the Gulf, the Red Snapper season has risen from 3 to 127 days, an over 4100% increase for Florida’s Gulf anglers and for-hire operators.

The expanded season is expected to drive major economic growth for coastal communities, benefiting tackle and bait shops, hotels, restaurants, and Florida’s robust boating and fishing industries. Florida remains the nation’s leader in recreational fishing and boating, home to over 4 million licensed anglers, 922,000 registered boats, and a \$31.3 billion recreational boating industry supporting over 100,000 jobs statewide.

The Governor also reinforced the success of the ongoing Second Amendment Sales Tax Holiday, which suspends collection of sales tax on the retail sale of items needed for hunting, fishing, or camping in Florida’s great outdoors

Anyone fishing for red snapper from a private recreational vessel—in state or federal waters—must be registered as a State Reef Fish Angler (with annual renewal), even if exempt from fishing license requirements. Registration is available at [GoOutdoorsFlorida.com](#).

Governor Ron DeSantis Celebrates Continued Everglades Restoration Momentum and Breaks Ground on New Inflow Pump Station at Critical EAA Reservoir Project

PALM BEACH COUNTY, Fla.— Today, Governor Ron DeSantis attended the groundbreaking for the new inflow pump station at the critical EAA Reservoir Project. The EAA Reservoir, located south of Lake Okeechobee, will store over 78 billion gallons of water—larger than Manhattan—and deliver up to 470 billion gallons of clean water annually to the Everglades and Florida Bay. It also supports the Biscayne Aquifer, the primary source of drinking water for South Florida.

This ceremony marks the 80th milestone event since 2019, celebrating ribbon cuttings, groundbreakings, and major achievements across Everglades restoration projects under the leadership of Governor Ron DeSantis—the most in state history.

“Florida reached a historic agreement with the Trump Administration earlier this year to expedite and advance Everglades restoration,” said **Governor Ron DeSantis**. “Today, I was pleased to announce a milestone in Everglades restoration made possible by our cooperation with the federal government. Florida is now breaking ground on the new EAA Inflow Pump Station, an essential component of the EAA Reservoir project. This is the second Everglades restoration project to commence since the agreement with the Army Corps of Engineers last summer, which has empowered Florida to step up our Everglades restoration efforts. Today’s groundbreaking marks the 80th milestone

event in Everglades restoration that has taken place since 2019, thanks to our leadership and commitment to getting this done.”

“The EAA Reservoir is a critical component of Everglades restoration and Governor DeSantis has led the charge on getting this project done,” said **Department of Environmental Protection Secretary Alexis Lambert**. “Restoring America’s Everglades is one of the most ambitious environmental restoration projects ever undertaken and will restore the natural flow of clean water south to where it’s needed most. With every project we are delivering real results on time, under budget and with strong returns for Florida’s taxpayers.”

The new inflow pump station will have nine pumps and will be one of the largest pump stations in the State of Florida. The pump station will have the capability to move approximately 3 billion gallons of water per day from Lake Okeechobee into the EAA Reservoir.

For decades, Florida’s water system was altered to prevent flooding, but at the cost of cutting off the natural flow of water to the Everglades. The EAA Reservoir Project is designed to correct that—redirecting water south, restoring ecosystems, and significantly reducing harmful discharges to the Caloosahatchee and St. Lucie estuaries. Once complete, the EAA Reservoir will provide lasting benefits for Florida’s coastal communities and unique natural environment.

Today’s groundbreaking commemorates another major milestone since the new landmark agreement was signed in July 2025 between the State of Florida and the U.S. Department of the Army. This agreement supercharges Everglades restoration by accelerating the EAA Reservoir’s construction timeline by five years—from 2034 to 2029. It also cuts federal red tape and redirects resources to fast-track critical restoration efforts. The

State of Florida already held a groundbreaking for the Blue Shanty Flow Way in September 2025, a vital system that will deliver clean water south across Tamiami Trail and into Florida Bay.

Florida’s leadership has already resulted in faster, cleaner, and more affordable restoration efforts. Since 2019:

- The C-44 reservoir is complete, the C-43 reservoir is complete, and the EAA Reservoir is being accelerated.
- Annual nutrient reduction totals have reached over 1.8 million pounds of nitrogen, and 770,000 pounds of phosphorus removed from Florida’s waterways.
- South Florida’s water storage capacity has tripled to 176 billion gallons.

Since taking office, Governor DeSantis has made restoring the Everglades and improving water quality a cornerstone of his administration. On his second day in office, he issued Executive Order 19-12, which committed \$2.5 billion over four years for water quality and Everglades projects. That goal was exceeded in his first term, with \$3.3 billion invested—more than the previous 12 years combined.

In his second term, Governor DeSantis continued this momentum. With \$1.4 billion included in this year’s FY 2025-26 Budget, the state has now committed \$4.6 billion in the first three years of the term, putting Florida on pace to exceed his \$3.5 billion second-term goal. Altogether, nearly \$8 billion has been invested since 2019 in Everglades restoration and water quality.

Let's Talk About Gratitude... Community of Gratitude: Orange Blossom Gardens Lions Club Deepens Support for Local Food Pantry Following Equipment Failure

Lady Lake, FL — The Orange Blossom Gardens (OBG) Lions Club has reaffirmed its long-standing commitment to addressing food insecurity in the region through support for the Community of Gratitude Food Pantry. As families across Central Florida face rising costs and increasing need, the Pantry continues to serve as a critical lifeline, providing essential groceries, meal supplies, and emergency food assistance to hundreds of households each month.

This November, the OBG Lions further strengthened this partnership with several contributions underscoring the Club's dedication to service, compassion, and community impact.

Last week, the Club donated 100 Walmart gift cards (\$10 each) to assist the Pantry's annual holiday meal program, helping local families prepare for the season with dignity and stability. Shortly after, Lions members delivered the results of the Club's October Community Food Drive, where local residents contributed more than 500 non-perishable food items. The OBG Lions then matched this total with an additional 500 items, resulting in more than 1,000 donated

goods supporting local households experiencing food insecurity.

Food insecurity continues to affect families in every part of the region, including working families, seniors on fixed incomes, and individuals facing unexpected medical or financial hardship. Community food pantries like Community of Gratitude play a vital role in bridging those gaps, ensuring that no family is left without the essentials they need to get through the week.

When Lions members arrived to deliver the October donations, they learned that the Pantry's three-wide commercial refrigerator unit had failed beyond repair, causing the loss of critical cold storage capacity and a significant amount of perishable food. The failure placed immediate strain on the Pantry's operations at one of the busiest times of the year.

Recognizing the urgency, the OBG Lions convened an emergency board meeting, then brought the matter to the full membership on Wednesday, November 12. The Club voted to fund an immediate solution. The Lions purchased two brand-new, 20-cubic-foot refrigerator units (freezerless) to restore the Pantry's cold-storage needs and prevent future distribution interruptions. In addition, the Club will purchase \$500 in replacement food to help cover the loss caused by the equipment breakdown.

"Our mission is grounded in service, and moments like this demonstrate the true value of community partnerships," said Barbara Crewell, President of the OBG Lions Club. "The Community of Gratitude Food Pantry is essential to the well-being of our neighbors. When an unexpected setback occurs, the Lions step forward to ensure that families continue to receive the support they rely on."

OBG Lion Robert Vass added, "Food insecurity is a very real challenge for many. By working together with donors, volunteers, and organizations like Community of Gratitude, we can make sure that help is available when it's needed most. Gratitude isn't just a theme for the season; it's the foundation of how we serve."

Prosecution. This structure allows investigators to pursue leads and evidence across jurisdictions, ensuring no delay or obstacle stands in the way of protecting children and seeking justice.

On October 20, 2025, Hernando County Sheriff's deputies arrested Holmberg on three counts of capital sexual battery on a child under twelve and one count of promoting sexual performance by a child.

In 2023, Governor DeSantis signed legislation aimed at overturning the decision in Kennedy v. Louisiana, where the U.S. Supreme Court held that the death penalty could not be a punishment for raping a child.

This investigation is still ongoing. As the investigation unfolds, prosecutors may bring additional charges.

Attorney General James Uthmeier Announces Guilty Verdict for Predator Charged with Possession of Child Sexual Abuse Materials

FORT MYERS, Fla.—Attorney General James Uthmeier's Office of Statewide Prosecution has secured the conviction of Phuc Minh Tran, 38, of Lehigh Acres, on 40 counts of child pornography possession.

"This predator is facing decades behind bars, which is right where he belongs," said Attorney General James Uthmeier. "Thanks to the hard work and dedication of Deputy Assistant Statewide Prosecutor Julie Chaikin and Senior Assistant Statewide Prosecutor Agnieszka Thomas, this monster is off the streets and away from our children."

On August 15, 2024, Florida Department of Law Enforcement officers carried out a search warrant at Tran's residence after known child sexual abuse material was flagged by the FDLE cyber squad as being downloaded by Tran. Tran was arrested on the scene.

After a week-long jury trial, Tran was found guilty on all 40 felony charges of second-degree possession, control, or intentional viewing of child pornography.

Tran will be sentenced on December 22 and faces up to 600 years in the Department of Corrections.
