The session will again be led by Howard Davis, the Town's IT cybersecurity expert. Based on feedback from the previous training, this presentation will focus specifically on phone cybersecurity, providing residents with practical tools to protect their personal information while using smartphones and mobile devices. Davis will cover common phone-based scams, suspicious text messages, malicious apps, and ways cybercriminals attempt to gain access to sensitive data through mobile platforms. Attendees will also learn best practices for securing their devices, identifying red flags, and reducing the risk of identity theft or fraud. The training is free and open to the public and is designed for users of all experience levels. Registration is not required. ## LLPD & American Legion Event

### Lady Lake Police Department And American Legion Host Shredding Event

LADY LAKE — The Lady Lake Police Department, in partnership with American Legion Post #347, are hosting the second annual "Shred it and Forget it," a free drive-through shredding event to help protect seniors from scams.

The event will take place on Saturday, April 25 from 9 – 11:30 a.m. (or until capacity is met) at Post 347, located at 699 W. Lady Lake Blvd. Residents are invited to drive through with a limit of two banker boxes of documents to be shredded, free of charge. The event is open to all area residents and will be held rain or shine. Last year, approximately 1,000 people attended, successfully shredding 20,000 pounds of documents.

The event is another opportunity offered

by the Town in its ongoing efforts to help residents avoid scams and fraud.

"This shredding event gives residents a simple, secure way to dispose of sensitive documents and protect their personal information - especially during tax season," said Lady Lake Police Chief Steve Hunt. "Properly shredding old financial records, medical paperwork and other confidential materials helps prevent identity theft and keeps private information out of the wrong hands."

"Shred it and Forget it" is made possible with the assistance of Veterans Memorial Post 347, American Legion Auxiliary Unit 347, Sons of the American Legion Squadron 347, and American Legion Riders Chapter 347.

## LLPD First Arrest New Technology

### Lady Lake Police make first arrest using new License Plate Reader technology

LADY LAKE — The Lady Lake Police Department has made its first arrest using the department's new license plate reader (LPR) camera system, demonstrating how technology can assist officers in identifying stolen vehicles and apprehending suspects.

On March 10 at around 3:30 p.m., Lady Lake officers were alerted by the department's Safety LPR system that a stolen vehicle was traveling southbound on U.S. Highway 27/441 near Avenida Central. The car had been entered into the National Crime Information Center database as stolen through the Lake County Sheriff's Office.

Officers conducted a search of the area and found the car in the parking lot of Publix on Bichara Boulevard. Sgt. Heather Couch located and arrested the vehicle's driver, later identified as suspect Stephanie Lynn Barbee, 37. During the investigation, officers determined Barbee had been in possession of the car for two days. A search of the vehicle uncovered a bag containing a crystal-like substance that tested presumptively positive for methamphetamine and weighed 1.29 grams. Officers also recovered pills later identified as benzodiazepine.

Barbee was charged with grand theft of a motor vehicle, possession of methamphetamine, and possession of benzodiazepine. She was transported to the Lake County Jail. A passenger in the vehicle, James Smith, 24, was also arrested on separate drug-related charges.

"This case is a great example of how technology and good police work go hand in hand," Lady Lake Police Chief Steve Hunt said. "The license plate reader system alerted our officers to the stolen vehicle, but it was the quick response and proactive work of our officers that ultimately led to the arrest. Tools like this help us respond faster, recover stolen property, and keep our community safer."

The system uses cameras to capture license plate numbers and vehicle characteristics such as make, model, and color. It then sends alerts when a vehicle associated with a crime or missing person alert is detected. The cameras do not use facial recognition or collect biometric data, and all data is automatically deleted after 30 days.

The Lady Lake Police Department recently installed the cameras at key entry points throughout Town.

## Suspect Charged Attempted Murder

Suspect charged with attempted murder. LADY LAKE — The Lady Lake Police Department has charged a man with attempted murder and aggravated battery following a stabbing that occurred Friday evening near Veterans Memorial Park in The Villages.

On March 7, the Sumter County Sheriff's Office notified the Lady Lake Department of a stabbing victim facing life threatening injuries being treated at UF Health Spanish Plains in Sumter County. He was later airlifted to UF Health Shands in Gainesville where he underwent surgery and survived. Investigators determined the incident occurred in a parking lot near Veterans Memorial Park on Paige Place in Lady Lake (The Villages) at around 8 p.m.

According to investigators, the altercation involved the victim, a 39-year-old male, and the suspect, William Tyler Warren, 42, and reportedly stemmed from a dispute involving a female acquaintance.

The 37-year-old female involved was not initially located but was later contacted and is cooperating with authorities. She was arrested on a warrant out of Georgia.

Warren, who had recently moved with the female to Lady Lake from Georgia to the 700 block of Turnberry Lane in Orange Blossom Gardens, was detained by the Marion County Sheriff's Office and transported to the Marion County Jail. Lady Lake detectives interviewed Warren at the jail, where he admitted his involvement in the incident.

Warren is facing charges of attempted murder and aggravated battery.

"This was a violent incident that left the victim with serious injuries," said Lady Lake Police Chief Steve Hunt. "Our officers and detectives moved quickly to investigate the case and worked with our law enforcement partners to locate the suspect. We are committed to holding those responsible for violent crimes accountable and ensuring the safety of our community." The investigation remains ongoing.

## Tree City USA

### Lady Lake designated Tree City USA for the 21st year.

The Town of Lady Lake has been recognized as a Tree City USA by the Arbor Day Foundation for the 21st consecutive year, continuing a long-standing commitment to urban forestry, environmental stewardship and community beautification.

To earn the designation, communities must meet four core standards established by the Arbor Day Foundation: maintaining a tree board or department, adopting a tree care ordinance, investing at least \$2 per capita in a community forestry program, and observing Arbor Day annually.

The Town of Lady Lake celebrates Arbor Day each April with community tree plantings. Over the last several years, the Town has planted trees in public spaces such as Lake County Fire Station 52 and Lady Lake Town Hall. This year, Parks and Recreation joined Public Works in a large-scale landscaping project along County Road 466, planting palm trees, crepe myrtles and zoysia grass, as well as updating the irrigation system.

On April 23 at 9:30 a.m., the Town invites the public to a tree planting ceremony outside the grounds of The Villages Elementary of Lady Lake.

Lady Lake is also currently hosting an annual Tree Raffle, providing residents with the opportunity to receive \$200 gift certificates to purchase trees from a local nursery. The raffle is funded through the town's tree bank, which is supported by developer contributions when tree preservation requirements cannot be fully met on-site.

Through its land development regulations, the town requires developers to contribute to the tree bank to offset tree removal, reinforcing Lady Lake's commitment to responsible growth and long-term environmental sustainability.

Communities recognized as Tree City USA demonstrate that thoughtful investment in trees contributes to cooler temperatures, improved air quality, increased property values and an enhanced

## The Villages Charter School



The Villages Charter School is taking agriculture education to the next level with a state-of-the-art hydroponic fodder farm. This innovative facility allows students to experience modern feed

production and agricultural technology firsthand.

Integrated into the school's agriscience and animal science programs, the modular system fosters experiential learning while introducing students to controlled

environment agriculture and its importance for resilient food systems.

Designed and manufactured by FarmBox Foods, the fodder farm is part of a larger initiative that includes deploying hydroponic fodder farms and vertical hydroponic farms across four Sumter County Schools.

The Villages Charter School, a K-12 workforce development hub, serves as an economic development tool for The Villages community, educating children whose parents work for The Villages corporation or its partner businesses.

Heather Chastain, who teaches agriscience foundations, agritechnology, and animal science, emphasizes that while the region is experiencing rapid growth, farming and livestock traditions remain strong, and residents remain deeply connected to agriculture. Her students are using the fodder farm as a research and production tool to study how the school's livestock respond to feed with higher

vitamin and mineral content. They're growing fresh barley fodder on-site and evaluating its potential to reduce feed costs and replace hay during winter when pasture grass is dormant.

The decision to purchase a fodder farm was partly driven by challenges following recent hurricanes, which caused flooding and limited access to grazing areas for extended periods.

Indoor feed production lets the program keep supporting livestock even when fields are inaccessible, making it better prepared for future storms. It also gives neighboring programs a helping hand during disruptions by keeping feed production going all year round.

Thanks to a partnership with Sumter County Schools, led by Casey Ferguson, director of career and technical education and adult education, the system got about \$1.7 million in grant funding. Ferguson looked at different container farming solutions and found FarmBox Foods to be

the best fit for both educational goals and practical needs across the district.

Students have quickly taken charge of the system. Two students take care of daily and weekly maintenance, while others help during harvest and feeding. The technology has attracted students who might not usually be interested in traditional animal agriculture because it emphasizes automation, data, and problem-solving. School leaders see the FarmBox Foods fodder farm as a great way to show how agriculture and technology are connected and to start conversations about resilience, sustainability, innovation, and food security in small rural communities.







**Attorney General James Uthmeier Launches Investigation into Discord over Child Safety Concerns**

**TALLAHASSEE, Fla.**—Attorney General James Uthmeier opened a civil investigation and

subpoenaed Discord, a popular online chat platform. The subpoena demands documents and information related to the platform's practices in marketing to children, enforcing age-verification requirements, content moderation, parental control features, and reporting of exploitative activity.

"Many of our criminal investigations into internet child predators lead to one place: Discord," said Attorney General James Uthmeier. "Groomers and predators seem to believe that they can get away with targeting children on Discord—and we are going to find out why. Discord owes us an explanation on the overwhelming use of its platform among predators, and what they are doing to protect children."

"Investigations show that offenders are using platforms like Roblox and Discord as an access point to reach children. Parents should know we are taking this seriously," said Sarasota County Sheriff Kurt A. Hoffman. "My message is clear, we are committed to protecting our kids, and predators have no safe place in our

community. If you exploit children, we will find you, arrest you, and hold you accountable."

Discord is widely used for online communication via messaging, audio, and video calls. The platform has increasingly been identified as a service that predators use to communicate with children and distribute and collect child sexual abuse material.

There have been many concerning reports indicating that predators initially contact minors on other platforms, including video games like Roblox and Fortnite, and then encourage them to move communications to Discord, which may be due to insufficient protections for children.

The subpoena seeks information and documents regarding Discord's practices in safeguarding children from being exposed to harmful content and being targeted by child predators. The filing suggests that Discord has potentially violated Florida's Deceptive and Unfair Trade Practices Act.

Attorney General Uthmeier is demanding Discord produce documents, including, but not limited to:

- Marketing and promotional materials that represent the platform's safety, suitability, and appropriateness for children.
- Documents relating to the marketing of Discord directly to children.
- Procedures relating to content and communication moderation.
- Records of complaints alleging exploitation, and records of responsive

steps taken.

- Documents describing age-verification processes and parent control features.
- Records of criminal cases involving children.
- Data on how many children are utilizing the platform.

This investigation is part of Attorney General Uthmeier's effort to investigate and bring accountability for the exploitative environment that has been created for children on social media websites and gaming platforms.

**Attorney General James Uthmeier Announces One Hundred Criminal Charges for Predator Arrested in Seminole County**

**TALLAHASSEE, Fla.**—Attorney General James Uthmeier announced the arrest of Blake McKinniss, 37, of Sanford. McKinniss faces 53 Counts of possession of Child Sexual Abuse Material (CSAM), 46 counts of possessing AI-generated CSAM, and one count of possessing a child-like sex doll. During a search of his house, law enforcement found a bedroom decorated for a little girl, even though no children lived there.

"Law enforcement and prosecutors walked into a house of horrors upon executing this search warrant," said Attorney General James Uthmeier. "This guy could spend the rest of his life in prison, and I'm grateful our team worked to ensure he never has access to our kids. I also thank Representative Plakon for supporting legislation to keep convicted predators away from children."

"I am honored to work alongside my

fellow legislators to protect Florida's children from those who exploit them through harmful materials," said Representative Rachel Plakon. "I extend my heartfelt gratitude to the Attorney General and our dedicated law enforcement agencies for their relentless efforts in enforcing these critical laws."

"FDLE remains steadfast in our mission to protect our most vulnerable from those who seek to harm them," said FDLE Special Agent in Charge Felipe Williams. "Our agents and law enforcement partners work every day to identify and remove dangerous predators from our communities. We have kept our word: if you think you can prey on our children, you are wrong. We will continue working with our partners and with Attorney General Uthmeier's team to ensure offenders are found and prosecuted to the fullest extent of the law."

The investigation began January 27, 2026, when the Florida Department of Law Enforcement (FDLE) received a cyber tip from the National Center for Missing and Exploited Children. The tip reported a user prompting the creation of CSAM using AI. The IP address led to McKinniss.

On March 9, 2026, FDLE executed a search warrant at the defendant's residence, where investigators located numerous files depicting CSAM on electronic devices belonging to McKinniss. Additionally, investigators found that McKinniss had children's bedrooms decorated, despite not being a parent. In these bedrooms, law enforcement found massive amounts of sexual paraphernalia, including child-like sex dolls, as well as children's toys and clothing.

## Governor Ron DeSantis Signs Legislation to Protect Florida's Coasts

**BRADENTON, Fla.** — Florida Governor Ron DeSantis signed two pieces of legislation aimed at protecting

Florida's coasts and strengthening coastal resilience and restoration efforts. The governor also announced plans to reopen the Sunshine Skyway fishing piers following reconstruction and rehabilitation projects. "My administration has delivered historic investments to protect Florida's 1,300 miles of coastline," said Governor Ron DeSantis. "Today, I signed legislation to preserve the Terra Ceia Bay and to build on our work to promote coastal resiliency and water quality statewide. We are committed to protecting Florida's environment for future generations to enjoy." "Protecting Florida's environment has been a top priority of the DeSantis Administration from day one," said Florida Department of Environmental Protection Secretary Alexis A. Lambert. "House Bill 1417 streamlines processes so the department can carry out its mission more efficiently while maintaining strong environmental protections, including ratifying a rule to restore the Lower Santa Fe and Ichetucknee rivers and their priority springs. Along with Senate Bill 302, which strengthens protections for the Terra Ceia Aquatic Preserve and supports nature-based solutions to improve coastal resilience, these bills help ensure Florida's natural resources remain strong for generations to come."

"Thank you Governor DeSantis for taking swift action to sign this legislation into law," said Senate Majority Leader Jim Boyd. "My amendment is a small part of this broader bill to strengthen coastal resiliency, but it will have a big impact on this region for decades to come. When a recent proposal threatened the future of the islands and coastlines that border the Terra Ceia Aquatic Preserve, I made a commitment to stop it. With this bill now signed into law, this region, the precious coastlines, pristine waters and wildlife habitats are effectively protected from massive transformations that would have destroyed them. Since I was a teen, I have explored these natural treasures, and now future generations will have the opportunity to see, enjoy and love the Terra Ceia we know today."

"Florida's natural resources are central to our economy, our way of life, and our future," said Representative Will Robinson. "This legislation takes historic steps toward environmental protection and resiliency, ensuring that our coastal communities stay strong, our waters stay clean, and our state is preserved for generations to come. I want to thank Governor DeSantis for signing this important legislation and for all the work he has done to conserve our state's natural habitats."

Governor Ron DeSantis signed Senate Bill 302 and House Bill 1417 into law.

Senate Bill 302 protects the *Terra Ceia Aquatic Preserve* by prohibiting the dredging or filling of submerged lands, allowing for passive recreational fishing and boating rather than commercial transportation in these sensitive waters. The legislation ensures that any future changes to the preserve must go through a transparent, state-level approval process. It also strengthens Florida's coastal resiliency by expanding the use of nature-based solutions to rehabilitate wetlands, restore oyster reefs, and increase the mangroves along the Florida peninsula. In addition, the bill streamlines permitting, accelerates restoration timelines, and enables the use of new technologies to enhance coastal protection efforts. Together, these measures safeguard vulnerable habitats, reduce erosion and storm surge risks, and preserve Florida's natural coastline.

House Bill 1417 streamlines environmental rulemaking by repealing the outdated Environmental Regulation Commission making it faster to update rules to protect our environment and keep our economy thriving. It also ratifies rules to ensure sufficient water supply along the Lower Santa Fe and Ichetucknee Rivers, vital water resources for our North Florida communities. Finally, the bill makes certain that stormwater management around solar fields is rigorous to protect both the environment and adjacent property owners.

Governor DeSantis also announced updates to *Florida's Sunshine Skyway fishing piers*, letting Floridians know that reconstruction and renewal projects on the north and south piers are now underway. A new pier will be built on the Manatee County side, and the existing Pinellas County side will be improved and extended. Early work includes enhancements to parking areas and the addition of wider sidewalks along the seawall to improve access and safety.

### MILESTONE: More Than 10,000 Bonuses of \$5,000 Awarded to New Law Enforcement Recruits

**NAPLES, Fla.** — Governor Ron DeSantis announced that Florida has reached the milestone of more than 10,000 bonuses awarded through the Florida Law Enforcement Recruitment Bonus Program. Launched in 2022, this first-of-its-kind initiative underscores Florida's commitment to supporting Florida law enforcement officers. The latest round of bonuses—totaling more than \$5 million—went to 744 officers across the state.

"Today in Naples, I was proud to announce a milestone for Florida's Law Enforcement Recruitment Bonus Program: More than 10,000 bonus payments of \$5,000 after-tax have now been distributed to law enforcement personnel across our state," said Governor Ron DeSantis. "Many of these new recruits have relocated to Florida from states where law enforcement has been defunded or demoralized by radical political agendas. We're fortunate to have them here, and Floridians are grateful for their service every day."

"This milestone of more than 10,000 recruitment bonuses is a tremendous achievement for our state and the dedicated

men and women who choose to protect our communities," said Secretary of Commerce J. Alex Kelly. "Thanks to Governor DeSantis' leadership, these bonuses not only help our new officers and their families get settled, but they also strengthen our neighborhoods, improve public safety and support the long-term well-being of communities throughout Florida."

The program provides a one-time \$5,000 bonus—after taxes—to newly relocated and employed officers as a show of appreciation and incentive for choosing to serve in Florida. Each of the more than 10,000 newly recruited officers has received a \$5,000 bonus after taxes, with the program distributing more than \$67.9 million to date.

The bonuses are part of a broader initiative to solidify Florida's position as the Nation's law-and-order state. Under the Fiscal Year 2025-26 budget, [the Governor secured \\$49 million in pay increases](#) for more than 16,200 state sworn law enforcement officers, raised the minimum base pay to \$60,000, and provided significant raises for both entry-level and veteran officers—10% and 15% increases, respectively. The state has also expanded wellness resources, enhanced penalties for crimes against officers, introduced law enforcement education programs in high schools, and launched the Florida Law Enforcement Academy Scholarship Program to cover training costs for new recruits.

In addition to a \$5,000 recruitment bonus, benefits of becoming a Florida law enforcement officer include financial stability, upward mobility, excellent health and retirement benefits, student loan forgiveness programs, home loan programs, and more.


