### NOTARY FRAUD?

Apparently the assumed protection of using a NOTARY is bogus!

To be recorded, a document/deed has to be notarized.

The State of Florida is supposed to 'register and regulate' Public Notaries.

Your County Recording Department does not verify, or even check that a document is genuine.

Your County Recording Department does not verify or check that the Notary even exists!

Their excuse is 'High Volume'.

For example, down in Orange County, Florida they might process as many as 3,000 recordings in a single day.

The Recording Department's excuse is that "State Law, mandates that documents MUST be accepted for recording".

But the law also includes the requirement "IF they comply with certain minimum requirements".

So, the question is "Should these fraudulent documents be recorded, when they are not in compliance with the law, because they were not (legally) notarized?".

Q-Shouldn't Recording Officials be held responsible for verifying that, in fact, submitted documents do, in fact, comply with the law?

Isn't verification of notaries available, from the State, on line, in minutes?

Keep in mind that, when you bought or sold your home, the deed was notarized.

Who was that notary?

Fact is, no-one knows and no-one cares.

A Notary 'registration' can be easily purchased 'on-line' along with the name stamp which you see on your deed and mortgage.

What might be even worse, is that a forged deed or mortgage can then be recorded against your home.

So now, while you're out of state or on a trip, the fraudster can sell your house, take the money and run.

For whatever reason, your State Senator, Representative, State Attorney or anyone else in government or law enforcement will say it's not their problem..

It's up to you, at your expense, to try to get your house back.

NOTE:- One reader claimed "Not a problem for me. I have Title Insurance."

I told him to call his lawyer who might tell him, "Title insurance covers the Chain of Title PRIOR to your purchase. Anything thereafter is on you".

There is an increasing number cases where deeds are fraudulently notarized and recorded.

So, don't be surprised if a friend or neighbor calls to to say, "Hey, didn't know you were selling your house. Why didn't you tell us?"

You say, "Are you kidding? We're not selling."

Then they tell you "Well, there's a new "For Sale" sign in your front yard."

Or, worse, they ask you "Hey, you sold your house?"

You reply "Hell no!"

They say, "I guess you did, because we just met our new neighbors!"

Unfortunately it is happening every day, right now.

Another reader claimed "I pay for protection from (Life-Lock or similar?)"

Fact is these companies claim to help you get your house back, No prevention there?.

As I See It, prevention is better than cure!

It's unbelievable that you can 'protect/suspend' your credit, but there is no law or procedure in law which 'freezes' the ownership of your home.

It will take a much louder voice than mine to get anything done.

But, if there's one issue which should UNITE every American, regardless of race, religion ethnicity, democrat or republican it is this!

Why not start with the Governor and all the candidates running in the upcoming election?

Maybe write up a (notarized, fake) deed to each one's house.

Then, at the rally or press conference, ask them "Is this a recordable deed to your house?"

Q-Is it a crime if you don't try to record it?

A-Maybe not, if you say it's a fake, and it is a fake, where's the deception?

## Simple Whole Wheat Bread



Make sure the egg and oil are at room temperature and be sure to aerate your flour before measuring. No mixer? Just mix it in a bowl by hand but knead longer, about 150 turns. (This recipe also works with all white flour)

### Ingredients:

- 2 cups whole wheat flour (Sift Flour Before Measuring)
- 1/2 cup bread flour or all-purpose flour
- 2 teaspoons (1 packet) instant yeast (or active dry yeast)
- 2 Tablespoons sugar (or honey but add honey after the milk)
- 1 teaspoon salt
- 1 cup milk (reduced fat or whole milk), heated to 120-130° F for instant yeast (or 110-120° F for active dry)
- 2 Tablespoons olive oil (or any vegetable oil)
- 1 egg
- about 1/4 cup additional bread flour

### Instructions:

- Place flours, yeast, sugar & salt in a large mixing bowl.
- Stir in milk, followed by oil and egg.
- Beat on high for 2 minutes.
- On low speed add about 1/4 cup bread flour until dough forms a mass.
- Place dough on floured surface and knead 50 turns.
- Cover and let rest 10 minutes.
- Shape dough into a loaf and place in a greased 8 1/2 x 4 1/2 x 2 3/4-inch loaf pan.
- Cover with a towel and let rise in a warm

spot until it's one inch taller than the pan, about 35 minutes.

- Meantime, preheat oven to 375° F.
- Bake for 30 minutes. After the first 15 minutes, cover the top of the loaf with a foil tent to prevent over-browning.
- Remove immediately from pan onto a cooling rack. Let it cool at least 10 minutes before slicing.

## Andrew Gillum Indicted

### Former Dem Candidate Andrew Gillum Indicted

Gillum, once mayor of Tallahassee, is accused of acting in concert with associate Sharon Janet Lettman-Hicks to solicit funds using false representations and promises.

"The indictment further alleges the defendants used third parties to divert a portion of those funds to a company owned by Lettman-Hicks, who then fraudulently provided the funds, disguised as payroll payments, to Gillum for his personal use," a Justice Department press release said.

Gillum is also charged with making a false statement to the FBI. He denied wrongdoing and said the case was political.

Gillum ran for governor of Florida with the Democratic nomination in 2018, nearly defeating Ron Desantis.

Since then, he has been no stranger to trouble.

In 2019, state officials brought an ethics complaint against Gillum after finding probable cause that he committed ethics violations involving gifts from lobbyists in 2016.

In 2020, Gillum entered rehab; police found him unresponsive in a Miami Beach hotel room with two other men, where officers found what they believed to be crystal methamphetamine.

Gillum denied using drugs but did admit to struggling with alcohol.

The bill creates an Office of Election Crimes and Security within the Department of State (DOS) to aid the Secretary of State in completion of existing duties relating to election fraud. The Office will, review reports of alleged election law violations or election irregularities; initiate independent inquiries and conduct preliminary

investigations; oversee the voter fraud hotline; and employ non sworn investigators to conduct any investigations. Investigations can be forwarded to law enforcement agencies or prosecutors when/if necessary.

As always, it is an honor to be your Senator and we look forward to continuing to serve you for the next two years in the Florida Senate.

vehicle—transforming lifesaving devices into life-threatening ones. The risk associated with defective airbags is even greater in hot and humid conditions.

That's why it's critical that you check your vehicle for recalled airbags and get them repaired at an authorized dealer. You can find out if your vehicle has an open recall by visiting [CheckToProtect.org](https://www.checktoprotect.org) and entering your license plate number or Vehicle Identification Number (VIN). The 17-character VIN is located on the driver's side dashboard near the windshield and can be found on insurance and registration documents.

Repairs are paid by your vehicle manufacturer, regardless of where or from whom you bought the vehicle, whether you

Ken was in the Royal Navy and wrote for the Seniors Voice and Ocala DownTown newspapers. He wrote for his own satisfaction and was well accepted by our readers especially Veterans. He was always volunteering at Veteran Park Ocala. He recalled one time, when I could get him to talk about his service, he said the ship he was on was blown up and hundreds of men were in the water at night praying for a rescue ship. He recalled the Sharks were taking men around him. It was very scary for a time but he and many others were rescued by an American ship. After several years Ken left TomL Publishing to write his own blog, I recalled after his wife passed away he said he did not like to deadline write any more even on a monthly. We thanked him very much for his service and for writing his column.

One more story with me as an eye witness. I was invited to the Rotary Club Breakfast in the Villages some years back by a some veteran's from the Villages. I think he was a retired Marine officer

himself. He was bringing a special speaker who had a special story and they wanted me to hear it! Sorry I can't recall the name, as he started his story he said he was the last man alive that put up the flag at Iwo Jima . That day the battle was raging, bullets were flying all around them they climb this mountain their job was to take position of the island and claim it as American victory against the Japanese, once that was done they would go help with the clean up of the enemy forces on the island. There were several ships watching the battle from the sea, a cargo ships Admiral looking through his Binocular saw the men raising the flag and was so inspired that he thought that a picture of that would make a good inspiration for the American people to see back home and the troops fighting on the Island. So he ordered a photographer to find a Big Flag and off load to the mountain where the smaller flag was raised recreate the event with the original troops. When the photographer got there the men who actually raised the flag were off fighting on a different part of the island. With the original men gone the photographer was ordered to get some men to reenact the event which he did. Actually three of the men that raised the first flag died in combat soon after that. So the picture you see is a reenactment. When ask why did you come forward to tell your story now he said I'm the last one left alive and I want people to know the truth in honor of the marines who really raised the flag.

The iconic photo that went viral was taken by Joe Rosenthal. The photograph won the Pulitzer prize in 1945.

When I look at the history of this event there were several accounts. I tend to agree with this man account he seemed very siencere. The Retired military man who brought him said he was the real deal!

often striking victims catching them off guard or while sleeping. It is poisonous and can cause headaches, fatigue, shortness of breath, nausea, and dizziness. In severe cases, exposure to this gas can cause neurological damage, mental confusion, vomiting, loss of muscular coordination, loss of consciousness, and death.

- Prevention and Protection:**
- Have a battery operated or battery backup carbon monoxide detector in the hallway near each sleeping area in the house. A carbon monoxide detector in the workplace is a good idea as well. Check the batteries monthly.
  - Never warm vehicles in a closed garage, especially if it is an attached garage. Carbon monoxide will build up quickly even if the garage door is open.
  - Heating systems and other gas or coal burning appliances should be serviced every year by a qualified person.
  - Do not use portable flameless chemical heaters indoors and do not use the oven to heat your home.

- Have your chimney checked and cleaned every year, and make sure your fireplace damper is open before lighting a fire and well after the fire is extinguished.
- Do not use generators inside your home, garage, or near the outside of windows, doors, or vents.
- Test the air regularly if you are in a confined space.
- Know the signs of exposure. Training and educating are vital.

**Employee Responsibilities for Carbon Monoxide Safety**

- When a Carbon Monoxide alarm sounds, immediately move outside and call 911. Make sure all people are accounted for.
- Report any complaints of nausea or dizziness.
- If you suspect carbon monoxide poisoning, immediately leave the area, and move outside.
- Beware of potential ventilation problems, especially in closed areas.
- Do not use gas or gasoline powered engines or tools in closed areas.
- Use effective ventilation systems to reduce carbon monoxide poisoning at the workplace.
- Do not reenter the premises until emergency responders clear the building and deem it safe.
- These tips go for a residential home as well.

## Disinformation and Misinterpretation

### Building Trust In An Era Of Misinformation, Disinformation and Misinterpretation

As public health information programs are developed, there has been increasing scrutiny of the veracity of the content, in the Fake News era. Persuading the public to act requires a professional communications plan that is resilient to change and includes agile responses to new information.

Like the game of telephone, that we played as children, in which a message is whispered from one person to the next, all around a circle, until it comes back sounding like a vastly different story, so too, even with the best of intentions, can information lead to a chain reaction of misinformation. Some bad actors start off whispering a story that is untrue, which makes matters worse and the public less trusting of the news, even if it is from a reliable source.

Trust has to be earned for meaningful change to take place. The best way to earn trust is to tell the truth, consistently, citing credible sources, such as the government, doctors, scientists, or other reputable

experts whose word should be beyond reproach. Even the best sources can make mistakes, which should be corrected as soon as possible, as new information becomes available and situations evolve.

As we watch the leaders of our society trying to set a good example by exhibiting the desired behavior, which is helpful, it would be even better if we could see case studies of people who have actually benefited from following the recommended course of action. It takes time to build trust, which becomes easier when people start to see that a plan is working.

An easy way to earn trust is to have the helpful information repeated again and again in a wide variety of prestigious news media, which people turn to regularly as their primary source of information about new developments and strategies for protecting their health and safety.

Traditional media that is hyperlocal, followed by millions regularly, is a highly trusted resource for health experts to disseminate their helpful advice. Journalists are willing to share information, which could help save lives, if it is from medical experts that are reputable and trustworthy. Statistics should be credible, including the source of the information, such as a survey, a study, a trade association, the government, or the opinion of a doctor.

Some like to use celebrity spokespeople, but if they are paid, that must be disclosed, and they will only be credible if they have had a real life experience that relates to the news to be shared.

The public needs to know what the benefit is of the message that is being conveyed and how they can believe that the information is accurate. If the information is helpful, and shown to be true, people will follow advice like a bee to honey.

### **New Seaports Report Shows Florida's Ports Well-Positioned to Take Advantage of Realignment in Global Trade Routes**

*Florida's "Open for Business" Strategy Answering Supply Chain Demands*

**TALLAHASSEE, Fla. (July 13, 2022)**— Strong investments in Florida's 15 seaports have well-positioned Florida to answer supply chain demands, and take advantage of a realignment in global trade routes, a new report shows. The Seaport Mission Plan, Florida Ports: Open for Business, released by the Florida Seaport Transportation and Economic Development Council (FSTED), provides an analysis on the health and capabilities of Florida ports, as well as trends on the horizon.

The report comes as 29 West Coast ports are working without a negotiated labor contract, and many shippers have already changed lanes to reroute to East Coast ports in fears that 2022 labor negotiations could lead to similar strikes, lockouts and slowdowns that occurred in 2002, 2008, 2012 and 2014.

"Florida's continued investment in our

seaports have made it a destination for companies from around the world frustrated with the logjams at Pacific coast ports," said **Governor Ron DeSantis**. "We will continue to make the investments necessary to bolster our supply chain and improve our infrastructure to bring more business to Florida's seaports."

"Florida's seaports are flexing their muscles, and seizing the opportunity to become a global hub by capturing an even larger share of international trade and related commercial activities," said **Michael Rubin**, FSTED Program Administrator.

Indeed, since the unprecedented economic and supply chain upheaval caused by the pandemic, it's clear that Florida ports can support current demand and grow into the future, the report says.

Further, Florida's strong performance has resulted in global shipping lines changing trade lanes to specifically call on Florida ports — this includes new direct Asia services. Chief among the new lines of business recently secured are:

- The first vessel in global ocean carrier Sea Lead Shipping Pte Ltd's new Asia East Coast container service making its inaugural call to **JAXPORT** in June.

- A new direct Asia service is now calling on **Port Tampa Bay**, and new service connections with Mexico and Central America have been secured.

- MSC has launched its new Zephyr service from northern China and South Korea to the U.S. Gulf Coast, and it includes a direct call to **Port Everglades**...

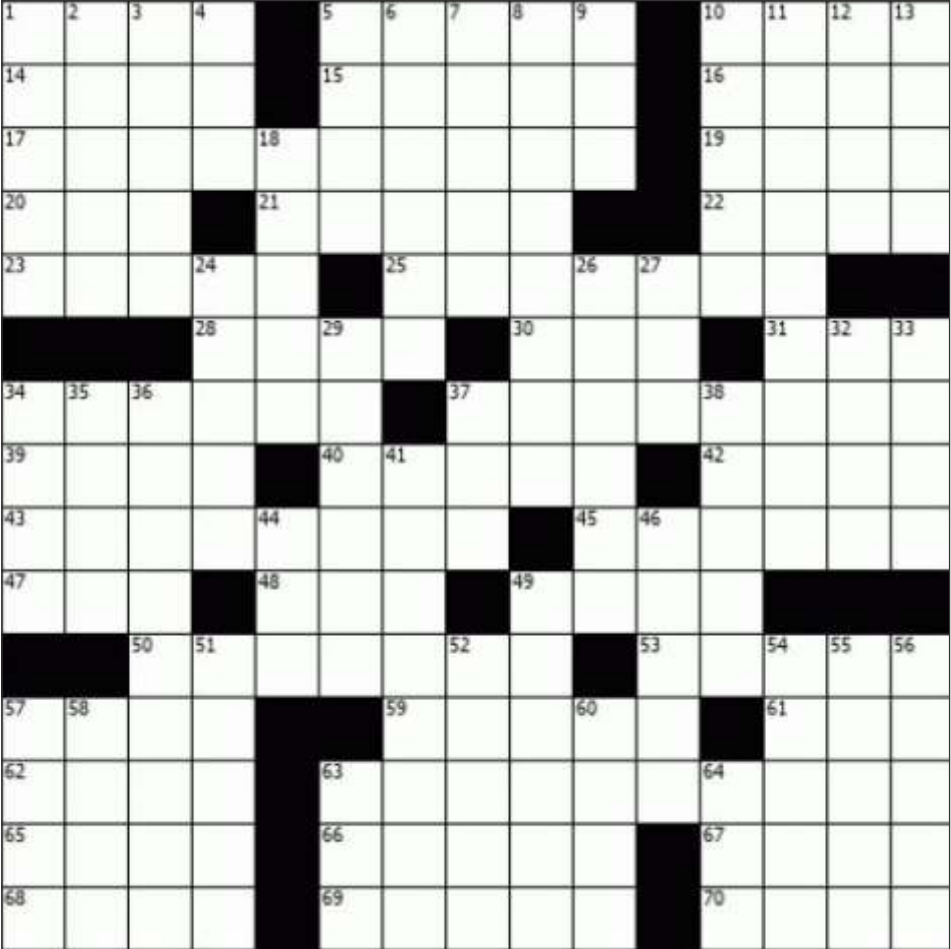

Port investments have been essential to seaports seizing the opportunity to connect more commerce and strengthen Florida's economy. Of the \$4.5 billion in seaport capital improvements identified over the next five years, 75.1 percent is being made in Atlantic coast seaports, with the remaining 24.9 percent being made by Gulf coast seaports. The largest planned investments are for:

TALLAHASSEE, Fla.—Continuing the Summer Scams

Series, Attorney General Ashley Moody is issuing a Consumer Alert to warn Floridians about potential online shopping scams. Many online retailers host huge summer sales. Scammers may mimic these legitimate events to target consumers with malware, phishing texts and other messages designed to steal personal or financial information.

Attorney General Ashley Moody said, "Summer sales are a popular way for online retailers to attract customers and promote seasonal items. Scammers know this and may exploit these shopping events by posing as representatives of major retailers to steal money or personal information from unsuspecting consumers. As we continue our Summer Scam Series, I am asking consumers to take a few proactive steps to avoid fake emails, text messages and websites designed to impersonate legitimate companies."

Attorney General Moody warns Floridians about four tactics used by scammers to target online shoppers:

- Copypcat websites that look dangerously similar to, or even exactly like, the legitimate store's website. Pay close attention to the website URL.

- Fake security alert emails claiming a target's online account is compromised—often asking for users to verify billing names, addresses and telephone numbers. These messages can be linked to malware or may be used to steal information. Verify the message's legitimacy by calling the company and asking about the email.

- Falsified order confirmations and package delivery updates use the same fake email concept of the security-alert scam, except they target different steps in the ordering process—making the entire scam seem more realistic.

- Spoofed phone calls can be made to look like they originate from a legitimate company's number. These phone calls may offer raffles, warn about security issues, ask the receiver to take a survey or use other tactics. Most companies will not call and attempt to convince a customer to pay for anything over the phone, ask for a customer's personal information or offer an unexpected refund. Hang up immediately if this is the case.

Ahead of the popular online shopping day, Cyber Monday, Attorney General Moody released tips to help online shoppers avoid retail-related scams.

Another resource provided by Attorney General Moody is *Scams at a Glance: Protect our Patriots*. This quick-reference tool provides tips for avoiding fraudulent schemes. Attorney General Moody also staffs a Military and Veterans Assistance Program within the Consumer Protection Division that aids service members dealing with fraud and related issues.

Attorney General Ashley Moody said, "This Military Consumer Protection Month, we are highlighting some of our resources designed to help protect those brave Americans who sacrifice so much in service to our nation. Sadly, some scammers attempt to exploit the military through scams designed to prey on service members, veterans and their families. Anyone who encounters one of these scams should contact my office immediately."

Attorney General Moody is encouraging all service members and veterans to consider the following tips to avoid falling

victim to military-related scams:

- Beware of scammers using misleading photos or language to imply association with a branch of the military;
- Know that phishing schemes use manipulated messages that appear to be from a military branch or the U.S. Department of Veterans Affairs in an effort to target service members, veterans or family members;
- Research charities soliciting funds by checking the Better Business Bureau's Wise Giving Alliance at [Give.org](https://www.bbb.org/wise-giving), or Charity Navigator at [CharityNavigator.org](https://www.charitynavigator.org), to determine if the organization has complaints against it; and
- Place an active-duty alert on credit reports at no cost. An active-duty alert requires businesses to take additional steps before granting credit in the name of active-duty personnel serving overseas.

Another resource available to help service members and their families is *Scams at a Glance: Protect our Patriots*. This easy-to-share tool provides additional information about common schemes targeting Florida's military community.

## Newspapers Are Alive And Well

### ...And Thriving

As the world has become increasingly digital, print marketing has kept pace or exceeded performance of online offerings. With fewer printed publications and fewer pages being printed, the value of information in newspapers has increased, due to a greater likelihood of being seen, as people are more easily able to read small, suburban community newspapers, cover to cover in a short amount of time. The digital versions of newspapers often have many more pages, as there is comparatively little cost to adding more and more content online.

As online publications are inundated with thousands of requests per day for inclusion of branded content, and the volume of site traffic remains relatively stable, the value of each individual placement in the online versions of newspapers is diminished and diluted by the influx of new information.

The visibility of the printed word as compared with the value of the same word in online versions, has always been far greater, by any measure, which is reflected in the cost of getting seen in newspapers in print versus the digital publication. As the gap widens, and digital publications add more and more pages for sponsored content, advertorials, and the like, the value of the printed word will increase.

regular consumption of peanuts has been shown to: reduce Alzheimer's disease risk by 70%; reduce diabetes risk by 53% and cardiovascular disease risk by 13%; and aid memory, cognitive function and concentration. Daily consumption can even help reduce anxiety and depression.

**The Science**

The benefits of plant-based protein are becoming more and more apparent. Research that compared nuts and legumes to animal protein showed higher intake from meat was associated with increased mortality risk. Another study found that

replacing animal-based protein with plant-based protein can substantially lower the likelihood of developing diabetes. Finally, an interesting study of older adults found that faster walking speed was associated with a higher intake of plant protein, while slower walking speed was associated with greater animal protein intake.

**Tasty Peanut Ramen Ingredients**

- 1 (3 oz.) package ramen
- 1 Tbsp shallot, diced
- 2 tsp minced garlic
- 1/2 cup shredded carrot
- 1/2 cup sliced mushrooms
- 1/2 cup coleslaw blend or chopped broccoli florets
- 1/2 cup red pepper, large dice
- 1/4 cup peanut butter
- 1/2 cup - 2/3 cup water
- 1 Tbsp soy sauce
- 1 Tbsp brown sugar
- 1 Tbsp Sriracha
- 1/4 cup roasted peanuts, chopped
- 1 Tbsp cilantro, for garnish

**Directions**

Cook ramen according to package directions. Strain noodles and set aside. In a medium sauté pan, warm 1 Tbsp of oil over medium high heat. Add shallot and garlic and cook until aromatic. Add mushrooms to pan, sauté until tender. Combine carrots, broccoli and red pepper into the pan and sauté about 2 minutes. Remove from the pan. Combine water, peanut butter, soy sauce, brown sugar and Sriracha in the pan. Simmer and reduce until sauce is thickened, about 2 minutes. Top ramen noodles with

sauce and combine well. Top with vegetables, chopped peanuts, and cilantro.

For those targeting Boomers or seniors, who generally read more in print than online, the disparity is especially appreciated.

For those targeting Millennials, they will reach more if they cover print than if they don't, both directly, as many read newspapers, starting with High School and College newspapers, and as a result of referred traffic from peers, co-workers, friends and family members. The printed versions can easily be shared online as many are replicated as a pdf version on an affiliated digital site with social media channels. Some take a picture of articles to share.

All things considered, here are five good reasons to add print media to your marketing mix:

1- Printed Newspapers Trigger Multiple Senses: Many people seek time away from touching their mobile phones, computer keyboards, and TV remote controls. It's nice to get the feel of a printed newspaper or magazine, with glossy pages, the smell of the ink, and the sounds of the pages flipping, which have been simulated online in digital flip books, by popular demand. It's easier to see a printed page in bright sunlight, instead of the glare or reflection on a screen.

2- Print Engages More Readily: Content that lives online doesn't engage as well if it is in an abbreviated format, requiring readers to click through to another page to see the rest of the article. Many readers are impatient when reading online, feeling they

### Rep. Cammack Issues Statement On Dobbs v. Jackson Supreme Court

WASHINGTON, D.C.— Congresswoman Kat Cammack (R-FL-03) issued the following statement following the Supreme Court's release of its decision in the *Dobbs v. Jackson* case.

"The monumental news in *Dobbs v. Jackson* is historic. Since the founding of our nation, life, liberty, and the pursuit of happiness have been key tenets in the United States, and this news has solidified our most basic right—the right to life. For the most vulnerable among us, this decision affirms the undeniable value of life and the protection and respect for all unborn children. This is a historic day. Life wins!"

### Rep. Cammack Joins Rep. Gimenez As Co-Sponsor On Migrant Protection Protocols Act Of 2022

WASHINGTON, D.C. — Congresswoman Kat Cammack (R-FL-03) joined Congressman Gimenez (R-FL-26) as an original co-sponsor of the Migrant Protection Protocols Act, which seeks to amend the Immigration and Nationality Act to codify President Trump's "Remain in Mexico" policy.

The Migrant Protection Protocols Act of 2019, otherwise known as the "Remain in Mexico" policy, ensured that migrants were returned to Mexico for the duration of their immigration proceedings and were given a notice to appear in an immigration court rather than being let loose in the United States. This policy was highly effective in securing our southern border as it enabled the Department of Homeland Security (DHS) to establish a safe and orderly immigration process. Under MPP, Customs and Border Patrol (CBP) were able to regulate the inflow of migrants, process those who followed the law and properly applied for asylum, and curb the ability of smugglers and traffickers to prey on vulnerable populations.

Now, however, the weak and gutless decision by the Biden administration to

reverse the Remain in Mexico Policy incentivizes Mexico to pass its border security responsibilities to the United States rather than dealing with the influx of migrants from Central and South America at the Mexican border.

"The Supreme Court's decision to end the Migration Protection Protocols was a devastating blow to our border and national security," said Rep. Cammack. "One of the only remaining tools at our agents' disposal, the border crisis will only worsen without the necessary steps taken to safeguard MPP and its demonstrated success. I'm glad to join Rep. Gimenez and my colleagues in enshrining MPP into law and returning law and order to the southern border with this important change."

"...Right now, the vast majority of migrants seeking asylum from their home countries are not actually from Mexico, but rather, Guatemala, Honduras, El Salvador, Nicaragua, and even countries such as Cuba, Haiti, and beyond," said Rep. Gimenez. "If the true intent of these migrants is to seek refuge from brutal regimes and harsh living conditions in their home countries, then it would make sense for them to apply for asylum in Mexico rather than engage in the dangerous and treacherous journey to the United States."

The Migration Protection Protocols Act of 2022 has been endorsed by FreedomWorks.

"President Trump's Migrant Protection Protocols (MPP) represented one of the most successful immigration policies in recent memory," said FreedomWorks President Adam Brandon after endorsing the legislation. "Unfortunately, President Biden has attempted to terminate it since his first day in office. Congressman Gimenez's Migrant Protection Protocols Act of 2022 requires MPP to remain in effect, and represents a commonsense solution in response to the Biden Administration's outright refusal to enforce immigration law."

Original co-sponsors include Reps. Kat Cammack (FL), Chris Smith (NJ), John Rutherford (FL), and Tedd Budd (NC).

don't have time to stop and read a whole article or blog post, so they merely skim, scan and move on to the next. Print readers tend to slow down and actually read, not only the news, but also the ads, especially those that are native and relevant to the adjacent articles they read.

3- Brains React Differently To Paper Than Screens: The human brain processes information differently depending on the presentation in print or on a screen. Readers of print have longer attention spans because screens have far more distractions. The act of deep reading, which occurs more naturally in print, creates deep thinking, which means readers can become fully engrossed in the content. When readers see relevant sponsored content next to the publisher generated content, they are more easily swayed to think about that as well.

4- Print Drives Online Engagement: To get people to take action and interact more with your brand, you can capture attention in printed media and drive your audience to your online assets.

5- Adding Newspapers To The Mix Increases ROI: For the message you worked so hard to craft and deliver online, you can get more mileage out of it, for very little extra cost, by covering print media, to reach more people in your target audience, and to achieve goal oriented outcomes.
