Dear Friends,
We sincerely hope that all of you made it safely through Hurricane Idalia. As we near the end of hurricane season, we have officially made it to the beginning of committee

meetings, which started on October 9th. As a reminder, The committees that I have been assigned to are Agriculture, Appropriations, Appropriations Committee on Criminal and Civil Justice, Appropriations Committee on Health and Human Services, Children, Families, and Elder Affairs, Community Affairs, Military and Veterans Affairs, Space, and Domestic Security, and Rules.

To better prepare for the upcoming legislative session, the Lake County Legislative Delegation held their annual legislative delegation meeting on August 22nd. This annual public meeting is an opportunity for citizens, elected officials, cities and local governments, and other civic organizations to address the delegation before the start of the next legislative session. This meeting was inspiring and fruitful. It is always encouraging to see the community come together to express their ideas and to take an active part in their government. Since Senate District 13 covers all of Lake County and West Orange

County, we will also be attending the Orange County Legislative Delegation meeting on November 29th for further insight into the concerns and needs of our constituents.

On another note, we have begun the implementation of one of the many important pieces of legislation that was passed during the 2023 Legislative Session – House Bill 1: Education. In a show of good faith, incorporating recommendations from the Florida Association of District School Superintendents, led by former Senator Bill Montford, this bill took the first step towards reducing onerous and excessive regulations on public schools with several immediate revisions to Florida's Education Code. For example, the bill reduces hurdles to a 5-year temporary teacher certificate for anyone with a bachelor's degree and for those with three years of effective or highly effective service. The bill repeals the requirement that a student take one online course in order to graduate from high school, which is not currently required in private schools. The bill also offers districts flexibility in facility costs for new construction, and offers student transportation flexibility to improve efficiency, while maintaining student safety. To reduce additional regulation on public schools, the next step in implementing HB 1 is for the State Board of Education to review the entirety of the Florida Early Learning-20 Education Code for potential repeals and revisions to be considered during the 2024 Legislative Session. HB 1 requires the

Board to consider input from teachers, superintendents, administrators, school boards, public and private postsecondary institutions, home educators, and other entities, and that process is ongoing.

Thank you for taking the time to read this letter. We hope that it will encourage you to

attend your local legislative delegation meeting as well as shed some light on an important legislative priority that the Florida Legislature will continue to focus on during the next session.

FAIRtax



I've often heard people say that the FAIRtax is unfair to the poor and the wealthy won't pay their fair share. That is NOT true. I've also heard that it is unfair that the wealthy get the same prebate as everyone else. Again, NOT true. Let's also remember that the "net" tax rate differs greatly from your "effective" tax rate (the rate you actually pay).

Let's look at a billionaire under the FAIRtax and assume he is married with no children. If he spends \$10,000,000 he is paying \$2,300,000 in taxes and gets a prebate of \$4,697 then his effective tax rate as a percentage of spending is 22.95 percent.

Now let's look at a middle-income married couple with no children under the FAIRtax. If they spend \$50,000 they pay \$6,803 net of their prebate for an effective rate of 13.6 percent. The effective rate increases as spending increases, but never exceeds 23 percent.

In contrast, if the same couple earns \$50,000 in wages today under the current

income tax system, they pay \$4,093 in income taxes and \$3,825 in payroll taxes for a total of \$7,918 or 15.8 percent. That's a tax burden 14.1 percent higher than under the FAIRtax. In addition, their employer pays another \$3,825 in payroll taxes. Most economists agree that the employer payroll tax is actually borne by the employees in the form of lower wages. Looking at it this way, this couple is paying \$11,743 (23.5 percent) in taxes today which does not include the hidden taxes they pay every time they purchase an item.

Finally, let's look at a low-income couple that spends at the poverty level under the FAIRtax. They pay no net FAIRtax at all as the prebate effectively eliminates their taxes on spending up to the poverty level. However, under today's income tax, this couple not only pays 15 percent in payroll taxes but also pays the hidden taxes arising from corporate taxes, private sector compliance costs and payroll taxes passed on to consumers and embedded in the price of everything they buy.

Help Kids SEE a Good Education



(NAPSI)—If any of the approximately 74 million schoolchildren in the U.S. is someone you care about, here's something you may want to look into: According to the National Institutes of Health (NIH), visual health can have a great influence on students' academic performance. Visual disorders, the NIH says, are one of the best predictors of educational success.

A Look Into The Eye

The eye is literally an extension of the brain. It is estimated that more than 60% of the brain has some duties associated with vision input, the American Optometric Association points out. Because of this, any condition that hampers vision or the processing of vision may result in learning problems. When diagnosed and treated early, however, most individuals have a better chance of learning efficiently.

That's one reason the U.S. Preventative Services Task Force recommends children between the ages of 3 and 5 get vision screening to reveal problems that may lead to blindness without early treatment.

So, many students, teachers, and parents may be glad to learn about an improved way to test children's vision.

Seeing Vision Problems Clearly

A handheld, portable device called the Welch Allyn Spot Vision Screener by Baxter has been designed to help quickly and easily detect the risk factors of amblyopia and other vision issues in children as young as six months, all done from a non-invasive, three-foot distance. A bright touchscreen displays instant results, indicating whether measurements are in range or a complete eye

exam is recommended.

The machine objectively measures refractive errors and alignment between the eyes, which helps identify six risk factors of amblyopia. Select photo screening devices can examine both eyes at once and can take only a few seconds to perform the screening.

Results are easy to interpret and can be shared with family and other eye care specialists. It can easily be used in pediatric offices, schools and community vision screenings. The American Academy of Pediatrics and American Association for Pediatric Ophthalmology and Strabismus recommend the use of photo screening instruments in young children.

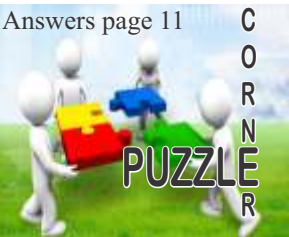
The Effectiveness of Photo Screening

A study performed by researchers at Virginia Commonwealth University found that photo screening correctly identified more students in need of a comprehensive eye exam than an ordinary screening could. The study also showed that instrument-based screening is time efficient and can be performed in a quarter of the time of visual acuity screening.

One Family's Story

The Malpass family, based in Washington State, includes two active boys, Miles, 12, and Parker, 8, who love to play all sorts of sports and are avid readers. When Miles complained that he could not see well out of his right eye, their parents had both boys looked at with a Spot Vision Screener. It was discovered that each boy's eyes were slightly different sizes, causing a refractive error in the bad eye. The brain prefers to use the dominant eye, which made the vision worse in the non-dominant eye. An ordinary eye chart test at school had failed to catch the problem. Fortunately, it was correctable and both boys now wear glasses and see well at school and on the playing fields and ski slopes.

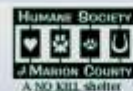

FROM THE DESK OF ATTORNEY GENERAL MOODY



ATTORNEY GENERAL MOODY CALLS ON CONGRESS TO INVESTIGATE AI AND CHILD EXPLOITATION

TALLAHASSEE, Fla.—Attorney General Ashley Moody is calling on the U.S. Congress to study artificial intelligence and the technology's potential harmful effects on children. Attorney General Moody, along with 53 other attorneys general, is urging congressional leaders to establish a commission to examine AI more fully and how it is being used to exploit children through child sexual abuse material and to propose legislation to protect children from those abuses.

Attorney General Ashley Moody said, "The rapid onset of artificial intelligence is raising concerns about how child predators may use the high-tech tool to prey on minors. We need a full congressional investigation into the capabilities of AI and what we can do to reduce the ability of predators to exploit this tool to harm children."

Attorney General Moody and the coalition are concerned with the dangers of AI as it relates to CSAM in three main categories: a real child's likeness who has not been physically abused being digitally altered in a depiction of abuse, a real child who has been physically abused being digitally recreated in other depictions of abuse, and a child who does not even exist being digitally created in a depiction of

abuse that feeds the market for CSAM.

In a letter to congressional leaders, the coalition states, "AI is also being used to generate child sexual abuse material (CSAM). For example, AI tools can rapidly and easily create 'deepfakes' by studying real photographs of abused children to generate new images showing those children in sexual positions. This involves overlaying the face of one person on the body of another. Deepfakes can also be generated by overlaying photographs of otherwise unvictimized children on the internet with photographs of abused children to create new CSAM involving the previously unharmed children."

Attorney General Moody and the coalition ask Congress to form a commission to study specifically how AI can be used to exploit children and to "act to deter and address child exploitation, such as by expanding existing restrictions on CSAM to explicitly cover AI-generated CSAM."

The letter continues, "We are engaged in a race against time to protect the children of our country from the dangers of AI. Indeed, the proverbial walls of the city have already been breached. Now is the time to act."

Attorney General Moody Encourages Floridians To Remain Vigilant During National Preparedness Month

TALLAHASSEE, Fla.—This National Preparedness Month, Attorney General Ashley Moody is urging Floridians to remain vigilant. National Preparedness Month raises awareness about the importance of preparing for disasters and emergencies that could happen at any time.

September also marks the peak of hurricane season. Currently, there are multiple tropical systems in the Atlantic Ocean, including Hurricane Lee. Florida just endured the effects of Hurricane Idalia late last month and recovery efforts will be ongoing for the foreseeable future. To help Floridians solidify storm-readiness plans, Attorney General Moody is highlighting the 2023 Hurricane Preparedness Guide.

Attorney General Ashley Moody said, "In emergency situations, proper preparations can make all the difference. As we recognize National Preparedness Month, move through the peak of hurricane season, and see heavy storm activity in the Atlantic, I encourage all Floridians to take another look at our 2023 Hurricane Preparedness Guide to solidify storm preparations."

The Atlantic Hurricane season peaks between mid-August and mid-October. Hurricane Lee and Hurricane Margot are both strong storms currently moving through the Atlantic Ocean, and thankfully not forecasted to reach Florida. However, Floridians should still be prepared. On Aug. 30, Hurricane Idalia hit Florida's Big Bend region, and residents are still recovering from the storm that caused billions of dollars in damage.

Preparedness tips provided in the guide include:

- Know evacuation routes and shelter locations;
- Stock up on enough food, water and emergency supplies for the entire household for at least seven days or more;
- Check that storm-related products are hurricane-proof or impact-proof before purchasing;
- Research recovery charities before donating;

- Beware of unsolicited contractors and extremely low or high prices for quotes; and
- Report price gouging during a state of emergency, including online or on the free No Scam app.

Floridians can stay informed about serious storm events using the Florida Division of Emergency Management's website, [FloridaDisaster.org](https://www.floridadisaster.org).
